- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subsection (a), Section 521.001, Transportation
- 6 Code, is amended by adding Subdivision (7-a) to read as follows:
- 7 (7-a) "Race or ethnicity" means of a particular
- 8 <u>descent, including Caucasian, African, Hispanic, Asian, or Native</u>
- 9 American descent.
- SECTION 2. Section 521.101, Transportation Code, is amended
- 11 by adding Subsection (j) to read as follows:
- 12 (j) A personal identification certificate must include the
- 13 race or ethnicity of the holder. A holder must be informed of the
- 14 right to elect not to have the holder's race or ethnicity stated on
- 15 the holder's personal identification certificate.
- SECTION 3. Subsection (a), Section 521.121, Transportation
- 17 Code, is amended to read as follows:
- 18 (a) The driver's license must include:
- 19 (1) a distinguishing number assigned by the department
- 20 to the license holder;
- 21 (2) a color photograph of the entire face of the
- 22 holder;
- 23 (3) the full name, date of birth, and residence
- 24 address of the holder; [and]

- 1 (4) a brief description of the holder; and
- 2 (5) the race or ethnicity of the holder. A holder must
- 3 be informed of the right to elect not to have the holder's race or
- 4 ethnicity stated on the holder's driver's license.
- 5 SECTION 4. Subsection (c), Section 521.142, Transportation
- 6 Code, is amended to read as follows:
- 7 (c) The application must state:
- 8 (1) the sex of the applicant;
- 9 (2) the residence address of the applicant;
- 10 (3) whether the applicant has been licensed to drive a
- 11 motor vehicle before;
- 12 (4) if previously licensed, when and by what state or
- 13 country;
- 14 (5) whether that license has been suspended or revoked
- or a license application denied;
- 16 (6) the date and reason for the suspension,
- 17 revocation, or denial;
- 18 (7) whether the applicant is a citizen of the United
- 19 States; [and]
- 20 (8) the county of residence of the applicant; and
- 21 (9) the race or ethnicity of the applicant. The
- 22 applicant must be informed of the right to elect not to have the
- 23 applicant's race or ethnicity stated on the application.
- SECTION 5. This Act applies only to a driver's license or
- 25 personal identification certificate for which an original or
- 26 renewal application is submitted on or after the effective date of
- 27 this Act.
