2	relating to the creation of a program to educate the public on the
3	value of health coverage and to increase public awareness of health

5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle B, Title 5, Insurance Code, as
7	effective April 1, 2005, is amended by adding Chapter 524 to read as
8	follows:
9	CHAPTER 524. HEALTH COVERAGE AWARENESS AND EDUCATION PROGRAM
10	Sec. 524.001. PROGRAM ESTABLISHED. (a) The department
11	shall develop and implement a health coverage public awareness and
12	education program that complies with this chapter. The program
13	must:
14	(1) increase public awareness of health coverage
15	options available in this state;
16	(2) educate the public on the value of health
17	coverage; and

- 18 (3) provide information on health coverage options,
- including health savings accounts and compatible high deductible 19
- health benefit plans. 20
- (b) The program may not endorse or direct the public to a 21
- specific issuer of health coverage but may include information on 22
- 23 all health coverage issuers authorized to offer health coverage in
- 24 this state.

1	Sec. 524.002. PUBLIC SERVICE ANNOUNCEMENTS. The department
2	shall develop and make public service announcements to educate
3	consumers and employers about the availability of health coverage
4	in this state.
5	Sec. 524.003. INTERNET WEBSITE; PUBLIC EDUCATION. (a) The
6	department shall develop an Internet website designed to educate
7	the public about the availability of health coverage in this state,
8	including information about health savings accounts and compatible
9	high deductible health benefit plans.
10	(b) The department shall provide other appropriate
11	education to the public regarding the value of health coverage.
12	Sec. 524.004. TASK FORCE. (a) The commissioner shall
13	appoint a task force to make recommendations regarding the health
14	coverage public awareness and education program. The task force is
15	<pre>composed of:</pre>
16	(1) one representative from each of the following
17	groups or entities:
18	(A) health benefit coverage consumers;
19	(B) small employers;
20	(C) employers generally;
21	(D) insurance agents;
22	(E) the office of public insurance counsel;
23	(F) the Texas Health Insurance Risk Pool;
24	(G) physicians; and
25	(H) hospital trade associations;
26	(2) a representative of the Health and Human Services
27	Commission responsible for programs under Medicaid and the

- children's health insurance program; and
- 2 (3) one or more representatives of health benefit plan
- 3 issuers.
- 4 (b) The department shall consult the task force regarding
- 5 the content for the public service announcements, Internet website,
- 6 and educational materials required by this chapter. The
- 7 commissioner has authority to make final decisions as to what the
- 8 program's materials will contain.
- 9 Sec. 524.005. FUNDING. In addition to general
- appropriations, the department may accept gifts and grants from any
- 11 party, including a health benefit plan issuer or a foundation
- 12 associated with health benefit plan issuers to assist with funding
- 13 the program.
- 14 SECTION 2. This Act takes effect immediately if it receives
- 15 a vote of two-thirds of all the members elected to each house, as
- 16 provided by Section 39, Article III, Texas Constitution. If this
- 17 Act does not receive the vote necessary for immediate effect, this
- 18 Act takes effect September 1, 2005.
