Subchapter E, Chapter 54, Education Code, is amended by adding Section 54.5201 to read as follows: 1-13 1-14 1**-**15 1**-**16 SEC. 54.5201. RECREATIONAL SPORTS FEE; STEPHEN F. AUSTIN STATE UNIVERSITY. (a) The board of regents of Stephen F. Austin 1-17 State University may charge each student enrolled at the university 1-18 a recreational sports fee not to exceed \$120 per semester or summer session of longer than six weeks or \$60 per summer session of six 1-19 1-20 1-21 weeks or less. The fee may be used to purchase equipment for and to construct, operate, and maintain recreational sports facilities 1-22 and programs. (b) The recreational sports fee authorized by this section may not be increased more than 10 percent from one academic year to 1-23 1-24 the next unless the increase has been approved by a majority vote of those students participating in a general student election called 1-25 1-26 for that purpose. This Act takes effect immediately if it receives 1-39 a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution.
