AN ACT

relating to the prohibition of signs on Farm-to-Market Road 3238.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subsection (a), Section 391.252, Transportation Code, is amended to read as follows:

(a) A [~~Subsequent to the effective date of this subchapter,~~
a] person may not erect an off-premise sign that is adjacent to and visible from the following highways:

(1) on or after September 1, 2001:

(A) [~~(1)~~] U.S. Highway 290 between the western city limits of the city of Austin and the eastern city limits of the city of Fredericksburg;

(B) [~~(2)~~] State Highway 317 between the northern city limits of the city of Belton to the southern city limits of the city of Valley Mills;

(C) [~~(3)~~] State Highway 16 between the northern city limits of the city of Kerrville and Interstate Highway 20;

(D) [~~(4)~~] U.S. Highway 77 between State Highway 186 and State Highway 44;

(E) [~~(5)~~] U.S. Highway 281 between State Highway 186 and Interstate Highway 37;

(F) [~~(6)~~] State Highway 17 between State Highway 118 and U.S. Highway 90;

(G) [~~(7)~~] State Highway 67 between U.S. Highway

1 90 and Farm-to-Market Road 170;

2 (H) [~~(8)~~] Farm-to-Market Road 170 between State
3 Highway 67 and State Highway 118;

4 (I) [~~(9)~~] State Highway 118 between
5 Farm-to-Market Road 170 and State Highway 17;

6 (J) [~~(10)~~] State Highway 105 between the western
7 city limits of the city of Sour Lake to the eastern city limits of
8 the city of Cleveland;

9 (K) [~~(11)~~] State Highway 73 between the eastern
10 city limits of the city of Winnie to the western city limits of the
11 city of Port Arthur;

12 (L) [~~(12)~~] State Highway 21 between the southern
13 city limits of the city of College Station and U.S. Highway 290; or

14 (M) [~~(13)~~] a highway located in:

15 (i) [~~(A)~~] the Sabine National Forest;

16 (ii) [~~(B)~~] the Davy Crockett National
17 Forest; or

18 (iii) [~~(C)~~] the Sam Houston National
19 Forest; and

20 (2) on or after September 1, 2005, Farm-to-Market Road
21 3238 between State Highway 71 and Hammetts Crossing Road.

22 SECTION 2. This Act takes effect September 1, 2005.
