1-7 AN ACT

1-8 relating to the prohibition of signs on Farm-to-Market Road 3238.

1-9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-10 SECTION 1. Subsection (a), Section 391.252, Transportation
1-11 Code, is amended to read as follows:

1-12 (a) A [~~Subsequent to the effective date of this subchapter,~~
1-13 ~~a]~~ person may not erect an off-premise sign that is adjacent to and
1-14 visible from the following highways:

1-15 (1) on or after September 1, 2001:

1-16 (A) [(1)] U.S. Highway 290 between the western
1-17 city limits of the city of Austin and the eastern city limits of the
1-18 city of Fredericksburg;

1-19 (B) [(2)] State Highway 317 between the northern
1-20 city limits of the city of Belton to the southern city limits of the
1-21 city of Valley Mills;

1-22 (C) [(3)] State Highway 16 between the northern
1-23 city limits of the city of Kerrville and Interstate Highway 20;

1-24 (D) [(4)] U.S. Highway 77 between State Highway
1-25 186 and State Highway 44;

1-26 (E) [(5)] U.S. Highway 281 between State Highway
1-27 186 and Interstate Highway 37;

1-28 (F) [(6)] State Highway 17 between State Highway
1-29 118 and U.S. Highway 90;

1-30 (G) [(7)] State Highway 67 between U.S. Highway
1-31 90 and Farm-to-Market Road 170;

1-32 (H) [(8)] Farm-to-Market Road 170 between State
1-33 Highway 67 and State Highway 118;

1-34 (I) [(9)] State Highway 118 between
1-35 Farm-to-Market Road 170 and State Highway 17;

1-36 (J) [(10)] State Highway 105 between the western
1-37 city limits of the city of Sour Lake to the eastern city limits of
1-38 the city of Cleveland;

1-39 (K) [(11)] State Highway 73 between the eastern
1-40 city limits of the city of Winnie to the western city limits of the
1-41 city of Port Arthur;

1-42 (L) [(12)] State Highway 21 between the southern
1-43 city limits of the city of College Station and U.S. Highway 290; or

1-44 (M) [(13)] a highway located in:

1-45 (i) [(A)] the Sabine National Forest;

1-46 (ii) [(B)] the Davy Crockett National
1-47 Forest; or

1-48 (iii) [(C)] the Sam Houston National
1-49 Forest; and

1-50 (2) on or after September 1, 2005, Farm-to-Market Road
1-51 3238 between State Highway 71 and Hammetts Crossing Road.

1-52 SECTION 2. This Act takes effect September 1, 2005.
