Section 11.163, Education Code, is amended by amending Subsection (c) and adding Subsections (d) and (e) to read 1-13 1-14 1-15 as follows: The employment policy may: (c) 1-16 (1) specify the terms of employment with the district; 1-17 [<del>or</del>] (2) delegate to the superintendent the authority to 1-18 1-19 1-20 determine the terms of employment with the district; or (3) include a provision for providing each 1-21 district employee with an opportunity to participate in a process 1-22 for transferring to another school in or position with the 1-23 district.  $\overline{(d)}$  The employment policy must provide that not later than 10th school day before the date on which a district fills a 1-24 1-25 vacant position for which a certificate or license is required as 1-26 provided by Section 21.003, other than a position that affects the 1-27 safety and security of students as determined by the board of trustees, the district must provide to each current district 1-28 trustees, 1-29 1-30 employee: 1-31 (1)notice of the position by posting the position on: 1-32 (A) a bulletin board at: 1-33 (i) a place convenient to the public in the district's central administrative office; and (ii) the central administrative office of 1-34 1-35 each campus in the district during any time the office is open; and 1-36 1-37 (B) the district's Internet website, if the 1-38 district has a website; and a reasonable opportunity to apply for the 1-39 (2) 1-40 position. 1-41 (e) If, during the school year, the district must fill vacant position held by a teacher, as defined by Section 21.201, in 1-42 1-43 less than 10 school days, the district: (1) must provide notice of the position in the manner by Subsection (d)(1) as soon as possible after the 1-44 1-45 <u>descri</u>bed vacancy occurs; 1-46 is not required to provide the notice for 10 school 1-47 (2) days before filling the position; and
