MEMBERSHIP AND EMPLOYEE RESTRICTIONS. 12 In this section, "Texas trade association" means a [nonprofit,] 13 14 cooperative  $[\tau]$  and voluntarily joined statewide association of 15 business or professional competitors in this state designed to assist its members and its industry or profession in dealing with 16 17 mutual business or professional problems and in promoting their common interest. 18 19 A person may not be a member of the board and may not be an employee of the board employed in a "bona fide executive,
- an employee of the board employed in a "bona fide executive,
  administrative, or professional capacity," as that phrase is used
  for purposes of establishing an exemption to the overtime
  provisions of the federal Fair Labor Standards Act of 1938 (29)
  U.S.C. Section 201 et seq.), if:
- 25 <u>(1) the person is an officer, employee, or paid</u> 26 <u>consultant of a Texas trade association in the field of health care;</u>
- 27 or

(2) the person's spouse is an officer, manager, or paid consultant of a Texas trade association in the field of veterinary medicine. [An officer, employee, or paid consultant of a Texas trade association in the field of health care may not be a member or employee of the board who is exempt from the state's position classification plan or is compensated at or above the amount prescribed by the General Appropriations Act for step 1, salary group A17, of the position classification salary schedule.]

- (c) [A person who is the spouse of an officer, manager, or paid consultant of a Texas trade association in the field of health care may not be a member of the board and may not be an employee of the board who is exempt from the state's position classification plan or is compensated at or above the amount prescribed by the Ceneral Appropriations Act for step 1, salary group A17, of the position classification salary schedule.
- [(d)] A person may not be [serve as] a member of the board or act as the general counsel to the board if the person is required to register as a lobbyist under Chapter 305, Government Code, because of the person's activities for compensation on behalf of a profession related to the operation of the board.
- 21 SECTION 4. Section 801.055, Occupations Code, is amended to 22 read as follows:
- Sec. 801.055. OFFICERS. (a) The governor shall designate a member of the board as the presiding officer of the board to serve in that capacity at the pleasure of the governor.

- (e) At an informal proceeding under this section, and on agreement with the license holder, the board may order the license holder to refund an amount not to exceed the amount a client paid to the license holder instead of or in addition to imposing an administrative penalty under this chapter. The board may not require payment of other damages or estimate harm under this subsection.
- 23 (f) Before an informal disposition is effective, the board 24 must review and approve at a public meeting an informal disposition 25 of the complaint recommended by board members or board staff.
- SECTION 22. Sections 801.452(a) and (c), Occupations Code, are amended to read as follows:
