 - [(d)] A person may not <u>be</u> [serve as] a member of the board or <u>act</u> [serve] as general counsel to the board <u>or the department</u> if the person is required to register as a lobbyist under Chapter 305,

- Sec. 505.458. REFUND. (a) Subject to Subsection (b), the
- 15 board may order a license holder to pay a refund to a consumer as
- 16 provided in an agreement resulting from an informal settlement
- 17 conference instead of or in addition to imposing an administrative
- 18 penalty under this chapter.
- 19 (b) The amount of a refund ordered as provided in an
- 20 agreement resulting from an informal settlement conference may not

- 14 member serving on the board immediately before September 1, 2005,
- 15 to continue to serve and function as a member of the board for the
- 16 remainder of the member's term. The changes in law made by that

- 19 (b) The changes in law made by this Act governing the
- 20 eligibility of a person for a license under Chapter 505,

Conduct that occurs before the effective date of this Act is 6 7 governed by the law in effect on the date the conduct occurred, and the former law is continued in effect for that purpose. 8
- 9 (d) The change in law made by Subsection (a), Section 10 505.353, Occupations Code, as amended by this Act, and Section 11 505.3545, Occupations Code, as added by this Act, regarding the 12 jurisprudence examination, applies only to an application for a 13 license filed with the Texas State Board of Social Worker Examiners 14 under Chapter 505, Occupations Code, as amended by this Act, on or 15 after September 1, 2006.
- SECTION 33. (a) Not later than September 1, 2007, the
 Texas State Board of Social Worker Examiners by rule shall adjust
 the fees for renewal of an expired license under Chapter 505,
 Occupations Code, in accordance with Subsection (c), Section
 505.203, Occupations Code, as added by this Act.
- Notwithstanding Subsection (c), Section 21 (b) 505.203, 22 Occupations Code, as added by this Act, and Subsection (c), Section 505.402, Occupations Code, as amended by this Act, the fees for an 23 applicant who applies for the renewal of an expired license under 24 25 Chapter 505, Occupations Code, before the effective date of the adjustment required by Subsection (a) of this section are governed 26 by the law in effect immediately before the effective date of this 27
