5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subsection (c), Section 223.0041,
7	Transportation Code, is amended to read as follows:
8	(c) For a maintenance contract involving an amount less than
9	<u>\$300,000</u> [\$100,000], if the lowest bidder withdraws its bid prior
10	to contract award or fails to execute the contract, the director may
11	recommend to the commission that the contract be awarded to the
12	second lowest bidder. The commission may award the maintenance
13	contract to the second lowest bidder if the second lowest bidder
14	agrees to accept the unit bid prices of the lowest bidder. The
15	commission shall adopt rules governing the conditions under which
16	the department will allow the withdrawal of the bid of the lowest
17	bidder and consider awarding a maintenance contract to the second
18	lowest bidder.
19	SECTION 2. Section 222.053, Transportation Code, is amended
20	by adding Subsections (f), (g), and (h) to read as follows:
21	(f) The commission shall certify a county as an economically
22	disadvantaged county on an annual basis as soon as possible after
23	the comptroller reports on the economic indicators listed under
24	Subsection (a). A county certified under this section is eligible

1 for an adjustment under Subsection (c)(2).

2 (g) The commission shall determine whether to make an 3 adjustment under Subsection (c)(2) at the time a political 4 subdivision that consists of all or a portion of an economically 5 disadvantaged county submits a proposal to construct, maintain, or 6 extend a highway or for another type of highway project.

7 (h) The commission may delegate any of its duties or powers
8 under this section to the director or the director's designee.

9 SECTION 3. (a) The changes in law made by this Act to the 10 Texas Department of Transportation's contract procedures apply 11 only to a highway project for which the department first solicits 12 bids on or after September 1, 2005.

(b) A highway project for which the Texas Department of Transportation first solicited bids before September 1, 2005, is governed by the law as it existed immediately before the effective date of this Act, and that law is continued in effect for that purpose.

SECTION 4. This Act takes effect September 1, 2005.
