4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 33, Natural Resources Code, is amended
6	by adding Subchapter I to read as follows:
7	SUBCHAPTER I. GULF COAST LEGISLATIVE WORKING GROUP
8	Sec. 33.651. LEGISLATIVE FINDING. The legislature finds
9	that it would be in the best interests of this state for appropriate
10	members of the legislature and the land commissioner together with
11	their counterparts in other states bordering the Gulf of Mexico to
12	form a Multistate Gulf Coast Legislative Working Group to work
13	together and with members of congress from the Gulf Coast states or
14	issues of common concern to the Gulf Coast.
15	Sec. 33.652. TEXAS GULF COAST LEGISLATIVE WORKING GROUP.
16	(a) The Texas Gulf Coast Legislative Working Group is composed of:
17	(1) the land commissioner;
18	(2) the chair of each standing or select committee or
19	subcommittee of the senate with jurisdiction over coastal issues,
20	as determined by the lieutenant governor; and
21	(3) the chair of each standing or select committee or
22	subcommittee of the house of representatives with jurisdiction over
23	coastal issues, as determined by the speaker of the house of
24	representatives.

- 1 (b) The members of the Texas working group shall annually
 2 elect a presiding officer and assistant presiding officer for the
 3 working group from among the members.
- 4 <u>(c) The Texas working group shall meet as provided by rule</u> 5 of the Texas working group.
- 6 (d) Members of the Texas working group may use their staff
 7 to support working group activities and may travel on working group
 8 business in accordance with the rules and procedures that apply to
 9 the members' travel on official business.
- Sec. 33.653. TEXAS WORKING GROUP ACTIVITIES; MULTISTATE

 GULF COAST LEGISLATIVE WORKING GROUP. (a) The Texas working group

 shall:
- 13 (1) identify coastal issues of common concern to Texas

 14 and one or more other Gulf Coast states;
- 15 (2) approach the group members' counterparts in other
 16 Gulf Coast states to work together on issues of common concern;
- 17 (3) in coordination with the group members'

 18 counterparts in other Gulf Coast states, communicate with

 19 appropriate members of congress on coastal issues of common

 20 concern; and
- 21 (4) propose to the group members' counterparts in 22 other Gulf Coast states that they join together with the Texas 23 working group to form a permanent Multistate Gulf Coast Legislative 24 Working Group to work together and with members of congress from the 25 Gulf Coast states on issues of common concern to the Gulf Coast.
- 26 (b) The Texas working group and the appropriate entity in 27 each Gulf Coast state that accepts the proposal described in

- 2 Working Group.
- 3 (c) Once formed, the Multistate Gulf Coast Legislative
- 4 Working Group may adopt whatever name the group determines to be
- 5 most suitable.
- 6 Sec. 33.654. BIENNIAL REPORT. The Texas Gulf Coast
- 7 Legislative Working Group shall report on its activities to the
- 8 lieutenant governor and the speaker of the house of representatives
- 9 not later than November 1 of each even-numbered year.
- 10 SECTION 2. This Act takes effect September 1, 2005.
