5	SECTION 1. Subchapter B, Chapter 32, Human Resources Code,

7	Sec. 32.058. LIMITATION ON MEDICAL ASSISTANCE IN CERTAIN
8	ALTERNATIVE COMMUNITY-BASED CARE SETTINGS. (a) In this section:
9	(1) "Institution" means a nursing facility or an
10	ICF-MR facility.
11	(2) "Medical assistance waiver program" means:
12	(A) the community-based alternatives program;
13	(B) the community living assistance and support
14	services program;
15	(C) the deaf-blind/multiple disabilities
16	program;
17	(D) the consolidated waiver pilot program; or
18	(E) the medically dependent children program.
19	(b) Except as provided by Subsection (c) or (d), the
20	department may not provide services under a medical assistance
21	waiver program to a person receiving medical assistance if the cost
22	of providing those services exceeds the individual cost limit
23	specified in the medical assistance waiver program.
24	(c) The department shall continue to provide services under

a medical assistance waiver program to a person who is receiving 1 those services on September 1, 2005, at a cost that exceeds the 2 3 individual cost limit specified in the medical assistance waiver, 4 if continuation of those services: 5 (1) is necessary for the person to live in the most integrated setting appropriate to the needs of the person; and 6 7 (2) does not affect the department's compliance with the federal cost-effectiveness and efficiency requirements of the 8 9 medical assistance waiver program under 42 U.S.C. Sections 1396n(b) and 1396n(c)(2)(D). 10 11 (d) The department may continue to provide services under a medical assistance waiver program to a person who is ineligible to 12 13 receive those services under Subsection (b) and to whom Subsection (c) does not apply if: 14 15 (1) the cost of providing those services to the person 16 under the medical assistance waiver program does not exceed 133.3 percent of the individual cost limit specified in the medical 17 18 assistance waiver program; and (2) continuation of those services does not affect the 19 20 department's compliance with the federal cost-effectiveness and efficiency requirements of the medical assistance waiver program 21 22 under 42 U.S.C. Sections 1396n(b) and 1396n(c)(2)(D). (e) The executive commissioner of the Health and Human 23 Services Commission may a<u>dopt rules under which the department may</u> 24 25 exempt a person from the cost limit established under Subsection (d)(1). 26 27 SECTION 2. This Act applies to a person receiving medical
