- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 2052.002, Occupations Code, is amended
- 5 to read as follows:
- 6 Sec. 2052.002. DEFINITIONS. In this chapter:
- 7 (1) "Amateur" means a person who has never received or
- 8 competed for any purse or other thing of value, including
- 9 reimbursement for expenses related to training or to participation
- 10 in a combative sports event, that exceeded the maximum amount
- 11 established by an amateur combative sports association.
- 12 (2) "Amateur combative sports association" means an
- organization that has nonprofit status under the laws of this state
- 14 or under federal law and that produces, arranges, advertises,
- 15 conducts, or stages combative sports events in which all the
- 16 <u>contestants are amateurs.</u>
- 17 (3) "Boxing" means to compete with the fists.
- 18 (4) "Combative sports" means sports, including
- 19 boxing, kickboxing, martial arts, and mixed martial arts, in which
- 20 participants voluntarily engage in full contact to score points, to
- 21 cause an opponent to submit, or to disable an opponent in a contest,
- 22 match, or exhibition. The term does not include student training or
- 23 exhibitions of students' skills conducted by martial arts schools,
- 24 or associations of schools, where the students' participation is

- 1 for health and recreational purposes rather than competition and
- 2 where the intent is to use only partial contact [includes
- 3 kickboxing, in which a person delivers blows with any part of the
- 4 arm below the shoulder, including the hand, and any part of the leg
- 5 below the hip, including the foot.
- [(2) "Boxing promoter" means a person who arranges,
- 7 advertises, or conducts a boxing event.
- 8 [(3) "Championship tournament" means a state,
- 9 regional, national, or international elimination tournament in
- 10 which the winners of elimination tournaments compete for a
- 11 championship in each weight category].
- 12 (5) [(4)] "Commission" means the Texas Commission of
- 13 Licensing and Regulation.
- 14 (6) "Contest" means a combative sports engagement in
- which the participants strive earnestly to win.
- 16 (7) [(5)] "Department" means the Texas Department of
- 17 Licensing and Regulation.
- 18 (8) [(6)] "Elimination tournament" means a combative
- 19 sports [boxing] contest in which [elimination tournament]
- 20 contestants compete in a series of matches until not more than one
- 21 contestant remains in any weight category. The term does not
- include <u>an</u> [a boxing] event described by Section 2052.110.
- 23 (9) [(7) "Elimination tournament boxing promoter"
- 24 means a person who arranges, advertises, or conducts an elimination
- 25 tournament.
- 26 [(8) "Elimination tournament contestant" means a
- 27 person who competes in an elimination tournament.

- 2 director of the department or the executive director's designated
- 3 representative.
- 4 (10) [(9)] "Exhibition" means a combative sports
- 5 [boxing or wrestling] skills demonstration.
- 6 (11) $\left[\frac{(10)}{(10)}\right]$ "Event" means a contest, match, or
- 7 exhibition.
- 8 (12) $[\frac{(11)}{1}]$ "Judge" means a person who is [+
- 9 [(A) located at ringside during a boxing match;
- 10 and
- 11 [(B)] responsible for scoring the performances
- of the participants in a [the] match.
- 13 "Kickboxing" means to compete by delivering blows
- with the fists, arms, feet, legs, or any combination thereof.
- 15 (14) "Martial arts" means any one of the individual
- disciplines described by rule adopted by the commission in which
- 17 the contestants engage in unarmed combat using the applicable
- 18 techniques to grapple with, kick, or strike an opponent to win a
- 19 contest by causing an opponent to submit or by scoring points
- against or disabling an opponent.
- 21 (15) "Match" means any contest or exhibition.
- 22 (16) "Mixed martial arts" means unarmed combat
- 23 <u>involving the use of a combination of techniques from different</u>
- 24 <u>disciplines of the martial arts including grappling, kicking, and</u>
- 25 striking and may include the use of full, unrestrained physical
- 26 force.
- 27 (17) [(12) "Local tournament" means an elimination

- 1 tournament in which only a resident of this state may compete.
- 2 [\(\frac{(13)}{}\)] "Professional combative sports contestant
- 3 [boxer]" means a person who competes in a combative sports [boxing]
- 4 event in this state conducted for a purse or compensation.
- 5 (18) [(13-a)] "Promoter" means any person who
- 6 produces, arranges, advertises, conducts, or stages a combative
- 7 sports event [a boxing promoter or wrestling promoter].
- 8 $\underline{(19)}$ [$\overline{(14)}$] "Referee" means a person who:
- 9 (A) is present in the ring during a <u>match</u> [boxing
- 10 event]; and
- 11 (B) exercises general supervision of the <u>match</u>
- 12 [event].
- 13 (20) [(15) "Regional tournament" means an elimination
- 14 tournament in which a contestant from outside of the immediate area
- 15 in which the tournament is conducted may compete against local
- 16 contestants.
- 17 [(15-a)] "Ringside physician" means an individual
- 18 licensed to practice medicine in this state who is registered with
- 19 the department.
- 20 [(16) "Wrestling promoter" means a person who
- 21 arranges, advertises, or conducts a wrestling event.
- 22 SECTION 2. Subsection (b), Section 2052.052, Occupations
- 23 Code, is amended to read as follows:
- 24 (b) The commission may adopt rules:
- 25 (1) governing boxing, [professional] kickboxing,
- 26 martial arts, or mixed martial arts contests and exhibitions;
- 27 (2) establishing reasonable qualifications for an

- 1 applicant seeking a license or registration from the department
- 2 under this chapter;
- 3 (3) recognizing a sanction, medical suspension, or
- 4 disqualification of a licensee or registrant [license holder] by a
- 5 combative sports authority in any state, provided that if licensure
- 6 or registration is denied based on those actions, an applicant has
- 7 <u>an opportunity for [a right to]</u> a hearing as prescribed by rule;
- 8 (4) establishing practice requirements or specialty
- 9 certifications that a person licensed to practice medicine in this
- 10 state must meet to register as a ringside physician;
- 11 (5) requiring a contestant to present $\underline{\text{with an}}$
- 12 application for licensure or license renewal documentation [to the
- 13 executive director at the time of weigh-in an original copy of
- 14 recent blood test results that demonstrate whether the contestant
- 15 is free from hepatitis B virus, hepatitis C virus, human
- 16 immunodeficiency virus, and any other communicable disease
- 17 designated by commission rule and providing that a contestant's
- 18 failure to provide the required blood test results disqualifies the
- 19 contestant;
- 20 (6) providing that to participate in any event a
- 21 contestant must be free of hepatitis B virus, hepatitis C virus,
- 22 human immunodeficiency virus, and any other communicable disease
- 23 designated by rule;
- 24 (7) requiring that a contestant <u>present with an</u>
- 25 application for licensure or license renewal documentation of the
- 26 results of [undergo] a physical examination, including an
- 27 ophthalmologic [opthalmological] examination, [at or near the time

- 1 of weigh-in] and providing for disqualification of a contestant who
- 2 is determined by an examining physician to be unfit; [and]
- 3 (8) establishing additional responsibilities for
- 4 promoters; and
- 5 (9) governing regulated amateur events.
- 6 SECTION 3. Subsection (a), Section 2052.055, Occupations
- 7 Code, is amended to read as follows:
- 8 (a) The presiding officer of the commission, with the
- 9 commission's approval, may appoint a medical advisory committee to
- 10 advise the department concerning health issues for combative sports
- 11 [boxing] event contestants.
- 12 SECTION 4. Section 2052.101, Occupations Code, is amended

- 14 (b) The person shall attach to the report a cashier's check,
- 15 check, or money order payable to this state in the amount of the tax
- imposed on the event covered by the report.
- 17 SECTION 14. Section 2052.153, Occupations Code, is amended
- 18 to read as follows:
- 19 Sec. 2052.153. CLOSED CIRCUIT TELECAST. A person
- 20 exhibiting a simultaneous telecast of a live, spontaneous, or
- 21 current combative sports [boxing] event on a closed circuit
- 22 telecast that occurs in Texas in which a fee is charged for
- 23 admission to the exhibition:
- 24 (1) must:
- 25 (A) be a [boxing] promoter; and
- 26 (B) obtain a permit for each telecast exhibited;
- 27 and

- 3 SECTION 15. Section 2052.251, Occupations Code, is amended

- 7 contestant under Subchapter E, shall wear [eight-ounce boxing]
- 8 gloves of the type and weight specified by commission rule, unless
- 9 the commission by <u>applicable</u> rule requires or permits <u>contestants</u>
- 10 [a contestant] to not wear [heavier] gloves.
- 11 SECTION 16. Section 2052.252, Occupations Code, is amended
- 12 to read as follows:
- 13 Sec. 2052.252. REGULATED [CERTAIN] AMATEUR EVENTS.
- 14 (a) This section applies to an amateur combative sports [boxing]
- 15 event, other than an event described by Section 2052.110
- 16 [2052.110(2), (3), (4), or (5) or an elimination tournament subject
- 17 to Subchapter E], in which a fee is charged for admission to the
- 18 event.
- 19 (b) The amateur combative sports association sponsoring or
- 20 producing the event shall register with the department not later
- 21 than 30 days before the date the event begins.
- 22 <u>(c)</u> The event may take place only if the executive director
- 23 approves the event not later than seven days before the date the
- 24 event begins.
- 25 (d) [(c)] Each contestant [entry] in the event must have
- been a member of the amateur combative sports association for the
- 27 30-day period immediately preceding [be filed with the amateur

- 1 organization not later than the third day before] the date the event
- 2 begins and must be a member on the date of the event.
- 3 <u>(e) [(d)</u>] The amateur <u>combative</u> sports association
- 4 [organization] shall determine the amateur standing of the event
- 5 contestants and shall establish training programs consisting of at
- 6 least 30 days of training for each contestant.
- 7 $\underline{\text{(f)}}$ [\(\frac{(e)}{}\)] The event is subject to the supervision of the
- 8 executive director.
- 9 [(f) All profits from the event must be used to develop
- 10 <u>amateur athletics.</u>]
- 11 (g) [Only a referee or judge licensed under this chapter may
- 12 participate in the event.
- 13 $\left[\frac{h}{h}\right]$ Each contestant participating in the event must be
- 14 examined by a licensed physician within a reasonable time before
- 15 the event begins. A licensed physician must be present at ringside
- 16 during the entire event.
- 17 <u>(h)</u> [(i)] A professional <u>combative</u> sports contestant
- 18 [boxer] licensed under this chapter may not participate as a
- 19 <u>contestant</u> [<u>in any capacity</u>] in the event.
- SECTION 17. Subchapter F, Chapter 2052, Occupations Code,
- 21 is amended by adding Section 2052.254 to read as follows:
- 22 <u>Sec. 2052.254. ELIMINATION TOURNAMENTS. An elimination</u>
- tournament may not be conducted in this state.
- 24 SECTION 18. The following provisions of the Occupations
- 25 Code are repealed:
- 26 (1) Sections 2052.103, 2052.105, and 2052.106; and
- 27 (2) Subchapter E, Chapter 2052.
