5	SECTION 1. Article 2.23A, Texas Non-Profit Corporation Act
6	(Article 1396-2.23A, Vernon's Texas Civil Statutes), is amended by
7	amending Section B to read as follows:
8	B. Based on these records, the board of directors shall
9	annually prepare or approve a report of the financial activity of
10	the corporation for the preceding year. The report must:
11	(1) conform to accounting standards as promulgated by
12	the American Institute of Certified Public Accountants <u>;</u>
13	(2) [and must] include a statement of support,
14	revenue, and expenses and changes in fund balances, a statement of
15	functional expenses, and balance sheets for all funds; and
16	(3) be completed not later than the 180th day after the
17	close of each fiscal year.
18	SECTION 2. Section 22.352, Business Organizations Code, is
19	amended by adding Subsection (c) to read as follows:
20	(c) The financial report of a corporation must be completed
21	not later than the 180th day after the close of each fiscal year.
22	SECTION 3. (a) Except as provided by Subsection (b) of this
23	section:
24	(1) this Act takes effect immediately if it receives a

vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution; and (2) if this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2005. (b) Section 2 of this Act takes effect January 1, 2006.
