Being a 400.0 acre tract of land located in the Walker County School Land Survey, A-494, Montgomery County, Texas; said 400.0 acre tract being out of a 756.08 acre tract of land recorded in Clerk's File Number 2004-069636 of the Official Public Records of Real Property of Montgomery County, Texas; said 400.0 acre tract being more particularly described by metes and bounds as follows (all bearings are referenced to the east line of said call 756.08 acre tract):

Beginning at the northeast corner of said 756.08 acre tract, same being in the center of F.M. 2090 (100-foot wide right-of-way), the east line of said Walker County School Land Survey, A-494, and the west line of the William Barker Survey, A-82;

Thence, with the east line of said 756.08 acre tract, east line of said Walker County School Land Survey, A-494, and west line of said William Barker Survey, A-82, South 02 degrees 56 minutes 23 seconds East, a distance of 4,219.26 feet;

Thence, crossing said 756.08 acre tract, South 87 degrees 03 minutes 37 seconds West, a distance of 6,749.47 feet to the northwest line of said 756.08 acre tract and southeast line of a 835.884 acre tract of land recorded in Clerk's File Number 2004-000030 of the Official Public Records of Real Property of Montgomery County, Texas;
