Beginning at the southwest corner of said 1092.131 acre tract, same being on the northerly right-of-way line of State Highway 242 (right-of-way width varies) recorded in Clerk's File Number 9050364 of the Official Public Records of Real Property of Montgomery County, Texas, same being on the west line of said Walker County School Land Survey, A-494 and the east line of the Beasley Prewitt Survey, A-419;

- (c) The Texas Commission on Environmental Quality has filed its recommendations relating to this Act with the governor, the lieutenant governor, and the speaker of the house of representatives within the required time.
- (d) All requirements of the constitution and laws of this state and the rules and procedures of the legislature with respect to the notice, introduction, and passage of this Act are fulfilled and accomplished.

SECTION 4. This Act takes effect September 1, 2005.
