10	Sec. 3834.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the board of directors of the

13	(2) "District" means the Harris County Improvement

- The Harris County Improvement District No. 5 is a special district 16
- 17 created under Section 59, Article XVI, Texas Constitution.
- Sec. 3834.003. PURPOSE; DECLARATION OF INTENT. (a) The 18
- 19 creation of the district is essential to accomplish the purposes of
- Sections 52 and 52-a, Article III, and Section 59, Article XVI, 20
- Texas Constitution, and other public purposes stated in this 21
- chapter. By creating the district and in authorizing the City of 22
- 23 Houston, Harris County, and other political subdivisions to
- contract with the district, the legislature has established a 24

- 1 program to accomplish the public purposes set out in Section 52-a,
- 2 Article III, Texas Constitution.
- 3 (b) The creation of the district is necessary to promote,
- 4 develop, encourage, and maintain employment, commerce,
- 5 transportation, housing, tourism, recreation, the arts,
- 6 entertainment, economic development, safety, and the public
- 7 welfare in the district and adjacent areas.
- 8 (c) This chapter and the creation of the district may not be
- 9 interpreted to relieve Harris County or the City of Houston from
- 10 providing the level of services provided as of the effective date of
- 11 this Act, to the area in the district. The district is created to
- 12 supplement and not to supplant the county services provided in the
- 13 area in the district.
- 14 Sec. 3834.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE.
- 15 (a) The district is created to serve a public use and benefit.
- 16 (b) All land and other property included in the district
- 17 will benefit from the improvements and services to be provided by
- 18 the district under powers conferred by Sections 52 and 52-a,
- 19 Article III, and Section 59, Article XVI, Texas Constitution, and
- 20 other powers granted under this chapter.
- 21 (c) The creation of the district is in the public interest
- 22 and is essential to:
- (1) further the public purposes of developing and
- 24 diversifying the economy of the state;
- 25 (2) eliminate unemployment and underemployment; and
- 26 (3) develop or expand transportation and commerce.
- 27 (d) The district will:

1	(1) promote the health, safety, and general welfare of
2	residents, employers, potential employees, employees, visitors,
3	and consumers in the district, and of the public;
4	(2) provide needed funding for the district to
5	preserve, maintain, and enhance the economic health and vitality of
6	the district territory as a residential neighborhood and a
7	commercially viable area; and
8	(3) promote the health, safety, welfare, and enjoyment
9	of the public by providing pedestrian ways and by landscaping and
10	developing certain areas in the district, which are necessary for
11	the restoration, preservation, and enhancement of scenic beauty.
12	(e) Pedestrian ways along or across a street, whether at
13	grade or above or below the surface, and street lighting, street
14	landscaping, and street art objects are parts of and necessary
15	components of a street and are considered to be a street or road
16	<pre>improvement.</pre>
17	(f) The district will not act as the agent or
18	instrumentality of any private interest even though the district
19	will benefit many private interests as well as the public.
20	Sec. 3834.005. DISTRICT TERRITORY. The district is
21	composed of the territory described by Section 2 of the Act enacting
22	this chapter, as that territory may have been modified under:
23	(1) Subchapter J, Chapter 49, Water Code; or
24	(2) other law.
25	Sec. 3834.0055. DISANNEXATION OF DISTRICT 146 TERRITORY.
26	(a) The district does not include the area of state representative

District 146 as of the effective date of the Act enacting this

- 1 section. 2 (b) Disannexation of territory under this section does not affect the district's right to collect any assessments, impact 3 4 fees, or taxes imposed on property in the disannexed territory 5 before the disannexation. 6 (c) Disannexation of territory under this section does not 7 diminish or impair the rights of the holders of any outstanding and unpaid bonds, warrants, or other obligations of the district. 8 9 Property disannexed under this section is not released from its pro rata share of any district indebtedness at the time of the 10 disannexation and the district may continue to tax the property 11 12 until that debt is paid. Sec. 3834.006. APPLICABILITY OF MUNICIPAL MANAGEMENT 13 14 DISTRICTS LAW. Except as otherwise provided by this chapter, 15 Chapter 375, Local Government Code, applies to the district. 16 Sec. 3834.007. LIBERAL CONSTRUCTION OF CHAPTER. This chapter shall be liberally construed in conformity with the 17 findings and purposes stated in this chapter. 18 19 [Sections 3834.008-3834.050 reserved for expansion] SUBCHAPTER B. BOARD OF DIRECTORS 20 21 Sec. 3834.051. BOARD OF DIRECTORS; TERMS. (a) The district is governed by a board of 11 voting directors who serve 22 staggered terms of four years, with five or six directors' terms 23 24 expiring June 1 of each odd-numbered year.
 - (b) The board by resolution may change the number of voting directors on the board, but only if the board determines that the change is in the best interest of the district. The board may not

consist of fewer than 5 or more than 15 directors. 1 2 Sec. 3834.052. QUALIFICATIONS. (a) Three voting directors on the board must reside in a residential area adjacent to 3 4 the district and eight voting directors must represent commercial 5 property owners or tenants in the district. 6 (b) If the total number of voting directors of the board is 7 increased or reduced, the board must maintain the same percentage 8 of representation of residential and commercial areas on the board. Sec. 3834.053. APPOINTMENT OF DIRECTORS. The mayor and 9 members of the governing body of the City of Houston shall appoint 10 directors from persons recommended by the board. A person is 11 appointed if a majority of the members of the governing body, 12 including the mayor, vote to appoint that person. 13 Sec. 3834.054. NONVOTING DIRECTORS. (a) The following 14 15 persons serve as nonvoting directors: 16 (1) the directors of the following departments of the 17 City of Houston or a person designated by that director: (A) parks and recreation; 18 19 (B) planning and development; and 20 (C) public works; and 21 (2) the City of Houston's chief of police. If a department described by Subsection (a) is 22 consolidated, renamed, or changed, the board may appoint a director 23 24 of the consolidated, renamed, or changed department as a nonvoting director. If a department described by Subsection (a) is 25 26 abolished, the board may appoint a representative of another department that performs duties comparable to those performed by 27

- the abolished department.
- 2 Sec. 3834.055. QUORUM. (a) Section 375.071, Local
- 3 Government Code, does not apply to the district.
- 4 (b) A majority of the board is a quorum.
- 5 (c) Nonvoting directors and vacant director positions are
- 6 not counted for the purposes of establishing a board quorum.
- 7 Sec. 3834.056. CONFLICTS OF INTEREST; ONE-TIME AFFIDAVIT.
- 8 (a) Except as provided by this section:
- 9 (1) a director may participate in all board votes and
- 10 decisions; and
- 11 (2) Chapter 171, Local Government Code, governs
- 12 conflicts of interest for directors.
- 13 (b) Section 171.004, Local Government Code, does not apply
- 14 to the district. A director who has a substantial interest in a
- business or charitable entity that will receive a pecuniary benefit
- 16 from a board action shall file a one-time affidavit declaring the
- 17 interest. An additional affidavit is not required if the
- 18 director's interest changes. After the affidavit is filed with the
- 19 board secretary, the director may participate in a discussion or
- 20 vote on that action if:
- 21 <u>(1) a majority of the directors have a similar</u>
- 22 <u>interest in the same entity; or</u>
- 23 (2) all other similar business or charitable entities
- in the district will receive a similar pecuniary benefit.
- 25 (c) A director who is also an officer or employee of a public
- 26 entity may not participate in the discussion of or vote on a matter
- 27 regarding a contract with that public entity.

2 substantial interest in a charitable entity in the same manner that
3 a person would have a substantial interest in a business entity

- Sec. 3834.101. ADDITIONAL POWERS OF DISTRICT. The district

- 1 may exercise the powers given to:

- 5 (2) a housing finance corporation under Chapter 394,

- 4 ENFORCEMENT. To protect the public interest, the district may
- 5 contract with Harris County or the City of Houston for the county or
- 6 the city to provide law enforcement services in the district for a
- 7 <u>fee.</u>
- 8 Sec. 3834.105. APPROVAL BY CITY OF HOUSTON. (a) Except as
- 9 provided by Subsection (b), the district must obtain the approval
- of the City of Houston's governing body for:
- 11 (1) the issuance of a bond for each improvement
- 12 project;
- 13 (2) the plans and specifications of the improvement
- 14 project financed by the bond; and
- 15 (3) the plans and specifications of any district
- improvement project related to the use of land owned by the City of
- 17 Houston, an easement granted by the City of Houston, or a
- 18 right-of-way of a street, road, or highway.
- 19 (b) If the district obtains the approval of the City of
- 20 Houston's governing body of a capital improvements budget for a
- 21 period not to exceed five years, the district may finance the

- Sec. 3834.106. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. The
- 25 district may join and pay dues to an organization that:
- 26 (1) enjoys tax-exempt status under Section 501(c)(3),
- 27 (4), or (6), Internal Revenue Code of 1986; and

- 1 (2) performs a service or provides an activity
- 2 consistent with the furtherance of a district purpose.
- 3 Sec. 3834.107. REMOVAL OF DANGEROUS BUILDINGS. (a) The
- 4 district may cooperate with the City of Houston to have the City of
- 5 Houston demolish and remove dangerous buildings in or outside the
- 6 district as provided by this section.
- 7 (b) The district may cooperate with the City of Houston to
- 8 demolish and remove dangerous buildings outside the district if:
- 9 (1) the district makes a determination that demolition
- and removal would benefit the district; and
- 11 (2) the City of Houston agrees.
- 12 (c) The district may borrow money to finance the demolition
- 13 and removal of dangerous buildings under this section without
- 14 complying with Section 3834.152.
- 15 (d) The City of Houston may reimburse the district for all
- 16 costs financed by the district from:
- 17 (1) the proceeds of foreclosure on any demolition lien

The district may not 3 exercise the power of eminent domain. 4 [Sections 3834.110-3834.150 reserved for expansion] 5 SUBCHAPTER D. FINANCIAL PROVISIONS 6 Sec. 3834.151. DISBURSEMENTS AND TRANSFERS OF MONEY. The board by resolution shall establish the number of directors' 7 signatures and the procedure required for a disbursement or 8 9 transfer of the district's money. 10 Sec. 3834.152. PETITION REQUIRED FOR FINANCING SERVICES AND IMPROVEMENTS. (a) The board may not finance a service or 11 12 improvement project with assessments under this chapter unless a written petition requesting that service or improvement has been 13 14 filed with the board. 15 (b) A petition requesting a project financed by assessment 16 must be signed by: 17 (1) the owners of a majority of the assessed value of real property in the district subject to assessment according to 18 19 the most recent certified tax appraisal roll for Harris County; or (2) at least 50 owners of real property in the district 20 21 that will be subject to the assessment, if more than 50 persons own 22 real property subject to the assessment in the district according 23 to the most recent certified tax appraisal roll for Harris County.
