## A BILL TO BE ENTITLED AN ACT

relating to the period of time during which a person may be supervised in a pretrial intervention program and the fee that may be charged for the program.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subsection (a), Section 76.011, Government Code, is amended to read as follows:

The department may operate programs for the supervision (a) and rehabilitation of persons in pretrial intervention programs. Programs may include testing for controlled substances. A person in a pretrial intervention program may be supervised for a period not to exceed <u>two years</u> [<del>one year</del>].

SECTION 2. Article 102.012, Code of Criminal Procedure, is amended to read as follows:

Art. 102.012. FEES FOR PRETRIAL INTERVENTION PROGRAMS. A court that authorizes a defendant to participate [person] in a pretrial intervention program established under Section 76.011, Government Code, may order the defendant to pay to the court [be assessed] a supervision fee in an amount not more than \$60 per month as a condition of participating in the program.

(b) In addition to or in lieu of the supervision fee

authorized by Subsection (a), the court may order the defendant to pay or reimburse [that equals the actual cost to] a community supervision and corrections department for any other expense incurred as a result of the defendant's participation in the pretrial intervention program or that is necessary to the defendant's successful completion of the program [, not to exceed \$500, for supervision of the defendant by the department or programs provided to the defendant by the department as part of the pretrial intervention program].

SECTION 3. Section 103.021, Government Code, is amended to read as follows:

Sec. 103.021. ADDITIONAL FEES AND COSTS IN CRIMINAL OR CIVIL CASES. An accused or defendant, or a party to a civil suit, as applicable, shall pay the following fees and costs if ordered by the court or otherwise required:
