## A BILL TO BE ENTITLED

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subsection (f), Section 305.006, Government
- 6 Code, is amended to read as follows:
- 7 (f) An expenditure described by Subsection (b)(1), (2),
- 8 (3), or (6) may not be made or accepted unless the registrant is
- 9 present at the event. This subsection does not apply to a gift of
- 10 food or beverages required to be reported under Subsection (b)(4)
- in accordance with Section 305.0061(e-1).
- 12 SECTION 2. Section 305.0061, Government Code, is amended by
- 13 adding Subsection (e-1) to read as follows:
- 14 (e-1) If a registrant or a person on the registrant's behalf
- 15 and with the registrant's consent or ratification makes an
- 16 expenditure for food or beverages with a value of \$50 or less
- intended as a gift for a member of the legislative or executive
- 18 branch and delivered by first-class United States mail or by common
- or contract carrier outside the Capitol Complex, the expenditure is
- 20 considered to be a gift and should be reported under Section
- 21 305.006(b)(4).
- 22 SECTION 3. Subsection (a), Section 305.007, Government
- 23 Code, is amended to read as follows:
- 24 (a) The registrant must file the report required by Section

- 1 305.006 between the 1st and 10th day of each month. Subject to
- 2 <u>Section 305.0071, the [The]</u> report must cover the activities
- 3 occurring during the previous month.
- 4 SECTION 4. Subchapter A, Chapter 305, Government Code, is
- 5 amended by adding Section 305.0071 to read as follows:
- 6 Sec. 305.0071. INCLUSION OF EXPENDITURE IN REPORT.
- 7 (a) Except as provided by this section:
- 8 (1) an expenditure is not required to be included in a
- 9 report under Section 305.006 for a month before the month in which
- 10 the amount is readily determinable by the person making the
- 11 <u>expenditure; and</u>
- 12 (2) an expenditure is not required to be included in a
- 13 report under Section 305.0063 for a calendar year before the year in
- 14 which the amount is readily determinable by the person making the
- 15 expenditure.
- (b) An expenditure that is of a character for which, under
- normal business practice, the amount is not disclosed until receipt
- of a periodic bill must be included in the report for the reporting
- 19 period in which the bill is received.
- 20 (c) The amount of an expenditure made by credit card must be
- 21 included in the report for the reporting period in which:
- 22 <u>(1)</u> the expenditure is made; or
- 23 (2) the person receives the credit card statement that
- 24 <u>includes the expenditure.</u>
- 25 SECTION 5. Subsection (a), Section 305.024, Government
- 26 Code, is amended to read as follows:
- 27 (a) Except as provided by Section 305.025, a person

- 1 registered under Section 305.005 or a person on the registrant's
- 2 behalf and with the registrant's consent or ratification may not
- 3 offer, confer, or agree to confer to a member of the legislative or
- 4 executive branch:
- 5 (1) a loan, including the guarantee or endorsement of
- 6 a loan;
- 7 (2) a gift of cash or a negotiable instrument as
- 8 described by Section 3.104, Business & Commerce Code;
- 9 (3) an expenditure for transportation and lodging;
- 10 (4) an expenditure or series of expenditures for
- 11 entertainment that in the aggregate exceed \$500 in a calendar year;
- 12 (5) an expenditure or series of expenditures for gifts
- that in the aggregate exceed \$500 in a calendar year;
- 14 (6) an expenditure for an award or memento that
- 15 exceeds \$500; or
- 16 (7) an expenditure described by Section
- 17 305.006(b)(1),(2),(3), or (6) unless:
- 18 (A) the registrant is present at the event; or
- 19 (B) the expenditure is for a gift of food or
- 20 <u>beverages required to be reported under Section 305.006(b)(4) in</u>
- 21 accordance with Section 305.0061(e-1).
- SECTION 6. Sections 305.0061 and 305.007, Government Code,
- as amended by this Act, and Section 305.0071, Government Code, as
- 24 added by this Act, apply only to a report required to be filed under
- 25 Section 305.006 or 305.0063, Government Code on or after
- 26 September 1, 2005. A report required to be filed under Section
- 27 305.006 or 305.0063, Government Code, before September 1, 2005, is

- 1 governed by the law in effect at the time the report is required to
- 2 be filed, and the former law is continued in effect for that
- 3 purpose.
- 4 SECTION 7. This Act takes effect September 1, 2005.
