## A BILL TO BE ENTITLED

AN ACT

- 2 relating to the conveyance of a ferry by the Texas Department of
- 3 Transportation to certain counties and local government
- 4 corporations.

- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. The heading to Chapter 284, Transportation Code,
- 7 is amended to read as follows:
- 8 CHAPTER 284. CAUSEWAYS, BRIDGES, TUNNELS, TURNPIKES, FERRIES, AND
- 9 HIGHWAYS IN CERTAIN COUNTIES
- 10 SECTION 2. Subdivision (3), Section 284.001,
- 11 Transportation Code, is amended to read as follows:
- 12 (3) "Project" means a causeway, bridge, tunnel,
- 13 turnpike, highway, ferry, or any combination of those facilities,
- 14 including:
- 15 (A) a necessary overpass, underpass,
- 16 interchange, entrance plaza, toll house, service station,
- 17 approach, fixture, and accessory and necessary equipment;
- 18 (B) necessary administration, storage, and other
- 19 buildings; and
- 20 (C) all property rights, easements, and related
- 21 interests acquired.
- 22 SECTION 3. Section 284.003, Transportation Code, is amended
- 23 to read as follows:
- Sec. 284.003. PROJECT AUTHORIZED; CONSTRUCTION, OPERATION,

- 1 AND COST. A county, acting through the commissioners court of the
- 2 county, or a local government corporation, without state approval,
- 3 supervision, or regulation, may:
- 4 (1) construct, acquire, improve, operate, maintain,
- 5 or pool a project located:
- 6 (A) exclusively in the county;
- 7 (B) in the county and outside the county; or
- 8 (C) in one or more counties adjacent to the
- 9 county;
- 10 (2) issue tax bonds, revenue bonds, or combination tax
- and revenue bonds to pay the cost of the construction, acquisition,
- 12 or improvement of a project;
- 13 (3) impose tolls or charges as otherwise authorized by
- 14 this chapter; [or]
- 15 (4) construct a bridge over a deep water navigation
- 16 channel if the bridge does not hinder maritime transportation; or
- 17 <u>(5) construct, acquire, or operate a ferry across a</u>
- 18 deepwater navigation channel.
- 19 SECTION 4. Subchapter A, Chapter 284, Transportation Code,
- is amended by adding Section 284.011 to read as follows:
- Sec. 284.011. CONVEYANCE OF FERRY CONNECTING STATE
- 22 HIGHWAYS. (a) The commission by order may convey a ferry operated
- 23 under Section 342.001 to a county or local government corporation
- 24 <u>incorporated under Chapter 431 in a county to which this chapter</u>
- 25 applies if:
- 26 (1) the commission determines that the proposed
- 27 conveyance is an integral part of the region's overall plan to

2	(2) the county or local government corporation:
3	(A) agrees to the conveyance; and
4	(B) agrees to assume all liability and
5	responsibility for the maintenance and operation of the ferry on
6	its conveyance.
7	(b) A county or local government corporation shall
8	reimburse the commission for the cost of a conveyed ferry unless the
9	commission determines that the conveyance will result in a
10	substantial net benefit to the state, the department, and the
11	traveling public that equals or exceeds that cost.
12	(c) In computing the cost of the ferry, the commission
13	shall:
14	(1) include the total amount spent by the department
15	for the original construction of the ferry, including the costs
16	associated with the preliminary engineering and design engineering
17	for plans, specifications, and estimates, the acquisition of
18	necessary rights-of-way, and actual construction of the ferry and
19	all necessary appurtenant facilities; and
20	(2) consider the anticipated future costs of
21	expanding, improving, maintaining, or operating the ferry to be
22	incurred by the county or local government corporation and not by
23	the department if the ferry is conveyed.
24	(d) The commission shall, at the time the ferry is conveyed,
25	remove the ferry from the state highway system. After a conveyance,
26	the commission has no liability or responsibility for the
27	maintenance or operation of the ferry.

- 1 (e) Before conveying a ferry that is a part of the state
  2 highway system under this section, the commission shall conduct a
  3 public hearing at which interested persons shall be allowed to
  4 speak on the proposed conveyance. Notice of the hearing must be
  5 published in the Texas Register and in one or more newspapers of
  6 general circulation in the county in which the ferry is located.
- 7 (f) The commission shall adopt rules to implement this 8 section. The rules must include criteria and guidelines for the 9 approval of a conveyance of a ferry.
- 10 (g) A county or local government corporation shall

  11 establish criteria and guidelines for approval of the conveyance of

  12 a ferry under this section.

- (h) A county or local government corporation may temporarily charge a toll for use of a ferry conveyed under this section to pay the costs necessary for an expansion of the ferry and may permanently charge a toll for use of ferry facilities that are an expansion of the ferry conveyed under this section.
- (i) The commission may not convey a ferry under this section if any of the docking facilities used by the ferry are located in a municipality with a population of 8,000 or less unless the governing body of the municipality approves the conveyance.
- SECTION 5. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2005.
