4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 571.0771, Government Code, is amended by
6	adding Subsection (b-1) to read as follows:
7	(b-1) For purposes of Subsection (a)(1), a report does not
8	substantially comply with the applicable law if it contains an
9	error other than one of the following errors:
10	(1) an obvious typographical error;
11	(2) the omission of information required for the
12	commission's administrative purposes;
13	(3) one or more instances of an incorrectly reported
14	contribution or an unreported contribution, if the total of
15	incorrectly reported or unreported contributions does not exceed:
16	(A) 10 percent of the total contributions
17	reported on the corrected report; or
18	(B) \$10,000;
19	(4) one or more instances of an incorrectly reported
20	contribution or an unreported contribution, if the total of
21	incorrectly reported or unreported contributions does not exceed
22	\$2,000;
23	(5) one or more instances of an incorrectly reported

expenditure or an unreported expenditure, if the total of

- 1 <u>incorrectly reported or unreported expenditures does not exceed:</u>
- 2 (A) 10 percent of the total expenditures reported
- 3 <u>on the corrected report; or</u>
- 4 (B) \$10,000;
- 5 (6) one or more instances of an incorrectly reported
- 6 expenditure or an unreported expenditure, if the total of
- 7 <u>incorrectly reported or unreported expenditures does not exceed</u>
- 8 \$2,000;
- 9 (7) an error in the amount reported under Section
- 10 254.031(a)(8), Election Code, if the correct amount does not:
- 11 (A) vary by more than 10 percent from the amount
- 12 <u>originally reported; or</u>
- 13 (B) exceed \$10,000;
- 14 (8) an error in the amount reported under Section
- 254.031(a)(8), Election Code, if the error in the amount originally
- 16 reported does not exceed \$2,000; or
- 17 (9) a reporting error that the commission determines
- 18 <u>is, in context, minor.</u>
- 19 SECTION 2. Section 571.0771(b-1), Government Code, as added
- 20 by this Act, applies only to a report, registration, or statement
- 21 required to be filed with the Texas Ethics Commission that is due on
- or after September 1, 2005. A report, registration, or statement
- 23 required to be filed with the Texas Ethics Commission that is due
- 24 before September 1, 2005, is governed by the law in effect on the
- 25 date the report, registration, or statement is due, and the former
- law is continued in effect for that purpose.
- 27 SECTION 3. This Act takes effect September 1, 2005.
