- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5
- 6 SECTION 1. The heading to Chapter 95, Health and Safety
- 7 Code, as added by Chapter 1465, Acts of the 77th Legislature,
- Regular Session, 2001, is amended to read as follows: 8
- CHAPTER 95. RISK ASSESSMENT FOR TYPE 2 DIABETES 9
- [ACANTHOSIS NIGRICANS SCREENING] 10
- SECTION 2. Chapter 95, Health and Safety code, as added by 11
- 12 Chapter 1465, Acts of the 77th Legislature, Regular Session, 2001,
- 13 is amended by adding Section 95.0011 to read as follows:
- Sec. 95.0011. EXPIRATION. This chapter expires September 14
- 1, 2007. 15
- SECTION 3. Sections 95.002, 95.003, and 95.004, Health and 16
- Safety Code, as added by Chapter 1465, Acts of the 77th Legislature, 17
- Regular Session, 2001, are amended to read as follows: 18
- 19 Sec. 95.002. TYPE 2 DIABETES [ACANTHOSIS NIGRICANS]
- EDUCATION AND RISK ASSESSMENT PROGRAM [SCREENING PROJECT]. 20
- The office shall administer <u>a risk assessment program for Type</u> 21
- 22 2 diabetes [an acanthosis nigricans screening program]
- accordance with this chapter. 23
- (b) The executive council by rule shall coordinate the risk 24

- 1 assessment for Type 2 diabetes [screening] of individuals who
- 2 attend public or private schools located in Texas Education Agency
- 3 Regional Education Service Centers 1, 2, 3, 4, 10, 11, 13, 15, 18,
- 4 19, and 20 and in additional regional education service centers as
- 5 funding is available.
- 6 (c) The rules must include procedures necessary to
- 7 administer the risk assessment program, including procedures that
- 8 require each school to record and report risk assessment
- 9 [screening] activities using:
- 10 (1) the Centers for Disease Control and Prevention's
- 11 Epi Info or similar surveillance software selected by the office;
- 12 <u>or</u>
- 13 (2) an existing database used to administer and track
- 14 risk assessment data.
- 15 (d) The office shall require a risk assessment for Type 2
- 16 <u>diabetes</u> [acanthosis nigricans screening] to be performed at the
- same time hearing and vision screening is performed under Chapter
- 18 36 or spinal screening is performed under Chapter 37. The risk
- 19 assessment for Type 2 diabetes should:
- 20 (1) identify students with a body mass index above the
- 21 normal range; and
- 22 (2) further assess students identified under
- 23 Subdivision (1) for acanthosis nigricans and elevated blood
- 24 pressure.
- 25 (e) The office may:
- 26 (1) coordinate the risk assessment for Type 2 diabetes
- 27 [acanthosis nigricans screening] activities of school districts,

- 1 private schools, state agencies, volunteer organizations,
- 2 <u>universities</u>, and other entities so that the efforts of each entity
- 3 are complementary and not fragmented and duplicative; and
- 4 (2) [. The office may] provide technical assistance
- 5 to those entities in developing <u>risk assessment</u> [screening]
- 6 programs.
- 7 <u>(f) The office shall:</u>
- 8 <u>(1)</u> [and may] provide educational and other material
- 9 to assist local <u>risk assessment</u> [screening] activities;
- 10 (2) [. (f) The office shall] monitor the quality of
- 11 <u>risk assessment</u> [<del>screening</del>] activities provided under this
- 12 chapter; and
- 13 (3) consult with the Board of Nurse Examiners to
- 14 determine the training requirements necessary for a nurse or other
- 15 person to conduct risk assessment activities under this chapter.
- 16 (g) The office shall periodically provide information on
- obesity, Type 2 diabetes, and related conditions to physicians.
- 18 Sec. 95.003. COMPLIANCE WITH RISK ASSESSMENT [SCREENING]
- 19 REQUIREMENTS. (a) Each individual required by rules adopted under
- 20 this chapter to be assessed [screened] shall undergo approved risk
- 21 assessment [screening] for Type 2 diabetes [acanthosis nigricans].
- 22 The individual shall comply with the requirements as soon as
- 23 possible after the individual's admission to a school and as
- 24 required by rule. The individual or, if the individual is a minor,
- 25 the minor's parent, managing conservator, or guardian may
- 26 substitute a professional examination for the risk assessment
- 27 [screening].

individual (b) An is exempt from risk assessment [screening] if <u>risk assessment</u> [screening] conflicts with the tenets and practices of a recognized church or religious denomination of which the individual is an adherent or a member. To qualify for the exemption, the individual or, if the individual is a minor, the individual's parent, managing conservator, or guardian must submit to the chief administrator of the school on or before the day of the <u>risk assessment process</u> [screening procedure] an affidavit stating the objections to the risk assessment [screening].

- 11 (c) The chief administrator of each school shall ensure that
  12 each individual admitted to the school complies with the <u>risk</u>
  13 <u>assessment</u> [screening] requirements set by the executive council or
  14 submits an affidavit of exemption.
- Sec. 95.004. RECORDS; 15 REPORTS. (a) The 16 administrator of each school shall maintain, on a form prescribed by the executive council, <u>risk assessment</u> [screening] records for 17 18 each individual in attendance  $[\tau]$  and enter the risk assessment information for each individual on the Centers for Disease Control 19 and Prevention's Epi Info or similar surveillance software selected 20 by the office. The risk assessment [the] records are open for 21 22 inspection by the office or the local health department.
  - (b) The office may, directly or through local health departments, enter a school and inspect records maintained by the school relating to <u>risk assessment</u> [screening] for <u>Type 2 diabetes</u> [acanthosis nigricans].
    - (c) An individual's risk assessment [screening] records may

- 1 be transferred among schools without the consent of the individual
- 2 or, if the individual is a minor, the minor's parent, managing
- 3 conservator, or guardian.
- 4 (d) The person performing the <u>risk assessment</u> [screening]
- 5 shall send a report indicating that an individual may be at risk for
- 6 developing Type 2 diabetes [have acanthosis nigricans] to the
- 7 individual or, if the individual is a minor, the minor's parent,
- 8 managing conservator, or guardian. The report must include:
- 9 (1) an explanation of:
- 10 (A) the process for assessing risk for developing
- 11 Type 2 diabetes;
- 12 (B) the body mass index;
- 13 (C) the risk factors associated with developing
- 14 Type 2 diabetes; and
- 15 (D) the reasons the individual was identified in
- the risk assessment process as being at risk for developing Type 2
- 17 diabetes [acanthosis nigricans and related conditions];
- 18 (2) a statement concerning an individual's or family's
- 19 need for further evaluation for Type 2 diabetes and related [of]
- 20 conditions [related to acanthosis nigricans]; and
- 21 (3) instructions to help the individual or family
- 22 receive evaluation by a physician or other health care provider
- 23 [and intervention by the school district].
- (e) Each school shall submit to the office an annual report
- on the risk assessment [screening] status of the individuals in
- 26 attendance during the reporting year and shall include in the
- 27 report any other information required by the office.

  2 compiled from the information entered into the surveillance
  3 software and be on a form prescribed by the executive council [and
- 4 must be submitted according to the executive council's rules].
- 5 (g) The office shall analyze and compile a summary of the
- 6 reports submitted by schools under Subsection (e), file a copy of
- 7 the summary with the Type 2 Diabetes Risk Assessment Program
- 8 Advisory Committee established under Section 103.0125, and make the
- 9 summary available to schools and the public on request.
- 10 (h) [<del>(f)</del>] Not later than January 15 of each odd-numbered
- 11 year, the office shall submit to the governor, [and] the
- 12 legislature, and the Type 2 Diabetes Risk Assessment Program
- 13 Advisory Committee a report concerning the effectiveness of the
- 14 risk assessment program for Type 2 diabetes [acanthosis nigricans
- 15 screening program] established by this chapter.
- SECTION 4. Chapter 95, Health and Safety Code, as added by
- 17 Chapter 1465, Acts of the 77th Legislature, Regular Session, 2001,
- is amended by adding Section 95.005 to read as follows:
- 19 Sec. 95.005. GIFTS AND GRANTS. The office may accept gifts,
- 20 grants, and donations to support the Type 2 diabetes risk
- 21 assessment program conducted under this chapter.
- 22 SECTION 5. Chapter 103, Health and Safety Code, is amended
- 23 by adding Section 103.0125 to read as follows:
- 24 Sec. 103.0125. TYPE 2 DIABETES RISK ASSESSMENT PROGRAM
- 25 ADVISORY COMMITTEE. (a) The council shall establish the Type 2
- 26 Diabetes Risk Assessment Program Advisory Committee to advise the
- 27 Texas-Mexico Border Health Coordination Office of The University of

- 8 <u>(d) The representative of the council appointed under</u>
- 9 Subsection (b)(1)(A) shall serve as the presiding officer of the
- 10 advisory committee.
- (e) Chapter 2110, Government Code, does not apply to the
- 12 size, composition, or duration of the advisory committee.
- 13 (f) The advisory committee shall:
- 14 (1) recommend the person who should be responsible for
- 15 conducting risk assessment activities under Chapter 95 for schools
- that do not employ a school nurse;
- 17 (2) advise the Texas-Mexico Border Health
- 18 Coordination Office of The University of Texas--Pan American on the
- 19 age groups that would benefit most from the risk assessment
- 20 activities under Chapter 95;
- 21 (3) recommend a method to record and report the number
- of children who are identified in the risk assessment process as
- 23 being at risk for having or developing Type 2 diabetes and who
- 24 qualify for the national free or reduced-price lunch program

- 26 (4) recommend a timeline for the Texas-Mexico Border

- 1 to implement the advisory committee's recommended risk assessment
- 2 activities, surveillance methods, reports, and quality
- 3 improvements; and
- 4 (5) contribute to the state plan for diabetes
- 5 treatment developed by the council under Section 103.013 by
- 6 providing statistics and information on the risk assessment
- 7 activities conducted under Chapter 95 and recommendations for
- 8 assisting children in this state at risk for developing Type 2
- 9 <u>diabetes.</u>
- 10 SECTION 6. (a) As early as possible after the effective
- 11 date of this Act, the executive head of the following entities shall
- 12 appoint a representative to serve on the Type 2 Diabetes Risk
- 13 Assessment Program Advisory Committee created under Section
- 14 103.0125, Health and Safety Code, as added by this Act:
- 15 (1) the Texas Diabetes Council;
- 16 (2) the Department of State Health Services;
- 17 (3) the Texas Education Agency;
- 18 (4) the Texas Medical Association;
- 19 (5) the Texas Pediatric Society;
- 20 (6) the American Heart Association;
- 21 (7) the American Diabetes Association;
- 22 (8) The University of Texas--Pan American; and
- 23 (9) the schools and school district selected by the
- 24 Texas Diabetes Council for this purpose.
- 25 (b) As early as possible after the effective date of this
- 26 Act, the head of the Texas Diabetes Council shall appoint a parent
- or guardian of a child in this state with Type 2 diabetes to serve on

- 4 SECTION 7. Subdivision (6), Section 95.001, Health and
- 5 Safety Code, as added by Chapter 1465, Acts of the 77th Legislature,
- 6 Regular Session, 2001, is repealed.
- 7 SECTION 8. This Act takes effect September 1, 2005.
