Subchapter A, Chapter 161, Health and Safety Code, is amended by adding Section 161.0052 to read as follows: 1**-**14 1**-**15 Sec. 161.0052. IMMUNIZATION OF ELDERLY PERSONS ΒY 1-16 HOSPITALS, END STAGE RENAL DISEASE FACILITIES, AND PHYSICIANS' OFFICES. (a) In this section: 1-17 (1) "Elderly person" means a person who is 65 years of 1-18 age or older. (2) 1-19 1-20 "End stage renal disease facility" has the meaning 1-21 assigned by Section 251.001. (3) "Hospital" has the meaning assigned by Section 1-22 1-23 241.003 (b) The executive commissioner of the Health and Human Services Commission by rule shall require a hospital to inform each 1-24 1-25 1-26 elderly person admitted to the hospital for a period of 24 hours or more that the pneumococcal and influenza vaccines are available. 1-27 If the elderly person requests a vaccine, the hospital must make the 1-28 1-29 vaccination available to the person before the person is discharged 1-30 from the hospital. 1-31 (c) The executive commissioner of the Health and Human Services Commission by rule shall require an end stage renal disease facility to offer, to the extent possible as determined by 1-32 1-33 the facility, the opportunity to receive the pneumococcal and influenza vaccines to each elderly person who receives ongoing care 1-34 1-35 at the facility.
