5	SECTION 1. Section 214.211, Local Government Code, is
6	amended by adding Subdivisions (4) and (5) to read as follows:
7	(4) "International Building Code" means the
8	International Building Code promulgated by the International Code
9	Council.
LO	(5) "Commercial" means a building for the use or

L2	(A) a public purpose or economic gain; or
L3	(B) a residence if the building is a multifamily
L4	residence that is not defined as residential by this section.
L5	SECTION 2. Subchapter G, Chapter 214, Local Government
L6	Code, is amended by adding Section 214.216 to read as follows:
L7	Sec. 214.216. INTERNATIONAL BUILDING CODE. (a) To
L8	protect the public health, safety, and welfare, the International
L9	Building Code, as it existed on May 1, 2003, is adopted as a
20	municipal commercial building code in this state.
21	(b) The International Building Code applies to all
22	commercial buildings in a municipality for which construction
23	begins on or after January 1, 2006, and to any alteration,

remodeling, enlargement, or repair of those commercial buildings.

2	(1) to adopt local amendments to the International
3	Building Code; and
4	(2) for the administration and enforcement of the
5	International Building Code.
6	(d) A local amendment adopted under Subsection (c) may not
7	result in less stringent building requirements than the
8	requirements prescribed by the International Building Code, as it
9	existed on May 1, 2003.
10	(e) A municipality may review and consider amendments made
11	by the International Code Council to the International Building
12	Code after May 1, 2003. Subsection (d) does not apply to an
13	amendment adopted by a municipality under this subsection.
14	SECTION 3. Chapter 233, Local Government Code, is amended
15	by adding Subchapter E to read as follows:
16	SUBCHAPTER E. COMMERCIAL BUILDING CODE
17	Sec. 233.121. DEFINITIONS. In this subchapter:
18	(1) "Commercial" means a building for the use or
19	occupation of people for:
20	(A) a public purpose or economic gain; or
21	(B) a residence if the building is a multifamily
22	residence that is not defined as residential by this section.
23	(2) "International Building Code" means the
24	International Building Code promulgated by the International Code
25	Council.
26	(3) "Residential" means having the character of a
27	detached one-family or two-family dwelling or a multiple

- 1 single-family dwelling that is not more than three stories high
- 2 with separate means of egress, including the accessory structures
- 3 of the dwelling, and that does not have the character of a facility
- 4 used for the accommodation of transient guests or a structure in

- 4 SECTION 4. Before January 1, 2006, rules shall be
- 5 established and other actions taken as necessary:
- 6 (1) by municipalities to implement Section 214.216,
- 7 Local Government Code, as added by this Act; and
- 8 (2) by counties to implement Subchapter E, Chapter
- 9 233, Local Government Code, as added by this Act.
- SECTION 5. (a) Except as provided by Subsection (b) of this
- 11 section, this Act takes effect January 1, 2006.
- 12 (b) This section and Section 4 of this Act take effect
- 13 September 1, 2005.
