A BILL TO BE ENTITLED

1 AN ACT

2 relating to an interim study regarding the operation of certain

3 state health insurance programs.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. INTERIM COMMITTEE; STUDY. The joint interim committee on state health insurance programs is established to study state expenditures on health insurance and health benefit programs and to analyze the feasibility of establishing a separate state agency to administer the health benefit programs currently administered by the Employees Retirement System of Texas, the Teacher Retirement System of Texas, The University of Texas System,

readiler Reellement System of Tenas, The onlyerstey of Tenas Sy

12 and The Texas A&M University System.

13 SECTION 2. COMPOSITION OF COMMITTEE. (a) The joint 14 interim committee shall be composed of five senators and five

15 members of the house of representatives, as follows:

16 (1) the chair of the senate finance committee, the

chair of the senate state affairs committee, and three senators

18 appointed by the lieutenant governor; and

19 (2) the chair of the appropriations committee of the

house of representatives, the chair of the insurance committee of

the house of representatives, and three members of the house of

representatives appointed by the speaker of the house of

24 (b) The lieutenant governor and speaker of the house of

- 1 representatives shall each designate a co-chair from among the
- 2 committee members.
- 3 SECTION 3. COMMITTEE MEETINGS. The joint interim committee
- 4 shall meet initially at the joint call of the co-chairs, and the
- 5 committee shall subsequently hold meetings and public hearings at
- 6 the call of the co-chairs.
- 7 SECTION 4. COMMITTEE POWERS AND DUTIES. The joint interim
- 8 committee has all powers and duties provided to special committees
- 9 by the senate and house of representatives rules of procedure, by
- 10 Subchapter B, Chapter 301, Government Code, and by policies of the
- 11 committees on administration.
- 12 SECTION 5. COMMITTEE FUNDING. (a) From the contingent
- 13 expense fund of the senate and the contingent expense fund of the
- 14 house of representatives equally, the members of the joint interim
- 15 committee shall be reimbursed for expenses incurred in carrying out
- 16 the provisions of this Act in accordance with the senate and house
- 17 of representatives rules of procedure and the policies of the
- 18 committees on administration.
- 19 (b) Other necessary expenses of operation shall be paid from
- 20 the contingent expense fund of the senate and the contingent
- 21 expense fund of the house of representatives equally.
- 22 SECTION 6. REPORT. The joint interim committee shall make a
- 23 complete written report, including findings and recommendations
- 24 and drafts of recommended legislation, to the 80th Legislature when
- it convenes in January, 2007.
- 26 SECTION 7. EFFECTIVE DATE. This Act takes effect September
- 27 1, 2005.
