1-10 relating to the prohibition of signs on certain roads.
1-11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
1-12 SECTION 1. Subsection (a), Section 391.252, Transportation
1-13 Code, is amended to read as follows:
1-14 (a) ~~A [Subsequent to the effective date of this subchapter,~~
1-15 ~~a]~~ person may not erect an off-premise sign that is adjacent to and
1-16 visible from:
1-17 (1) U.S. Highway 290 between the western city limits
1-18 of the city of Austin and the eastern city limits of the city of
1-19 Fredericksburg;
1-20 (2) State Highway 317 between the northern city limits
1-21 of the city of Belton to the southern city limits of the city of
1-22 Valley Mills;
1-23 (3) State Highway 16 between the northern city limits
1-24 of the city of Kerrville and Interstate Highway 20;
1-25 (4) U.S. Highway 77 between State Highway 186 and
1-26 State Highway 44;
1-27 (5) U.S. Highway 281 between State Highway 186 and
1-28 Farm-to-Market Road 3162 [~~Interstate Highway 37~~];
1-29 (6) State Highway 17 between State Highway 118 and
1-30 U.S. Highway 90;
1-31 (7) State Highway 67 between U.S. Highway 90 and
1-32 Farm-to-Market Road 170;
1-33 (8) Farm-to-Market Road 170 between State Highway 67

1-35 (9) State Highway 118 between Farm-to-Market Road 170

1-37 (10) State Highway 105 between the western city limits
