- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 24.205, Government Code, is amended to
- 6 read as follows:
- 7 Sec. 24.205. 103rd JUDICIAL DISTRICT (CAMERON COUNTY [AND
- 8 WILLACY COUNTIES]). (a) The 103rd Judicial District is composed
- 9 of Cameron County [and Willacy counties]. The court shall give
- 10 preference to civil cases.
- 11 (b) The 103rd, 107th, and 138th district courts have
- 12 concurrent jurisdiction.
- 13 (c) The terms of the 103rd District Court begin[+
- 14 [(1) in Cameron County] on the first Mondays in
- 15 February and July[; and
- 16 [(2) in Willacy County on the first Mondays in January
- 17 and June].
- 18 (d) The judges of the 103rd and 107th district courts need
- 19 not impanel grand juries except in cases of emergency.
- SECTION 2. Section 24.209, Government Code, is amended to
- 21 read as follows:
- Sec. 24.209. 107th JUDICIAL DISTRICT (CAMERON COUNTY [AND
- 23 WILLACY COUNTIES]). (a) The 107th Judicial District is composed
- 24 of Cameron County [and Willacy counties]. The court shall give

- 1 preference to criminal cases.
- 2 (b) The terms of the 107th District Court begin on the first
- 3 Mondays in January and July.
- 4 (c) Section 24.205, relating to the 103rd District Court,
- 5 contains provisions applicable to both that court and the 107th
- 6 District Court.
- 7 SECTION 3. Section 24.240, Government Code, is amended to
- 8 read as follows:
- 9 Sec. 24.240. 138th JUDICIAL DISTRICT (CAMERON <u>COUNTY</u> [AND
- 10 WILLACY COUNTIES]). (a) The 138th Judicial District is composed
- 11 of Cameron County [and Willacy counties]. The court shall give
- 12 preference to criminal cases.
- 13 (b) The terms of the 138th District Court begin[+
- 14 [(1) in Cameron County] on the first Mondays in March,
- 15 July, and November [; and
- 16 [(2) in Willacy County on the first Mondays in
- 17 January, May, and September].
- 18 (c) The judge of the 138th District Court shall impanel
- 19 grand juries at all times required by law.
- 20 (d) Section 24.205, relating to the 103rd District Court,
- 21 contains provisions applicable to both that court and the 138th
- 22 District Court.
- SECTION 4. Section 24.503, Government Code, is amended to
- 24 read as follows:
- Sec. 24.503. 357th JUDICIAL DISTRICT (CAMERON COUNTY [AND
- 26 WILLACY COUNTIES]). The 357th Judicial District is composed of
- 27 Cameron County [and Willacy counties].

- 1 SECTION 5. Section 24.549, Government Code, is amended to
- 2 read as follows:
- 3 Sec. 24.549. 404th JUDICIAL DISTRICT (CAMERON COUNTY [AND
- 4 WILLACY COUNTIES]). The 404th Judicial District is composed of
- 5 Cameron County [and Willacy counties].
- 6 SECTION 6. (a) The local administrative district judge
- 7 shall transfer all cases from Willacy County that are pending in the
- 8 103rd, 107th, 138th, 357th, and 404th district courts on September
- 9 1, 2005, to the 197th District Court.
- 10 (b) When a case is transferred as provided by Subsection (a)
- 11 of this section, all processes, writs, bonds, recognizances, or
- other obligations issued from the 103rd, 107th, 138th, 357th, and
- 13 404th district courts are returnable to the 197th District Court as
- 14 if originally issued by that court. The obligees on all bonds and
- recognizances taken in and for the 103rd, 107th, 138th, 357th, and
- 16 404th district courts and all witnesses summoned to appear in those
- 17 courts are required to appear before the 197th District Court as if
- 18 originally required to appear before that court.
- 19 SECTION 7. This Act takes effect September 1, 2005.
