1 AN ACT

- 2 relating to the authority of the Barton Springs-Edwards Aquifer
- 3 Conservation District to charge certain fees.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. The legislature finds that the Barton
- 6 Springs-Edwards Aquifer Conservation District benefits the
- 7 sustainable use of groundwater by promoting, through fee and
- 8 permitting mechanisms, alternatives to the exclusive use of
- 9 groundwater resources, including the conjunctive use of
- 10 groundwater and surface water resources.
- 11 SECTION 2. Section 2, Chapter 429, Acts of the 70th
- 12 Legislature, Regular Session, 1987, is amended by amending
- 13 Subsection (f)(2) and adding Subsections (g) and (h) to read as
- 14 follows:
- 15 (2) The board may assess the City of Austin, as a water
- 16 use fee, each year an amount not to exceed 60 [40] percent of the
- 17 total funding of the district received from water use fees assessed
- 18 against Austin and other nonexempt users. For purposes of this
- 19 section, the total annual funding of the district received from
- 20 water use fees assessed against Austin and other nonexempt users is
- 21 determined using the rates in effect for permits issued for water
- 22 used for any purpose other than agricultural use immediately before
- 23 September 1, 2005.
- 24 (g) Except as provided by Subsection (h), the board may not

- 1 charge an annual production fee of more than \$1 per acre-foot for
- 2 water used for agricultural use or 17 cents per thousand gallons of
- 3 water used for any other purpose. The board may adopt a
- 4 differential rate structure for non-agricultural production fees
- 5 to promote alternatives to the exclusive use of groundwater
- 6 <u>resources.</u>
- 7 (h) For a permit approved or materially amended after
- 8 September 1, 2005, or a permit issued after September 9, 2004, and
- 9 renewed after September 1, 2005, the board may charge an annual
- 10 production fee of not more than 31 cents per thousand gallons for
- 11 water used for any purpose other than agricultural use.
- 12 SECTION 3. Section 36.205(d), Water Code, is amended to
- 13 read as follows:
- 14 (d) The [Barton Springs-Edwards Aquifer Conservation
- 15 District, the Lone Star Groundwater Conservation District $[\tau]$ and
- 16 the Guadalupe County Groundwater Conservation District may not
- 17 charge production fees for an annual period greater than \$1 per
- 18 acre-foot for water used for agricultural use or 17 cents per
- 19 thousand gallons for water used for any other purpose. [The Barton
- 20 Springs-Edwards Aquifer Conservation District may assess a water
- 21 use fee against a specific municipality in an amount not to exceed
- 22 60 percent of the total funding of the district received from water
- 23 use fees assessed against that municipality and other nonexempt
- 24 users in the district.] This subsection shall take precedence over
- 25 all prior enactments.
- SECTION 4. This Act takes effect September 1, 2005.
