S.B. No. 1686

A BILL TO BE ENTITLED

AN ACT

relating to the interagency work group on rural issues.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Section 487.054, Government Code, is amended by amending Subsection (a) and adding Subsection (c) to read as follows:

(a) At least once each year, the following agency heads or their designees shall meet in Austin to discuss rural issues and to provide information showing the impact each agency has on rural communities for use in developing rural policy and compiling the annual report under Section 487.051(4):

(1) the commissioner of agriculture;

(2) the executive director of the Public Utility Commission of Texas;

(3) the director of the Texas Agricultural Extension Service;

(4) the presiding officer of the Telecommunications Infrastructure Fund Board;

(5) the executive director of the Texas Department of Housing and Community Affairs;

(6) the commissioner of the Department of State Health Services ~~health~~;

(7) the executive administrator of the Texas Water Development Board;

6 (a), the governor shall designate a representative from the entity
7 that provides mediation services to the state under 7 U.S.C.

9 SECTION 2. This Act takes effect September 1, 2005.
