A BILL TO BE ENTITLED 1 AN ACT 2 relating to the regulation of a poultry operation that does not use 3 a liquid waste handling system. Δ BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: SECTION 1. Section 26.0286, Water Code, is amended to read 5 6 as follows: Sec. 26.0286. PROCEDURES APPLICABLE TO PERMITS FOR CERTAIN 7 CONCENTRATED ANIMAL FEEDING OPERATIONS. (a) In this section: 8 (1) "Sole-source surface drinking water supply" means 9 a body of surface water that is designated as a sole-source surface 10 drinking water supply in rules adopted by the commission. 11 "Protection zone" means an area so designated by 12 (2) 13 commission rule under Subsection (c). 14 (3) "Liquid waste handling system" means a system in 15 which fresh water or wastewater is used for transporting and land applying waste. 16 17 (b) The commission shall process an application for authorization to construct or operate a concentrated animal feeding 18 19 operation as a specific permit under Section 26.028 subject to the procedures provided by Subchapter M, Chapter 5, if, on the date the 20 commission determines that the application is administratively 21 22 complete, any part of a pen, lot, pond, or other type of control or 23 retention facility or structure of the concentrated animal feeding 24 operation is located or proposed to be located within the

protection zone of a sole-source surface drinking water supply.
For the purposes of this subsection, a land application area is not considered a control or retention facility.

4 (c) For the purposes of this section only, when adopting rules under Section 26.023 to set water quality standards for water 5 in the state, the commission by rule shall designate a surface water 6 7 body as a sole-source surface drinking water supply if that surface water body is identified as a public water supply in rules adopted 8 9 by the commission under Section 26.023 and is the sole source of 10 supply of a public water supply system, exclusive of emergency 11 water connections. At the same time, the commission shall designate as a protection zone any area within the watershed of a 12 13 sole-source surface drinking water supply that is:

(1) within two miles of the normal pool elevation of a body of surface water that is a sole-source surface drinking water supply;

17 (2) within two miles of that part of a perennial stream18 that is:

(A) a tributary of a sole-source surface drinkingwater supply; and

(B) within three linear miles upstream of the normal pool elevation of a sole-source surface drinking water supply; or

(3) within two miles of that part of a stream that is a
sole-source surface drinking water supply, extending three linear
miles upstream from the water supply intake.

27 (d) This section does not apply to a poultry operation that

1 does not use a liquid waste handling system.

2 SECTION 2. This Act takes effect immediately if it receives 3 a vote of two-thirds of all the members elected to each house, as 4 provided by Section 39, Article III, Texas Constitution. If this 5 Act does not receive the vote necessary for immediate effect, this 6 Act takes effect September 1, 2005.
