5	SECTION 1. Subchapter Z, Chapter 51, Education Code, is
6	amended by adding Section 51.949 to read as follows:
7	Sec. 51.949. INFORMATION FOR BOOKSTORES RELATING TO
8	<pre>INSTRUCTIONAL MATERIALS. (a) In this section:</pre>
9	(1) "Institution of higher education" has the meaning
10	assigned by Section 61.003.
11	(2) "Instructional materials" means any printed or
12	computer-generated educational material, including textbooks, or
13	any equipment or supplies that a student is required or recommended
14	to use in connection with a course.
15	(3) "University-affiliated bookstore" means a store
16	that sells instructional materials, regardless of whether the store
17	is located on the campus of an institution of higher education, and
18	that is operated by or with the approval of the institution through
19	ownership, a management agreement, a lease or rental agreement, or
20	otherwise.
21	(b) Each institution of higher education shall provide on
22	request to a retailer or other provider of instructional materials
23	any list of required or recommended instructional materials for a

semester or other academic term at the same time the institution

- 3 (c) To the extent that space for an activity described by
- 4 this subsection is available, an institution of higher education
- 5 shall provide to a retailer or other provider of instructional

- 8 related to the dissemination or provision of instructional
- 9 <u>materials</u> for students of the institution, including providing

- 12 (d) An institution of higher education may not charge
- another provider of instructional materials an amount greater than
- 14 the amount charged the operator of a university-affiliated

- 16 (e) If an institution of higher education works in
- 17 conjunction with a university-affiliated bookstore to provide a
- 18 method for the extension of credit or the ability of a student to
- 19 charge or otherwise delay the payment of the costs of instructional
- 20 materials, including the extension of credit under Section
- 21 51.929(b), the institution shall provide any other person providing
- 22 <u>instructional materials to students of the institution with equal</u>
- 23 access and opportunity to use or develop the same or similar method
- of payment at a reasonable cost to that person.
- 25 SECTION 2. (a) This Act applies only to a semester or term
- 26 that begins on or after the effective date of this Act.
- (b) This Act does not affect the terms of a contract entered

- 2 (c) As soon as practicable on or after the effective date of
- 3 this Act, each institution of higher education shall designate an
- 4 officer or employee of the institution to ensure the institution's
- 5 compliance with Section 51.949, Education Code, as added by this
- 6 Act.
- 7 SECTION 3. This Act takes effect immediately if it receives
- 8 a vote of two-thirds of all the members elected to each house, as
- 9 provided by Section 39, Article III, Texas Constitution. If this
- 10 Act does not receive the vote necessary for immediate effect, this
- 11 Act takes effect September 1, 2005.
