Not later than September 30, 2005:

(1) the governing body of the City of Lubbock shall appoint five directors under Section 3501.051, Special District Local Laws Code, as amended by this Act, to serve terms beginning October 1, 2005, with two directors' terms expiring September 30, 2007, and three directors' terms expiring September 30, 2009;

16 (2) the commissioners court of Lubbock County shall
17 appoint one director under Section 3501.051, Special District Local
18 Laws Code, as amended by this Act, to serve a term beginning October
19 1, 2005, and expiring September 30, 2007; and

(3) the South Plains Association of Governments shall
appoint one director under Section 3501.051, Special District Local
Laws Code, as amended by this Act, to serve a term beginning October
1, 2005, and expiring September 30, 2009.

SECTION 4. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this
