A BILL TO BE ENTITLED

1	AN ACT
2	relating to the establishment and operation of a public building
3	mapping information system by the Texas Building and Procurement
4	Commission.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Chapter 2152, Government Code, is amended by
7	adding Subchapter D to read as follows:
8	SUBCHAPTER D. PUBLIC BUILDING MAPPING INFORMATION SYSTEM
9	Sec. 2152.151. DEFINITIONS. In this subchapter:
10	(1) "Committee" means the Public Building Mapping
11	Information System Committee under Section 2152.155.
12	(2) "First responder" means:
13	(A) a public safety employee whose primary duties
14	include responding rapidly to an emergency as the first person to
15	arrive at the scene of the emergency;
16	(B) a person who is defined as fire protection
17	personnel under Section 419.021;
18	(C) a volunteer firefighter certified by the
19	Texas Commission on Fire Protection or the State Firemen's and Fire
20	Marshals' Association of Texas; and
21	(D) a peace officer or firefighter who provides
22	first responder services under an interlocal agreement.
23	(3) "Maps and other information" means the information
24	required by the commission under Section 2152.152(b).

1	(4) "Public agency" means the state or a political
2	subdivision of the state.
3	(5) "Public building" means any building owned or
4	occupied by a public agency.
5	Sec. 2152.152. INFORMATION SYSTEM. (a) The commission,
6	with the advice of the committee, shall establish and operate a
7	statewide public building mapping information system for the
8	purpose of storing information related to public buildings in an
9	electronic format that will be readily accessible to first
10	responders in the event of an emergency.
11	(b) Subject to available funding, the commission, with the
12	advice of the committee, shall develop a plan to create or obtain,
13	as appropriate, the following information relating to public
14	buildings for the purpose of storing the information in the public
15	building mapping information system:
16	(1) floor plans and other relevant building maps;
17	(2) fire protection information;
18	(3) evacuation plans;
19	(4) utility information;
20	(5) known hazards;
21	(6) text and digital images showing emergency
22	personnel contact information; and
23	(7) other information determined by the committee to
24	be necessary.
25	Sec. 2152.153. SOFTWARE STANDARDS AND FORMAT REQUIREMENTS.
26	The commission, with the advice of the committee:
27	(1) shall develop software standards and format

- 1 requirements for the creation and storage of maps and other
- 2 information relating to public buildings by all public agencies;
- 3 and
- 4 (2) may refuse to accept for storage in the system any
- 5 submitted maps and other information that do not comply with the
- 6 software standards or format required by the commission.
- 7 Sec. 2152.154. SUBMISSION OF INFORMATION. (a) Each public
- 8 agency that creates or stores maps and other information related to
- 9 a public building shall submit the maps and information to the
- 10 commission for storage in the public building mapping information
- 11 system.
- 12 (b) A private entity that creates or stores maps and other
- information related to a public building may voluntarily provide
- 14 the maps and information to the commission for storage in the public
- building mapping information system.
- Sec. 2152.155. COMMITTEE. (a) The Public Building Mapping
- 17 Information System Committee is an advisory entity administered by
- 18 the commission.
- 19 (b) The commission may adopt rules necessary for the
- 20 operation of the committee.
- 21 (c) The committee is composed of one representative of each
- 22 of the following entities, appointed by the single statewide
- 23 elected or appointed governing officer or administrative head of
- 24 the entity:
- 25 (1) the commission;
- 26 (2) the Department of Public Safety;
- 27 (3) the Department of Information Resources;

1	(4) the Texas Association of Counties;
2	(5) the Texas Municipal League;
3	(6) the Sheriffs' Association of Texas;
4	(7) the Texas Police Chiefs Association; and
5	(8) the Texas Fire Chiefs Association.
6	(d) The committee shall develop recommendations for the
7	<pre>commission with respect to:</pre>
8	(1) the information required to be included in the
9	<pre>public building mapping information system;</pre>
LO	(2) the software standards and required format for
L1	maps and other information to be included in the public building
L2	<pre>mapping information system;</pre>
L3	(3) a plan for the creation and storage of maps and
L4	other information that, based on the availability of funding,
L5	specifies the order in which the information shall be created and
L6	stored;
L7	(4) the manner in which information in the public
L8	building mapping information system shall be accessed, including
L9	detailed procedures and security systems that will ensure
20	information is made available only to appropriate persons at
21	appropriate times; and
22	(5) guidelines for training related to the use of the
23	public building mapping information system.
24	Sec. 2152.156. AVAILABILITY OF INFORMATION. The
25	commission, with the advice of the committee, shall develop
26	procedures for the release of information in the public building
27	mapping information system to first responders in the event of an

- 1 <u>emergency</u>.
- 2 Sec. 2152.157. ACCESS TO INFORMATION. This subchapter does
- 3 not apply to the extent that it interferes with the ability of a
- 4 public agency to control and maintain access to information in an
- 5 information system other than the public building mapping
- 6 <u>information system.</u>
- 7 Sec. 2152.158. FUNDING. The commission shall apply for
- 8 federal funding available for purposes related to this subchapter.
- 9 If the commission obtains a federal grant for public building
- 10 mapping, the commission shall use the grant to:
- 11 (1) establish and maintain the public building mapping
- information system under this subchapter; and
- 13 (2) administer grants to other public agencies in
- 14 accordance with federal and state guidelines to assist with the
- creation and storage of maps and other information according to the
- 16 plan developed by the commission with the advice of the committee.
- 17 Sec. 2152.159. EXCEPTION FROM PUBLIC INFORMATION LAW.
- 18 Information received and maintained by the commission under this
- 19 subchapter is excepted from required disclosure under the public
- 20 <u>information law, Chapter 552.</u>
- 21 Sec. 2152.160. LOCAL GOVERNMENT IMMUNITY. A local
- 22 government and its employees are immune from civil liability from
- 23 any act or omission relating to the creation and use of the public
- 24 building mapping information system under this subchapter, unless
- 25 the act or omission was grossly negligent or done in bad faith.
- SECTION 2. Notwithstanding Subchapter D, Chapter 2152,
- 27 Government Code, as added by this Act, a public agency is not

- 1 required to create or store maps and other information related to
- 2 public buildings owned or occupied by the agency unless all related
- 3 costs are provided to the public agency specifically for that
- 4 purpose by the Texas Building and Procurement Commission or another
- 5 entity.
- 6 SECTION 3. (a) Not later than December 1, 2005, the Texas
- 7 Building and Procurement Commission shall develop software
- 8 standards and format requirements in accordance with Section
- 9 2152.153, Government Code, as added by this Act.
- 10 (b) A public agency is not required to comply with Section
- 11 2152.153, Government Code, as added by this Act, until the software
- 12 standards and format requirements are developed by the Texas
- 13 Building and Procurement Commission in accordance with that
- 14 section.
- 15 SECTION 4. If, before the establishment of the public
- 16 building mapping information system under Subchapter D, Chapter
- 17 2152, Government Code, as added by this Act, a local government
- 18 establishes an independent building mapping system or creates or
- 19 stores maps and other information related to a public building
- 20 using software standards and format requirements other than those
- 21 established under Section 2152.153, Government Code, as added by
- this Act, the local government may continue to use its independent
- 23 building mapping system and unique software standards and format
- 24 until the Texas Building and Procurement Commission provides
- 25 funding necessary to modify the local government's information
- 26 system to achieve compatibility with the standards and format
- 27 requirements established by the commission under Section 2152.153,

- 1 Government Code, as added by this Act.
- 2 SECTION 5. This Act takes effect immediately if it receives
- 3 a vote of two-thirds of all the members elected to each house, as
- 4 provided by Section 39, Article III, Texas Constitution. If this
- 5 Act does not receive the vote necessary for immediate effect, this
- 6 Act takes effect September 1, 2005.
