THENCE $S 4^{\circ} 0^{\prime} 3^{\prime \prime} \mathrm{E}$, along the North line of said Veach tract, 312.00 feet to a point for corner;

THENCE S $45^{\circ} 44^{\prime} 52^{\prime \prime} \mathrm{W}$, feet along the said Veach tract, $1,168.40$ feet to a point for corner in the East corner of the Gracon Construction Co. 5.00 acre tract;
THENCE N 44.20'58" W , along the Northeast line of said 5.0 acre tract, 500.00 feet to a point for corner;
THENCE $S 45^{\circ} 44^{\prime \prime} 52^{\prime \prime} \mathrm{W}$, along the Northwest line of said 5.0 acre tract, 459.76 feet to a point for corner, said point being in the Center line of Lasater Road;
THENCE $S$ 44.43'00" E, along the Center line of Lasater Road, 3,205.10 feet to a point for corner, said point being in the North right of way line of Interstate Highway 20 ;
THENCE along the Northerly right of way of said Interstate Highway 20 as follows:

S 89²1'55" W, 2,548.44 feet to smooth 5/8 inch iron rod found near a concrete post;

S 8414'41" W, 784.25 to a point for corner;
S 76¹8'13" W, 558.93 feet to a point for corner;
S $8^{\circ} 2^{\prime} 9^{\prime} 13^{\prime \prime} \mathrm{W}, 1,758.06$ feet to a point for corner, said point being in the East line of the C.L. REED Survey Abstract No. 1265 and the West line of the J.M. SMITH Survey Abstract No. 1374, Dallas County Texas, said point also being 1,300 feet East of the centerline of Pioneer Road;
THENCE S 0155'00" W, crossing said Interstate Highway 20, along a line 1,300 feet East and parallel to the centerline of Pioneer Road, 753.09 feet to a point for a corner, said point being 1,000 feet South of the centerline of Seagoville Road;
THENCE N 8932'50" W, 5,629.02 feet along a line 1,000 feet South of and parallel to Seagoville Road to the POINT OF BEGINNING. Said tract containing 6260 acres of land more or less.

SECTION 6. NO ADDITIONAL POWERS OR DUTIES. This Act does not grant any additional powers or duties to the district.

SECTION 7. FINDINGS RELATED TO PROCEDURAL REQUIREMENTS. The legislature finds that:
(1) the proper and legal notice of the intention to introduce this Act, setting forth the general substance of this Act, has been published as provided by law, and the notice and a copy of this Act have been furnished to all persons to which they are required to be furnished by the constitution and laws of this state; and
(2) all requirements of the constitution and laws of this state and rules and procedures of the legislature with respect to the notice, introduction, and passage of this Act are fulfilled and accomplished.

SECTION 8. EFFECTIVE DATE. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas
