C.S.S.B. No. 1803

A BILL TO BE ENTITLED

AN ACT

relating to the creation of the Galveston County Municipal Utility District No. 63; providing authority to impose taxes and issue bonds; granting the power of eminent domain.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle F, Title 6, Special District Local Laws Code, is amended by adding Chapter 8145 to read as follows:

CHAPTER 8145. GALVESTON COUNTY MUNICIPAL UTILITY DISTRICT

NO. 63

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 8145.001. DEFINITIONS. In this chapter:

(1) "Board" means the board of directors of the district.

(2) "City" means the City of Texas City, Texas.

(3) "Director" means a member of the board.

(4) "District" means the Galveston County Municipal Utility District No. 63.

Sec. 8145.002. NATURE OF DISTRICT. The district is a municipal utility district in Galveston County created under and essential to accomplish the purposes of Section 59, Article XVI, Texas Constitution.

Sec. 8145.003. CONFIRMATION ELECTION REQUIRED. The board shall hold an election to confirm the creation of the district as provided by Section 49.102, Water Code.

1 Sec. 8145.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE. (a)
2 All land and other property included in the district will benefit
3 from the improvements and services to be provided by the district
4 under powers conferred by Section 52, Article III, and Section 59,
5 Article XVI, Texas Constitution.

6 (b) The district is created to accomplish:

7 (1) the same purposes as a municipal utility district
8 as provided by Section 54.012, Water Code;

9 (2) the same purposes as a navigation district created
10 under Section 59, Article XVI, Texas Constitution, and operating
11 under Chapters 60 and 62, Water Code; and

12 (3) to the extent authorized by Section 52, Article
13 III, Texas Constitution, the construction, acquisition,
14 improvement, maintenance, or operation of macadamized, graveled,
15 or paved roads or turnpikes, or improvements in aid of those roads
16 or turnpikes, inside the district.

17 Sec. 8145.005. INITIAL DISTRICT TERRITORY. (a) The
18 district is initially composed of the territory described by
19 Section 2 of the Act creating this chapter.

20 (b) The boundaries and field notes contained in Section 2 of
21 the Act creating this chapter form a closure. A mistake made in the
22 field notes or in copying the field notes in the legislative process
23 does not affect the district's:

24 (1) organization, existence, or validity;

25 (2) right to issue any type of bond for the purposes
26 for which the district is created or to pay the principal of and
27 interest on a bond;

1 (3) right to impose or collect an assessment or tax; or

2 (4) legality or operation.

4 SUBCHAPTER B. BOARD OF DIRECTORS

5 Sec. 8145.051. DIRECTORS; TERMS. (a) The district is
6 governed by a board of five directors.

7 (b) Except as provided by Section 8145.053, directors serve
8 staggered four-year terms.

9 Sec. 8145.052. ELECTION OF DIRECTORS. On the uniform
10 election date in May of each even-numbered year, the appropriate
11 number of directors shall be elected.

12 Sec. 8145.053. INITIAL DIRECTORS. (a) The initial board
13 consists of:

14 (1) Patrick Carmichael;

15 (2) Matthew Mannen;

16 (3) Matthew May;

17 (4) Gigi Strang; and

18 (5) Jason H. Styles.

19 (b) The terms of the first three directors named in
20 Subsection (a) expire on the uniform election date in May 2006, and
21 the terms of the last two directors named in Subsection (a) expire
22 on the uniform election date in May 2008.

23 (c) This section expires September 1, 2009.

25 SUBCHAPTER C. GENERAL POWERS AND DUTIES

26 Sec. 8145.101. GENERAL POWERS AND DUTIES. The district has
27 the powers and duties necessary to accomplish the purposes for

1 which the district is created.

2 Sec. 8145.102. MUNICIPAL UTILITY DISTRICT POWERS AND
3 DUTIES. The district has the powers and duties provided by the
4 general law of this state, including Chapters 49 and 54, Water Code,
5 applicable to municipal utility districts created under Section 59,
6 Article XVI, Texas Constitution.

7 Sec. 8145.103. NAVIGATION POWERS. The district may
8 purchase, construct, acquire, own, operate, maintain, improve, or
9 extend, inside and outside the district, canals, waterways,
10 bulkheads, docks, and any other improvements or facilities
11 necessary or convenient to accomplish the navigation purposes of
12 the district authorized by Section 59, Article XVI, Texas
13 Constitution.

14 Sec. 8145.104. ROAD PROJECTS. (a) The district may
15 construct, acquire, improve, maintain, or operate macadamized,
16 graveled, or paved roads or turnpikes, or improvements in aid of
17 those roads or turnpikes, inside the district.

18 (b) A road project must meet all applicable construction
19 standards, zoning and subdivision requirements, and regulatory
20 ordinances of the municipality or county in whose jurisdiction the
21 district is located.

22 (c) The district may not undertake a road project unless
23 each municipality or county in whose jurisdiction the district is
24 located consents by ordinance or resolution.

25 Sec. 8145.105. COMPLIANCE WITH MUNICIPAL CONSENT
26 ORDINANCES OR RESOLUTIONS. Subject to the limitations of Section
27 54.016, Water Code, the district shall comply with all applicable

1 requirements of any ordinance or resolution adopted by the city
2 council that consents to the creation of the district or to the
3 inclusion of lands within the district.

4 Sec. 8145.106. LIMITATION ON USE OF EMINENT DOMAIN. The
5 district may exercise the power of eminent domain outside the
6 district only to acquire an easement necessary for underground
7 water, sewage, or drainage facilities that serve the district.

9 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

10 Sec. 8145.151. ELECTIONS REGARDING TAXES OR BONDS. (a)
11 Except as provided by Section 8145.201(c), the district may issue,
12 without an election, bonds and other obligations secured by revenue
13 or contract payments from any lawful source other than ad valorem
14 taxation.

15 (b) The district must hold an election in the manner
16 provided by Chapters 49 and 54, Water Code, to obtain voter approval
17 before the district may impose a maintenance tax or issue bonds
18 payable from ad valorem taxes.

19 Sec. 8145.152. AD VALOREM TAX. (a) If authorized at an
20 election held under Section 8145.151, the district may impose an
21 annual ad valorem tax on taxable property in the district for the
22 provision of services or for the maintenance and operation of the
23 district, including the construction, acquisition, maintenance,
24 and operation of improvements.

25 (b) The board shall determine the tax rate. The rate may not
26 exceed the rate approved at the election.

1 SUBCHAPTER E. BONDS AND OTHER OBLIGATIONS

2 Sec. 8145.201. AUTHORITY TO ISSUE BONDS AND OTHER
3 OBLIGATIONS. (a) The district may issue bonds or other obligations
4 payable wholly or partly from ad valorem taxes, impact fees,
5 revenue, grants, or other district money, or any combination of
6 those sources, to pay for any authorized district purpose.

7 (b) In exercising the district's borrowing power, the
8 district may issue a bond or other obligation in the form of a bond,
9 note, certificate of participation, or other instrument evidencing
10 a proportionate interest in payments to be made by the district, or
11 other type of obligation.

12 (c) The district may not issue bonds to finance projects
13 authorized by Section 8145.104 unless the issuance is approved by a
14 vote of a two-thirds majority of the voters of the district voting
15 at an election called for that purpose.

16 (d) Bonds or other obligations issued or incurred to finance
17 projects authorized by Section 8145.104 may not exceed one-fourth
18 of the assessed value of the real property in the district.

19 (e) Sections 49.181 and 49.182, Water Code, do not apply to
20 a project undertaken by the district under Section 8145.104 or to
21 bonds issued by the district to finance the project.

22 Sec. 8145.202. TAXES FOR BONDS AND OTHER OBLIGATIONS. At
23 the time bonds or other obligations payable wholly or partly from ad
24 valorem taxes are issued:

25 (1) the board shall impose a continuing direct annual
26 ad valorem tax, without limit as to rate or amount, for each year
27 that all or part of the bonds are outstanding; and

1 (2) the district annually shall impose an ad valorem
2 tax on all taxable property in the district in an amount sufficient
3 to:

4 (A) pay the interest on the bonds or other
5 obligations as the interest becomes due;

6 (B) create a sinking fund for the payment of the
7 principal of the bonds or other obligations when due or the
8 redemption price at any earlier required redemption date; and

9 (C) pay the expenses of imposing the taxes.

10 SECTION 2. The Galveston County Municipal Utility District
11 No. 63 initially includes all the territory contained in the
12 following area:

13 TRACT 1

14 Description of 249.1201 acres of land being part of Subdivisions A,
15 E, F, C, and L, of the KOHFELDT'S RESUBDIVISION according to the map
16 or plat thereof recorded in Volume 10, Page 35 of the Deed Records
17 of Galveston County, Texas. Said 249.1201 being part of the tracts
18 of land conveyed by deed dated March 22, 2004 from Kohfeldt family
19 Limited Partnership, to Texas Gulf Coast Holdings I LP., as
20 recorded in Galveston County Clerk's File No. GAC 2004020691, of
21 the Deed Records of Galveston County, Texas, and being all of the
22 property conveyed by deed dated December 12, 2003 from Presbyterian
23 Children's Homes and Services to Texas Gulf Coast Holdings I LP., as
24 recorded in Galveston County Clerk's File No. GAC 2003089572, of
25 the Deed Records of Galveston County, Texas. Said 249.1201 acres
26 being situated in the Thomas W. Johnson Survey and the James Smith
27 Survey, Galveston County, Texas, and being more particularly

described by metes and bounds as follows; (Bearings based plat calls of said Kohfeldts Resubdivision)

COMMENCING at a point for corner at the intersection of the north line of F.M. 1764 with the northeasterly line of the G.H. & H. R.R. railroad right-of-way adjacent to State Highway 3;

THENCE North $39^{\circ} 12' 00''$ West, along the said northeasterly line of the G.H. & H. R.R. railroad right-of-way, for a distance of 557.48 feet to a to a point for corner;

THENCE in a easterly direction along the perimeter of the 190.6 acre
tract (Golf Course), the following calls;

North 87° 28' 47" East, for a distance of 30.11 feet to a to a
point for corner;

South 36° 30' 23" East, for a distance of 49.19 feet to a to a
point for corner;

North 87° 28' 47" East, for a distance of 54.39 feet to a to a point
for corner;

North 85° 48' 20" East, for a distance of 1,121.18 feet to a to a
point for corner;

North 23° 36' 58" West, for a distance of 280.94 feet to a to a point
for corner;

North 81° 28' 44" East, for a distance of 1,708.56 feet to a to a
point for corner;

South 68° 58' 23" East, for a distance of 735.29 feet to a to a point
for corner;

North 68° 34' 30" East, for a distance of 533.76 feet to a to a point
for corner;

for corner in the west line of a 100' Texas & New Orleans Rail Road
right-of-way;

THENCE South 11° 37' 17" East, along the west line of said 100'

14 THENCE continuing along the west line of said 8.23 acres along said
15 curve to the left having a radius of 200.00 feet, a central angle of
16 68° 43' 28", a chord bearing and distance of N 02° 56' 25" W, 225.78
17 feet, an arc length of 239.90 feet to a to the point of tangent;
18 THENCE North 37° 08' 45" West, continuing along the west line of said
19 8.23 acres for a distance of 595.32 feet to the southeast corner and
20 PLACE of BEGINNING of the herein described tract;
21 THENCE in a northwesterly direction along the perimeter of the said
22 190.6 acre tract (Golf Course), the following calls;

8 SECTION 3. (a) The legal notice of the intention to
9 introduce this Act, setting forth the general substance of this
10 Act, has been published as provided by law, and the notice and a
11 copy of this Act have been furnished to all persons, agencies,
12 officials, or entities to which they are required to be furnished
13 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
14 Government Code.

15 (b) The governor, one of the required recipients, has
16 submitted the notice and Act to the Texas Commission on
17 Environmental Quality.

18 (c) The Texas Commission on Environmental Quality has filed
19 its recommendations relating to this Act with the governor, the
20 lieutenant governor, and the speaker of the house of
21 representatives within the required time.

22 (d) All requirements of the constitution and laws of this
23 state and the rules and procedures of the legislature with respect
24 to the notice, introduction, and passage of this Act are fulfilled
25 and accomplished.

26 SECTION 4. This Act takes effect immediately if it receives
27 a vote of two-thirds of all the members elected to each house, as

1 provided by Section 39, Article III, Texas Constitution. If this
2 Act does not receive the vote necessary for immediate effect, this
3 Act takes effect September 1, 2005.
