## A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of the West Ranch Management District;
3	providing authority to impose a tax and issue a bond or similar
4	obligation.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. WEST RANCH MANAGEMENT DISTRICT. Subtitle C,
7	Title 4, Special District Local Laws Code, is amended by adding
8	Chapter 3837 to read as follows:
9	CHAPTER 3837. WEST RANCH MANAGEMENT DISTRICT
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 3837.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the board of directors of the
13	district.
14	(2) "District" means the West Ranch Management
15	District.
16	Sec. 3837.002. WEST RANCH MANAGEMENT DISTRICT. The West
17	Ranch Management District is a special district created under
18	Section 59, Article XVI, Texas Constitution.
19	Sec. 3837.003. PURPOSE; DECLARATION OF INTENT. (a) The
20	creation of the district is essential to accomplish the purposes of
21	Sections 52 and 52-a, Article III, and Section 59, Article XVI,
22	Texas Constitution, and other public purposes stated in this
23	chapter. By creating the district and in authorizing the City of
24	Friendswood, Galveston and Harris Counties, and other political

- 1 subdivisions to contract with the district, the legislature has
- 2 established a program to accomplish the public purposes set out in
- 3 Section 52-a, Article III, Texas Constitution.
- 4 (b) The creation of the district is necessary to promote,
- 5 develop, encourage, and maintain employment, commerce,
- 6 transportation, housing, tourism, recreation, the arts,
- 7 entertainment, economic development, education, safety, and the
- 8 public welfare in the district.
- 9 <u>(c)</u> This chapter and the creation of the district may not be
- 10 interpreted to relieve Galveston and Harris Counties and the City
- of Friendswood from providing the level of services provided as of
- 12 the effective date of the Act enacting this chapter, to the area in
- 13 the district. The district is created to supplement and not to
- 14 supplant the county or city services provided in the area in the
- 15 district.
- 16 Sec. 3837.004. FINDINGS OF BENEFIT AND PUBLIC PURPOSE.
- 17 (a) The district is created to serve a public use and benefit.
- 18 (b) All land and other property included in the district
- 19 will benefit from the improvements and services to be provided by
- 20 the district under powers conferred by Sections 52 and 52-a,
- 21 Article III, and Section 59, Article XVI, Texas Constitution, and
- other powers granted under this chapter.
- (c) The creation of the district is in the public interest
- 24 and is essential to:
- 25 (1) further the public purposes of developing and
- 26 diversifying the economy of the state;
- 27 (2) eliminate unemployment and underemployment; and

1	(3) develop or expand transportation and commerce.
2	(d) The district will:
3	(1) promote the health, safety, education, and general
4	welfare of residents, employers, potential employees, employees,
5	visitors, and consumers in the district, and of the public;
6	(2) provide needed funding for the district to
7	preserve, maintain, and enhance the economic health and vitality of
8	the district territory as a community and business center; and
9	(3) promote the health, safety, welfare, education,
10	and enjoyment of the public by providing pedestrian ways and by
11	landscaping and developing certain areas in the district, which are
12	necessary for the restoration, preservation, and enhancement of
13	scenic beauty.
14	(e) Pedestrian ways along or across a street, whether at
15	grade or above or below the surface, and street lighting, street
16	landscaping, parking, and street art objects are parts of and
17	necessary components of a street and are considered to be a street
18	or road improvement.
19	(f) The district will not act as the agent or
20	instrumentality of any private interest even though the district
21	will benefit many private interests as well as the public.
22	Sec. 3837.005. DISTRICT TERRITORY. (a) The district is
23	composed of the territory described by Section 2 of the Act enacting
24	this chapter, as that territory may have been modified under:
25	(1) Subchapter J, Chapter 49, Water Code; or
26	(2) other law.
27	(b) The boundaries and field notes of the district contained

in Section 2 of the Act enacting this chapter form a closure. A 1 mistake in the field notes or in copying the field notes in the 2 3 legislative process does not in any way affect the district's: (1) organization, existence, or validity; 4 5 (2) right to issue any type of bond for a purpose for which the district is created or to pay the principal of and 6 7 interest on the bond; 8 (3) right to impose or collect an assessment or tax; or 9 (4) legality or operation. Sec. 3837.006. ELIGIBILITY FOR INCLUSION IN SPECIAL ZONES. 10 11 All or any part of the area of the district is eligible to be 12 included in: 13 (1) a tax increment reinvestment zone created by a municipality under Chapter 311, Tax Code; 14 15 (2) a tax abatement reinvestment zone created by a 16 municipality under Chapter 312, Tax Code; or 17 (3) an enterprise zone created by a municipality under 18 Chapter 2303, Government Code. Sec. 3837.007. APPLICABILITY OF MUNICIPAL MANAGEMENT 19 DISTRICTS LAW. Except as otherwise provided by this chapter, 20 Chapter 375, Local Government Code, applies to the district. 21 22 Sec. 3837.008. LIBERAL CONSTRUCTION OF CHAPTER. This chapter shall be liberally construed in conformity with the 23 findings and purposes stated in this chapter. 24

SUBCHAPTER B. BOARD OF DIRECTORS

Sec. 3837.051. GOVERNING BODY. The district is governed by

- 1 a board of five directors who serve staggered terms of four years,
- 2 with two or three directors' terms expiring June 1 of each
- 3 odd-numbered year.
- 4 Sec. 3837.052. APPOINTMENT OF DIRECTORS. (a) The
- 5 governing body of the City of Friendswood shall appoint the
- 6 directors of the board. The governing body shall appoint:
- 7 (1) three directors from a list of persons nominated
- 8 by the board; and
- 9 (2) two directors chosen by the governing body.
- 10 (b) If a person owns 25 percent or more of the land in the
- 11 district, the board shall request that the person provide to the
- 12 board a list of persons for the board to nominate under this
- 13 section. If the person does not provide a list of persons to the
- 14 board for that purpose before the 31st day after the date the board
- 15 requests the list or if no person owns 25 percent or more of the land
- in the district, the board is not required to obtain a list and may
- 17 nominate any eligible person for appointment to the board. If more
- 18 than one person owns 25 percent or more of the land included in the
- 19 district, only the person who owns the greatest amount of land
- 20 included in the district is entitled to have the board request a
- 21 list under this subsection.
- (c) If a person owns 25 percent or more of the land in the
- 23 district, at least a majority of the board must have been named from
- 24 a list provided by a person who owns 25 percent or more of the land.
- Sec. 3837.053. REMOVAL OF DIRECTORS CHOSEN BY CITY. The
- 26 City of Friendswood for any reason may remove a director appointed
- 27 under Section 3837.052(a)(2) and appoint a person to serve the

- 1 remainder of that director's term.
- Sec. 3837.054. VACANCY IN OFFICE OF DIRECTOR. (a) The
- 3 board may appoint a person to fill a vacancy in the office of a
- 4 director appointed under Section 3837.052(a)(1) for the remainder
- 5 of the director's term.
- 6 (b) The City of Friendswood may appoint a person to fill a
- 7 vacancy in the office of a director appointed under Section
- 8 3837.052(a)(2) for the remainder of the director's term.
- 9 Sec. 3837.055. QUORUM. For purposes of determining whether
- 10 a quorum of the board is present, the following are not counted:
- 11 (1) a board position vacant for any reason, including
- death, resignation, or disqualification; or
- 13 (2) a director who is abstaining from participation in
- 14 a vote because of a conflict of interest.
- 15 Sec. 3837.056. INITIAL DIRECTORS. (a) The initial board
- 16 consists of two directors appointed by the governing body of the
- 17 City of Friendswood to serve in positions 1 and 2 and the following
- 18 persons to serve in positions 3-5:

- 23 (b) Of the initial directors, the terms of the directors
- 24 appointed for positions 1 and 3 expire June 1, 2007, and the terms
- of the directors appointed for positions 2, 4, and 5 expire June 1,
- 26 2009.
- 27 (c) Section 3837.052 does not apply to this section.

(d) The governing body of the City of Friendswood may remove 1 2 a director the governing body appoints under this section and may 3 appoint a person to serve the remainder of the director's term. 4 (e) This section expires September 1, 2009. [Sections 3837.057-3837.100 reserved for expansion] 5 SUBCHAPTER C. POWERS AND DUTIES 6 7 Sec. 3837.101. EDUCATIONAL FACILITIES. (a) The district may acquire, construct, or finance an educational facility or a 8 site or appurtenance for an educational facility to benefit the 9 10 district. 11 (b) The district may convey the facility, site, or appurtenance to a school district that contains territory in the 12 13 West Ranch Management District. Sec. 3837.102. AGREEMENTS; GRANTS. (a) The district may 14 15 make an agreement with or accept a gift, grant, or loan from any 16 person. 17 (b) The implementation of a district project is a 18 governmental function or service for the purposes of Chapter 791, 19 Government Code. Sec. 3837.103. AUTHORITY TO CONTRACT FOR LAW ENFORCEMENT. 20 To protect the public interest, the district may contract with the 21 22 City of Friendswood for the city to provide law enforcement services in the district that exceed the services that would 23 otherwise be provided in the district by the city. 24 25 Sec. 3837.104. MEMBERSHIP IN CHARITABLE ORGANIZATIONS. The

(1) enjoys tax-exempt status under Section 501(c)(3),

district may join and pay dues to an organization that:

- (4), or (6), Internal Revenue Code of 1986; and 1 2 (2) performs a service or provides an activity 3 consistent with the furtherance of a district purpose. Sec. 3837.105. ECONOMIC DEVELOPMENT PROGRAMS. (a) The 4 district may establish and provide for the administration of one or 5 6 more programs to promote state or local economic development and to 7 stimulate business and commercial activity in the district, 8 including programs to: 9 (1) make loans and grants of public money; and 10 (2) provide district personnel and services.
- (b) For purposes of this section, the district has all of
  the powers of a municipality under Chapter 380, Local Government
  Code.
- Sec. 3837.106. NO EMINENT DOMAIN. The district may not exercise the power of eminent domain.
- [Sections 3837.107-3837.150 reserved for expansion]
  [Subchapter D. Financial provisions
- Sec. 3837.151. DISBURSEMENTS AND TRANSFERS OF MONEY. The
  board by resolution shall establish the number of directors'
  signatures and the procedure required for a disbursement or
  transfer of the district's money.
- Sec. 3837.152. PETITION REQUIRED FOR FINANCING SERVICES AND
  IMPROVEMENTS WITH ASSESSMENTS. (a) The board may not finance a
  service or improvement project with assessments under this chapter
  unless a written petition requesting that service or improvement
  has been filed with the board.
- 27 (b) A petition filed under Subsection (a) must be signed by

- 1 the owners of a majority of the assessed value of real property in
- 2 the district subject to assessment according to the most recent
- 3 certified tax appraisal rolls for Harris County and Galveston
- 4 County, as applicable.
- 5 Sec. 3837.153. AD VALOREM TAX. (a) If authorized at an
- 6 election held in accordance with Section 3837.157, the district may
- 7 impose an annual ad valorem tax on taxable property in the district
- 8 for any district purpose, including to:
- 9 (1) maintain and operate the district;
- 10 <u>(2)</u> construct or acquire improvements, sites, or
- 11 appurtenances; or
- 12 <u>(3)</u> provide a service.
- 13 (b) The board shall determine the tax rate.
- 14 Sec. 3837.154. UTILITY PROPERTY EXEMPT FROM IMPACT FEES AND
- 15 ASSESSMENTS. The district may not impose an impact fee or
- 16 assessment on the property, including the equipment,
- 17 rights-of-way, facilities, or improvements, of:
- 18 (1) an electric utility or a power generation company
- 19 as defined by Section 31.002, Utilities Code;
- 20 (2) a gas utility as defined by Section 101.003 or
- 21 <u>121.001</u>, <u>Utilities Code</u>;
- 22 <u>(3) a telecommunications provider as defined by</u>
- 23 Section 51.002, Utilities Code; or
- 24 (4) a person who provides to the public cable
- 25 television or advanced telecommunications services.
- Sec. 3837.155. BONDS AND OTHER OBLIGATIONS; APPROVAL BY
- 27 CITY OF FRIENDSWOOD. (a) The district may issue bonds or other

- 1 obligations payable wholly or partly from taxes, assessments,
- 2 impact fees, revenue, grants, or other money of the district, or any
- 3 combination of those sources of money, to pay for any authorized
- 4 purpose of the district.
- 5 (b) The district may issue a bond or other obligation in the
- 6 form of a bond, note, certificate of participation or other
- 7 instrument evidencing a proportionate interest in payments to be
- 8 made by the district, or other type of obligation.
- 9 (c) The district must obtain the approval of the City of
- 10 Friendswood for the issuance of bonds or other obligations for any
- improvement project.
- 12 Sec. 3837.156. TAXES FOR BONDS AND OTHER OBLIGATIONS. At
- the time bonds or other obligations payable wholly or partly from ad
- 14 valorem taxes are issued:
- 15 (1) the board shall impose a continuing direct annual
- 16 ad valorem tax, without limit as to rate or amount, for each year
- that all or part of the bonds are outstanding; and
- 18 (2) the district annually shall impose the continuing
- 19 direct ad valorem tax on all taxable property in the district in an
- 20 amount sufficient to:
- 21 (A) pay the interest on the bonds or other
- obligations as the interest becomes due;
- 23 (B) <u>create a sinking fund for the payment of the</u>
- 24 principal of the bonds or other obligations when due or the
- 25 redemption price at any earlier required redemption date; and
- 26 (C) pay the expenses of imposing the taxes.
- Sec. 3837.157. TAX AND BOND ELECTIONS. (a) The district

- 1 shall hold an election in the manner provided by Subchapter L,
- 2 Chapter 375, Local Government Code, to obtain voter approval before
- 3 the district imposes a maintenance tax or issues bonds payable from
- 4 ad valorem taxes.
- 5 (b) The board may include more than one purpose in a single
- 6 proposition at an election.
- 7 (c) Section 375.243, Local Government Code, does not apply
- 8 to the district.
- 9 Sec. 3837.158. CITIES NOT REQUIRED TO PAY DISTRICT
- 10 OBLIGATIONS. Except as provided by Section 375.263, Local
- 11 Government Code, a municipality is not required to pay a bond, note,
- 12 or other obligation of the district.
- Sec. 3837.159. COMPETITIVE BIDDING. (a) The competitive
- 14 bidding provisions of Subchapter I, Chapter 49, Water Code, apply
- 15 to the district for a contract to acquire or construct a water, a
- 16 wastewater, or a drainage or detention improvement. For all other
- 17 district contracts or projects, the competitive bidding
- 18 requirements that apply to a local government corporation created
- 19 under Chapter 431, Transportation Code, apply to the district.
- 20 (b) Subchapter K, Chapter 375, Local Government Code, does
- 21 not apply to the district.

- SUBCHAPTER E. DISSOLUTION
- 24 Sec. 3837.201. DISSOLUTION OF DISTRICT WITH OUTSTANDING
- 25 DEBT. (a) The board may dissolve the district regardless of
- 26 whether the district has debt. Section 375.264, Local Government
- 27 Code, does not apply to the district.

- 1 (b) If the district has debt when it is dissolved, the
- 2 district shall remain in existence solely for the purpose of
- 3 discharging its debts. The dissolution is effective when all debts
- 4 have been discharged.

- 7 SECTION 3. LEGISLATIVE FINDINGS. The legislature finds
- 8 that:
- 9 (1) proper and legal notice of the intention to
- 10 introduce this Act, setting forth the general substance of this
- 11 Act, has been published as provided by law, and the notice and a
- 12 copy of this Act have been furnished to all persons, agencies,
- officials, or entities to which they are required to be furnished by
- 14 the constitution and laws of this state, including the governor,
- 15 who has submitted the notice and Act to the Texas Commission on
- 16 Environmental Quality;
- 17 (2) the Texas Commission on Environmental Quality has
- 18 filed its recommendations relating to this Act with the governor,
- 19 lieutenant governor, and speaker of the house of representatives
- 20 within the required time;
- 21 (3) the general law relating to consent by political
- 22 subdivisions to the creation of districts with conservation,
- 23 reclamation, and road powers and the inclusion of land in those
- 24 districts has been complied with; and
- 25 (4) all requirements of the constitution and laws of
- 26 this state and the rules and procedures of the legislature with
- 27 respect to the notice, introduction, and passage of this Act have

- 1 been fulfilled and accomplished.
- 2 SECTION 4. EFFECTIVE DATE. This Act takes effect
- 3 immediately if it receives a vote of two-thirds of all the members
- 4 elected to each house, as provided by Section 39, Article III, Texas
- 5 Constitution. If this Act does not receive the vote necessary for
- 6 immediate effect, this Act takes effect September 1, 2005.
