## A BILL TO BE ENTITLED

1	AN ACT
2	relating to statewide evaluation of tech-prep consortia.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Section 61.853, Education Code, is amended by
5	adding Subsections (e), (f), and (g) to read as follows:
6	(e) An entity established after January 1, 2005, may not be
7	a tech-prep consortium for purposes of this subchapter unless the
8	entity is established or otherwise formed after that date as a
9	result of an action taken under Subsection (f)(1) or (2).
10	(f) In accordance with rules adopted by the board, if a
11	tech-prep consortium fails to meet standards established under
12	Section 61.858, that consortium:
13	(1) may be consolidated with an existing consortium to
14	serve the regions formerly served by both consortia; or
15	(2) may be abolished and a new consortium may be
16	established to serve the region formerly served by the abolished
17	consortium and to meet the goals of the abolished consortium's
18	tech-prep program.
19	(g) In adopting rules for purposes of Subsection (f), the
20	board shall specifically describe:
21	(1) the type of failure to meet standards that may
22	result in an action being taken under Subsection (f)(1) or (2),
23	including whether an action may result only from a severe or
24	repeated deviation from a standard or from the failure to meet one

- 1 or more particular standards; and
- 2 (2) which action authorized under Subsection (f) may
- 3 be taken for each type of failure to meet standards.
- 4 SECTION 2. Subchapter T, Chapter 61, Education Code, is
- 5 amended by adding Section 61.858 to read as follows:
- 6 Sec. 61.858. STATEWIDE EVALUATION. (a) In coordination
- 7 with tech-prep consortia, including the governing board of each
- 8 <u>tech-prep consortium</u>, the board shall develop and implement a
- 9 statewide system to evaluate each consortium based on the success
- 10 of the consortium's tech-prep program and other appropriate
- 11 <u>criteria</u>. The evaluation system must include standards that a
- 12 tech-prep consortium, including the consortium's governing board,
- is expected to meet in administering the consortium's duties under
- 14 this subchapter.
- 15 (b) Using the criteria developed under Subsection (a), the
- 16 board shall evaluate each tech-prep consortium biennially. Not
- 17 <u>later than October 1 of each even-numbered year, the board shall</u>
- 18 report to each tech-prep consortium the results of the evaluation.
- 19 The report must discuss any failure of the tech-prep consortium to
- 20 meet a standard established under Subsection (a) during the
- 21 reporting period, recognize the achievements of the consortium,
- 22 <u>including the consortium's meeting of standards during the</u>
- 23 reporting period, identify areas in which the consortium has made
- 24 improvement or should take steps to improve its performance, and
- 25 identify best practices of tech-prep consortia.
- 26 (c) Not later than October 1, 2006, the board shall issue
- 27 the initial reports required by this section. This subsection
