2	relating to the creation of the Flatrock Springs Municipal
3	Management District; granting authority for taxation and the
4	issuance of bonds.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle C, Title 4, Special District Local Laws
7	Code, is amended by adding Chapter 3818 to read as follows:
8	CHAPTER 3818. FLATROCK SPRINGS MUNICIPAL MANAGEMENT DISTRICT
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 3818.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the board of directors of the
12	district.
13	(2) "District" means the Flatrock Springs Municipal
14	Management District.
15	Sec. 3818.002. FLATROCK SPRINGS MUNICIPAL MANAGEMENT
16	DISTRICT. (a) The Flatrock Springs Municipal Management District
17	is created in Burnet County. The district is a political
18	subdivision of the state, a governmental agency, and a body politic
19	and corporate.

- 20 (b) The name of the district may be changed by resolution of
- 21 <u>the board.</u>
- 22 (c) The district is created under and is essential to
- 23 accomplish the purposes of Sections 52 and 52-a, Article III, and
- 24 Section 1-g, Article VIII, Texas Constitution, and other public

- 1 purposes stated in this chapter.
- 2 Sec. 3818.003. DISTRICT TERRITORY. (a) The district is
- 3 composed of the territory described by Section 2 of the Act creating
- 4 <u>this chapter.</u>
- 5 (b) The boundaries and field notes of the district contained
- 6 in Section 2 of the Act creating this chapter form a closure. A
- 7 <u>mistake made in the field notes or in copying the field notes in the</u>
- 8 <u>legislative process does not affect:</u>
- 9 <u>(1) the organization, existence, or validity of the</u>
- 10 district;
- 11 (2) the right of the district to levy and collect taxes
- 12 or issue bonds;
- 13 (3) the district's right to enter into any type of
- 14 contract for the purposes for which the district is created; or
- 15 (4) the legality or operation of the district or the
- 16 board.
- 17 Sec. 3818.004. LEGISLATIVE DECLARATIONS AND FINDINGS OF
- 18 PUBLIC BENEFIT. (a) The legislature finds that all of the land and
- 19 other property included within the boundaries of the district will
- 20 be benefited by the works, services, and projects that are to be
- 21 accomplished by the district under the powers conferred by Sections
- 22 <u>52 and 52-a, Article III, and Section 1-g, Article VIII, Texas</u>
- 23 Constitution, and other powers granted under this chapter.
- 24 (b) The creation of the district is essential to accomplish
- 25 the purposes of Sections 52 and 52-a, Article III, and Section 1-g,
- 26 Article VIII, Texas Constitution, and to accomplish the other
- 27 public uses, benefits, and purposes of this chapter.

- 1 (c) The legislature finds that the creation of the district:
- 2 (1) is essential to the conservation and beneficial
- 3 use of the water, land, soil, and other natural resources in or
- 4 adjacent to the district;
- 5 (2) is essential to further the public purposes of the
- 6 economic development and diversification of the state, the
- 7 elimination of unemployment and underemployment, and the
- 8 stimulation and development of transportation and commerce;
- 9 <u>(3) will promote the health, safety, and general</u>
- 10 welfare of residents, employers, employees, and consumers in the
- district and in Burnet County and of the public; and
- 12 (4) is in the public interest.
- 13 (d) The district's operations and the district's
- 14 improvement projects will enable the district to preserve,
- 15 maintain, and enhance the economic health and vitality of the area
- 16 <u>in the district as a community, residential, recreational,</u>
- 17 <u>business</u>, and commerce center. The district will further promote
- 18 the health, safety, welfare, education, convenience, and enjoyment
- 19 of the public by improving, landscaping, and developing certain
- 20 areas in and adjacent to the district and providing public services
- 21 and facilities in and adjacent to the district that are necessary
- 22 for the restoration, preservation, enhancement, and enjoyment of
- 23 scenic beauty.
- 24 Sec. 3818.005. CONSTRUCTION OF CHAPTER. This chapter shall
- 25 be liberally construed in conformity with the findings and purposes
- 26 stated in this chapter.
- Sec. 3818.006. APPLICABILITY OF OTHER LAW. This chapter

- 1 prevails over any provision of general law that is in conflict or
- 2 inconsistent with this chapter. Any general law which supplements
- 3 the power and authority of the district, to the extent not in
- 4 conflict or inconsistent with this chapter, is adopted and
- 5 incorporated herein by reference.
- 6 Sec. 3818.007. PROHIBITION AGAINST IMPAIRMENT OF DISTRICT.
- 7 (a) A municipality in whose extraterritorial jurisdiction the
- 8 district is located may not adopt an ordinance or resolution or take
- 9 any other action that:
- 10 (1) impairs the ability of the district to exercise
- 11 <u>its own powers under this chapter; or</u>
- 12 (2) limits the ability of the district to finance,
- 13 construct, operate, or provide the improvements and services
- 14 authorized in this chapter.
- 15 (b) The district and a municipality in whose
- 16 <u>extraterritorial jurisdiction the district is located may enter</u>
- into development agreements under Subchapter G, Chapter 212, Local
- 18 Government Code, concerning development of the property within the
- 19 district and annexation of all or a portion of the district by the
- 20 municipality.
- 21 [Sections 3818.008-3818.020 reserved for expansion]
- 22 SUBCHAPTER A-1. TEMPORARY PROVISIONS
- 23 Sec. 3818.021. TEMPORARY DIRECTORS. (a) The temporary
- 24 board consists of:
- 25 <u>(1) Sandy Jenkins;</u>
- 26 (2) Pat Dickey;
- 27 (3) Vi Cloud;

1	(4) Terry Turner; and
2	(5) Jack Cooley.
3	(b) If a temporary director fails to qualify for office, the
4	temporary directors who have qualified shall appoint a person to
5	fill the vacancy.
6	(c) Temporary directors serve until initial directors are
7	elected under Section 3818.022.
8	Sec. 3818.022. INITIAL DIRECTORS' ELECTION. In the manner
9	provided by Section 49.102, Water Code, the temporary board of
10	directors shall call and hold an election to elect five initial
11	directors.
12	Sec. 3818.023. INITIAL ELECTED DIRECTORS; TERMS. The
13	directors elected under Section 3818.022 shall draw lots to
14	determine which two shall serve until the first regularly scheduled
15	election of directors under Section 3818.052 and which three shall
16	serve until the second regularly scheduled election of directors.
17	Sec. 3818.024. EXPIRATION OF SUBCHAPTER. This subchapter
18	expires September 1, 2010.
19	[Sections 3818.025-3818.050 reserved for expansion]
20	SUBCHAPTER B. BOARD OF DIRECTORS
21	Sec. 3818.051. BOARD OF DIRECTORS. (a) The district is
22	governed by a board of five directors.
23	(b) Directors serve staggered four-year terms.
24	(c) Each director must qualify to serve as a director in the
25	manner provided by Sections 49.052, 49.055, and 54.025, Water Code,
26	as applicable.

(d) A director serves until the director's successor has

- 1 qualified.
- 2 (e) A vacancy in the office of director because of the
- death, resignation, or removal of the director shall be filled by
- 4 the remaining members of the board by appointing a qualified person
- 5 for the unexpired term.
- 6 Sec. 3818.052. ELECTION OF DIRECTORS. On the uniform
- 7 election date, established by the Election Code, in May of each
- 8 even-numbered year, the appropriate number of directors shall be
- 9 elected.
- 10 [Sections 3818.053-3818.100 reserved for expansion]
- SUBCHAPTER C. POWERS AND DUTIES
- Sec. 3818.101. GENERAL POWERS OF DISTRICT. (a) The
- 13 district has all of the rights, powers, privileges, authority, and
- 14 functions:
- 15 (1) of a district created under Chapter 375, Local
- 16 Government Code, except:
- 17 (A) the rights, powers, privileges, authority,
- 18 and functions unique to a conservation and reclamation district
- 19 created under Section 59, Article XVI, Texas Constitution; and
- 20 (B) as otherwise provide by this chapter;
- 21 (2) of a municipality or a county under Chapter 372,
- 22 Local Government Code;
- 23 (3) of a corporation under Section 4B, Development
- 24 Corporation Act of 1979 (Article 5190.6, Vernon's Texas Civil
- 25 Statutes); and
- 26 (4) provided by the general laws of the state
- 27 authorizing:

- 1 (A) programs and the making of loans and grants
- 2 of public money for economic development permitted under Section
- 3 52-a, Article III, Texas Constitution; and
- 4 (B) the development of property under Section
- 5 1-g, Article VIII, Texas Constitution.
- 6 (b) The powers incorporated by reference in Subsection (a)
- 7 include the power to issue bonds or other obligations and to levy,
- 8 <u>assess, and collect ad valorem taxes, assessments, and impact fees</u>
- 9 and apply the proceeds of the taxes, assessments, or fees to the
- 10 payment of debt, contract payments, or maintenance and operating
- 11 expenses, and the district may exercise such powers.
- 12 (c) Without limiting any of the powers referenced in this
- 13 chapter, the district has all powers necessary or required to
- 14 accomplish the purposes for which the district was created.
- 15 Sec. 3818.102. IMPROVEMENT PROJECTS. (a) The district may
- 16 provide, or it may enter into contracts with a governmental or
- 17 private entity to provide, improvement projects.
- 18 (b) A district improvement project may include the
- 19 following types of improvement projects or activities in support of
- 20 or incidental to those projects, whether individual, intermittent,
- 21 or continuing and whether located or conducted within or outside
- 22 the district, for the planning, design, construction, acquisition,
- lease, rental, lease-purchase, installment purchase, improvement,
- 24 provision of furnishings, equipment, rehabilitation, repair,
- 25 reconstruction, relocation, use, management, operation, or
- 26 maintenance of any works, improvements, or facilities or the
- 27 provision, support, enhancement, improvement, extension, or

- 1 expansion of services, whether provided to, for, by, or on behalf of
- 2 the district, for the accomplishment of the public purposes of the
- 3 district:
- 4 (1) landscaping; lighting, banners, and signs;
- 5 streets or sidewalks; hike and bike paths and trails, pedestrian
- 6 walkways, skywalks, crosswalks, or tunnels; highway right-of-way
- 7 or transit corridor beautification and improvements; fiber optic
- 8 cables and networks; parks, trails, lakes, gardens, recreational
- 9 facilities, open space, scenic areas, and related exhibits and
- 10 preserves; and any other public improvements, facilities, or
- 11 <u>services similar to the improvements, facilities, or services</u>
- 12 described by this subdivision;
- 13 (2) the removal, razing, demolition, or clearing of
- land or improvements in connection with an improvement project;
- 15 (3) the acquisition and improvement of land and other
- 16 property for the mitigation of the environmental effects of an
- improvement project;
- 18 (4) the acquisition of real or personal property or an
- 19 interest in real or personal property in connection with an
- 20 authorized improvement project; and
- 21 (5) any special or supplemental services for the
- 22 improvement and promotion of the district or adjacent areas or for
- 23 the protection of public health and safety within or adjacent to the
- 24 district, including health and sanitation, public safety,
- 25 security, development, advertising, promotion, elimination of
- 26 traffic congestion, and recreational improvements, enhancements,
- 27 and services.

- 1 (c) The district may undertake an improvement project
- 2 separately or jointly with another person and pay all or part of the
- 3 costs of an improvement project, including an improvement project
- 4 that:
- 5 (1) improves, enhances, or supports public safety and
- 6 security and law enforcement within and adjacent to the district;
- 7 (2) confers a general benefit on the entire district
- 8 and the areas adjacent to the district; or
- 9 (3) confers a special benefit on a definable part of
- 10 the district, which may be all or part of the district.
- (d) When applicable to a particular improvement project,
- 12 the district may enter into a contract with any private or
- 13 governmental entity to own, acquire, lease, lease-purchase,
- 14 construct, operate, or maintain, jointly or otherwise, an
- improvement project. The contract may provide:
- 16 (1) that any payments due under the contract are
- 17 payable from and are secured by a pledge of a specified part of the
- 18 revenues of one or more improvement projects;
- 19 <u>(2) for the levying of an ad valorem or maintenance tax</u>
- 20 to make payments due under the contract; or
- 21 (3) that the payments due under the contract be made
- 22 <u>from a combination of revenues from one or more improvement</u>
- 23 projects and taxes.
- Sec. 3818.103. PUBLIC SAFETY. (a) The district may not
- 25 employ peace officers, but may contract for off-duty peace officers
- 26 to provide public safety and security services in connection with a
- 27 special event, holiday, period with high traffic congestion, or

- 1 similar circumstance.
- 2 (b) The board by rule may regulate the private use of public
- 3 roadways, open spaces, parks, sidewalks, and similar public areas.
- 4 The rules may provide for the safe and orderly use of public
- 5 roadways, open spaces, parks, sidewalks, and similar public areas
- 6 or facilities.
- 7 Sec. 3818.104. EMPLOYEES; COMPENSATION. The board may
- 8 employ and establish the terms of employment and compensation of an
- 9 executive director, a general manager, and any other operating
- officer of the district the board considers necessary.
- 11 Sec. 3818.105. BORROWING MONEY. The district may borrow
- money for the corporate purposes of the district.
- 13 Sec. 3818.106. CONTRACTS; GRANTS; DONATIONS. (a) The
- 14 district may contract with any person to accomplish the purposes of
- 15 this chapter including contracting for the payment, repayment, or
- 16 reimbursement, out of tax proceeds or any other specified source of
- funds, of costs, including carrying costs, incurred by the person
- on behalf of the district, including all or part of the costs of an
- 19 improvement project.
- 20 (b) The district may apply for and contract with a person to
- 21 receive, administer, and perform the district's duties and
- 22 <u>obligations under any federal, state, local, or private gift,</u>
- 23 grant, loan, conveyance, transfer, bequest, donation, or other
- 24 financial assistance arrangement relating to the investigation,
- 25 planning, analysis, study, design, acquisition, construction,
- 26 improvement, completion, implementation, or operation by the
- 27 district or others of a proposed or existing improvement project.

- (c) The district may contract with the state or a state 1 2 agency, city, county, other political subdivision, corporation, or 3 other person to carry out the purposes of this chapter on such terms and conditions and for such period of time as the board may 4 determine. The state or a state agency, city, county, other 5 political subdivision, corporation, individual, or other entity 6 7 may contract with the district to carry out the purposes of this chapter without any further authorization, notwithstanding any 8 9 other law or charter provision to the contrary.
- Sec. 3818.107. RULES. The district may adopt and enforce

 rules for:
- 12 (1) the administration and operation of the district;
- 13 (2) the use, enjoyment, availability, protection,
- 14 security, and maintenance of the district's properties and
- 15 facilities; and
- 16 (3) the provision of public safety and security in the
- 17 <u>district.</u>
- Sec. 3818.108. FEES; CHARGES. The district may:
- 19 (1) establish and collect user fees, concession fees,
- 20 admission fees, rental charges, or other similar fees or charges;
- 21 and
- 22 (2) apply the proceeds from those fees or charges for
- 23 the enjoyment, sale, rental, or other use of the district's
- 24 <u>facilities</u>, services, properties, or improvement projects.
- Sec. 3818.109. PAYMENT OF EXPENSES. The district may
- 26 provide or secure the payment or repayment of the costs and expenses
- of the establishment, administration, and operation of the district

- 1 and the district's costs or share of the costs on any improvement
- 2 project, or the district's contractual obligation or indebtedness,
- 3 by or through:
- 4 (1) a lease, lease-purchase agreement, installment
- 5 purchase contract, or other agreement with any person;
- (2) a tax, assessment, user fee, concession fee, or
- 7 rental charge; or
- 8 (3) any other revenues or resources of the district.

- 10 SUBCHAPTER D. DISSOLUTION
- 11 Sec. 3818.151. DISSOLUTION OF DISTRICT. (a) The district
- may be dissolved as provided by Subchapter M, Chapter 375, Local
- 13 Government Code.
- 14 (b) If the district has debt and is dissolved, the district
- 15 shall remain in existence solely for the limited purpose of
- discharging its bonds or other obligations according to their terms.
