A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation, administration, powers, duties,
3	functions, operations, and financing of the Parker County Special
4	Utility District; granting the power of eminent domain.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle C, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 7202 to read as follows:
8	CHAPTER 7202. PARKER COUNTY SPECIAL UTILITY DISTRICT
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 7202.001. DEFINITION. In this chapter, "district"
11	means the Parker County Special Utility District.
12	Sec. 7202.002. NATURE OF DISTRICT. The district is a
13	special utility district in Parker County created under and
14	essential to accomplish the purposes of Section 59, Article XVI,
15	Texas Constitution.
16	Sec. 7202.003. CONFIRMATION ELECTION REQUIRED. If the
17	creation of the district is not confirmed at a confirmation and
18	initial directors' election held before September 1, 2007:
19	(1) the district is dissolved on September 1, 2007,
20	<pre>except that:</pre>
21	(A) any debts of the district incurred shall be
22	paid;
23	(B) any assets of the district that remain after
24	the payment of debts shall be transferred to Parker County; and

1	(C) the organization of the district shall be
2	maintained until all debts are paid and remaining assets are
3	transferred; and
4	(2) this chapter expires September 1, 2010.
5	Sec. 7202.004. APPLICABILITY OF OTHER SPECIAL UTILITY
6	DISTRICT LAW. Except as otherwise provided by this chapter,
7	Chapters 49 and 65, Water Code, apply to the district.
8	Sec. 7202.005. INITIAL DISTRICT TERRITORY. (a) The
9	district is initially composed of the territory described by
LO	Section 2 of the Act creating this chapter.
L1	(b) The boundaries and field notes contained in Section 2 of
L2	the Act creating this chapter form a closure. A mistake made in the
L3	field notes or in copying the field notes in the legislative process
L4	<pre>does not affect:</pre>
L5	(1) the organization, existence, or validity of the
L6	<pre>district;</pre>
L7	(2) the right of the district to issue any type of
L8	bond, including a refunding bond, for a purpose for which the
L9	district is created or to pay the principal of and interest on a
20	bond; or
21	(3) the legality or operation of the district or the
22	board of directors of the district.

24	SUBCHAPTER A-1. TEMPORARY PROVISIONS
25	Sec. 7202.021. TEMPORARY DIRECTORS. (a) The temporary
26	board of directors of the district is composed of:

1 (2) Bob Elder; 2 (3) James Estes; 3 (4) Bonnie Finch; 4 (5) Mike Hooten; 5 (6) Skip Queen; and (7) George Wootten. 6 7 (b) Each temporary director shall qualify for office as provided by Section 49.055, Water Code. 8 9 (c) If a temporary director fails to qualify for office, the 10 temporary directors who have qualified shall appoint a person to fill the vacancy. If at any time there are fewer than four 11 qualified temporary directors, the Texas Commission on 12 Environmental Quality shall appoint the necessary number of 13 directors to fill all vacancies on the board. 14 (d) Temporary directors serve until initial directors are 15 16 elected under Section 7202.022. 17 Sec. 7202.022. CONFIRMATION AND INITIAL DIRECTORS' 18 ELECTION. (a) The temporary directors shall hold an election to confirm the creation of the district and to elect seven initial 19 directors in accordance with Chapters 49 and 65, Water Code, on or 20 before September 1, 2007. 21 (b) The temporary board of directors shall determine the 22 method for determining the initial term of each person on the 23 initial board of directors. The terms must be clearly stated on the 24

- 4 Sec. 7202.023. TRANSFER OF ASSETS; DISSOLUTION. (a) If
- 5 the district's creation is confirmed under Section 7202.022, the
- 6 Parker County Water Supply Corporation shall transfer the assets,
- 7 debts, and contractual rights and obligations of the corporation to
- 8 the district.
- 9 (b) Not later than the 30th day after the date of the
- 10 transfer under Subsection (a), the board of directors of the Parker
- 11 <u>County Water Supply Corporation shall commence dissolution</u>
- 12 proceedings of the corporation.
- 13 (c) On dissolution of the Parker County Water Supply
- 14 Corporation, Certificate of Convenience and Necessity No. 12313 is
- 15 considered to be held by the district.
- 16 (d) The board of directors of the Parker County Water Supply
- 17 Corporation shall notify the Texas Commission on Environmental
- 18 Quality of the dissolution of the corporation and of the transfer of
- 19 Certificate of Convenience and Necessity No. 12313 to the district.
- (e) On receipt of notice under Subsection (d), the Texas
- 21 Commission on Environmental Quality shall note in its records that
- 22 <u>Certificate of Convenience and Necessity No. 12313 is held by the</u>
- 23 district and shall reissue the certificate in the name of the
- 24 <u>district without further application or notice.</u>
- 25 Sec. 7202.024. EXPIRATION OF SUBCHAPTER. This subchapter
- 26 expires September 1, 2010.

2	Sec. 7202.051. DIRECTORS: TERM OF OFFICE. (a) The
3	district is governed by a board of not fewer than five and not more
4	than 11 directors.
5	(b) A member of the board of directors of the district
6	serves a three-year term of office and may serve consecutive terms.

8	SUBCHAPTER C. POWERS AND DUTIES
9	Sec. 7202.101. GENERAL POWERS. The district has all of the
LO	rights, powers, privileges, authority, functions, and duties
L1	provided by the general law of this state, including Chapters 49 and
L2	65, Water Code, applicable to special utility districts created
L3	under Section 59, Article XVI, Texas Constitution.
L4	Sec. 7202.102. WATER SERVICE IMPACT FEE. (a) The district
L5	may charge a water service impact fee that is equal to the sum of the
L6	equity buy-in fee and the installation fee charged by the Parker
L7	County Water Supply Corporation on November 1, 2004, under that
L8	corporation's tariff.
L9	(b) Chapter 395, Local Government Code, does not apply to
20	the initial water service impact fee set under this section.
21	(c) The district may increase the water service impact fee
22	only as provided by Chapter 395, Local Government Code, or as
23	approved by the Texas Commission on Environmental Quality.
24	Sec. 7202.103. EMINENT DOMAIN. (a) Except as provided by
25	Subsection (b), the district has all the authority under Chapters
26	49 and 65, Water Code, of a special utility district to acquire by

- 17 SECTION 3. (a) The legal notice of the intention to
- 18 introduce this Act, setting forth the general substance of this
- 19 Act, has been published as provided by law, and the notice and a
- 20 copy of this Act have been furnished to all persons, agencies,
- 21 officials, or entities to which they are required to be furnished
- under Section 59, Article XVI, Texas Constitution, and Chapter 313,
- 23 Government Code.
- (b) The governor has submitted the notice and Act to the
- 25 Texas Commission on Environmental Quality.
- 26 (c) The Texas Commission on Environmental Quality has filed
- 27 its recommendations relating to this Act with the governor,

- 1 lieutenant governor, and speaker of the house of representatives
- 2 within the required time.
- 3 (d) All requirements of the constitution and laws of this
- 4 state and the rules and procedures of the legislature with respect
- 5 to the notice, introduction, and passage of this Act are fulfilled
- 6 and accomplished.
- 7 SECTION 4. This Act takes effect immediately if it receives
- 8 a vote of two-thirds of all the members elected to each house, as
- 9 provided by Section 39, Article III, Texas Constitution. If this
- 10 Act does not receive the vote necessary for immediate effect, this
- 11 Act takes effect September 1, 2005.
