5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle C, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 7205 to read as follows:
8	CHAPTER 7205. STEPHENS REGIONAL SPECIAL UTILITY DISTRICT
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 7205.001. DEFINITION. In this chapter, "district"
11	means the Stephens Regional Special Utility District.
12	Sec. 7205.002. NATURE OF DISTRICT. The district is a
13	special utility district in Stephens, Eastland, Palo Pinto,
14	Shackelford, and Throckmorton Counties created under and essential
15	to accomplish the purposes of Section 59, Article XVI, Texas
16	Constitution.
17	Sec. 7205.003. CONFIRMATION ELECTION REQUIRED. If the
18	creation of the district is not confirmed at a confirmation and
19	initial directors' election held before September 1, 2007:
20	(1) the district is dissolved on September 1, 2007,
21	<pre>except that:</pre>
22	(A) any debts of the district incurred shall be
23	<pre>paid;</pre>
24	(B) any assets of the district that remain after

- the payment of debts shall be transferred to Stephens, Eastland, 1 2 Palo Pinto, Shackelford, or Throckmorton County as appropriate; and 3 (C) the organization of the district shall be maintained until all debts are paid and remaining assets are 4 transferred; and 5 6 (2) this chapter expires September 1, 2010. 7 Sec. 7205.004. APPLICABILITY OF OTHER SPECIAL UTILITY DISTRICT LAW. Except as otherwise provided by this chapter, 8 9 Chapters 49 and 65, Water Code, apply to the district. Sec. 7205.005. INITIAL DISTRICT TERRITORY. 10 (a) The district is initially composed of the territory described by 11 12 Section 2 of the Act creating this chapter.
- 13 (b) The boundaries and field notes contained in Section 2 of
 14 the Act creating this chapter form a closure. A mistake made in the
 15 field notes or in copying the field notes in the legislative process
 16 does not affect:
- 17 (1) the organization, existence, or validity of the
 18 district;
- 19 (2) the right of the district to issue any type of
 20 bond, including a refunding bond, for a purpose for which the
 21 district is created or to pay the principal of and interest on a
 22 bond; or
- 23 (3) the legality or operation of the district or the board of directors of the district.

 SUBCHAPTER A-1. TEMPORARY PROVISIONS
- 27 Sec. 7205.021. TEMPORARY DIRECTORS. (a) The temporary

board of directors of the district is composed of: 1 2 (1) Gary Brockman; 3 (2) Roger Broyles; 4 (3) Kelley Grissom; 5 (4) Cotton Kinnard; (5) Donnie Lockhart; 6 7 (6) Monroe Pugh; and (7) Danny Stephens. 8 (b) Each temporary director shall qualify for office as 9 provided by Section 49.055, Water Code. 10 (c) If a temporary director fails to qualify for office, the 11 temporary directors who have qualified shall appoint a person to 12 fill the vacancy. If at any time there are fewer than four 13 qualified temporary directors, the Texas Commission 14 Environmental Quality shall appoint the necessary number of 15 16 directors to fill all vacancies on the board. 17 (d) Temporary directors serve until initial directors are 18 elected under Section 7205.022. Sec. 7205.022. CONFIRMATION 19 AND INITIAL DIRECTORS' ELECTION. (a) The temporary directors shall hold an election to 20 confirm the creation of the district and to elect seven initial 21 22 directors in accordance with Chapters 49 and 65, Water Code, on or before September 1, 2007. 23 (b) The temporary board of directors shall determine the 24 25 method for determining the initial term of each person on the

initial board of directors. The terms must be clearly stated on the

ballot for the confirmation and directors' election.

- 6 Sec. 7205.023. TRANSFER OF ASSETS; DISSOLUTION. (a) If
- 7 the district's creation is confirmed under Section 7205.022, the
- 8 <u>Stephens County Rural Water Supply Corporation shall transfer the</u>
- 9 assets, debts, and contractual rights and obligations of the
- 10 corporation to the district.
- 11 (b) Not later than the 30th day after the date of the
- 12 transfer under Subsection (a), the board of directors of the
- 13 Stephens County Rural Water Supply Corporation shall commence
- 14 dissolution proceedings of the corporation.
- 15 (c) On dissolution of the Stephens County Rural Water Supply
- 16 Corporation, Certificate of Convenience and Necessity No. 11456 is
- 17 considered to be held by the district.
- 18 (d) The board of directors of the Stephens County Rural
- 19 Water Supply Corporation shall notify the Texas Commission on
- 20 Environmental Quality of the dissolution of the corporation and of
- 21 the transfer of Certificate of Convenience and Necessity No. 11456
- 22 to the district.
- (e) On receipt of notice under Subsection (d), the Texas
- 24 Commission on Environmental Quality shall note in its records that
- 25 Certificate of Convenience and Necessity No. 11456 is held by the
- 26 district and shall reissue the certificate in the name of the
- 27 district without further application or notice.
