

AN ACT

relating to the creation of the Rockwall County Municipal Utility Districts Nos. 6, 7, 8, and 9; providing authority to impose a tax and issue bonds; granting the power of eminent domain.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle F, Title 6, Special District Local Laws Code, is amended by adding Chapter 8136 to read as follows:

CHAPTER 8136. ROCKWALL COUNTY MUNICIPAL UTILITY DISTRICTS

NOS. 6, 7, 8, and 9

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 8136.001. DEFINITIONS. In this chapter:

(1) "Board" or "boards" means, as appropriate, the board of directors of one or all of the districts.

(2) "Director" means a member of the board.

(3) "District" or "districts" means, as appropriate, one or all of the Rockwall County Municipal Utility Districts Nos. 6, 7, 8, and 9.

Sec. 8136.002. NATURE OF DISTRICT. Each district is a municipal utility district in Rockwall County created under and essential to accomplish the purposes of Section 52, Article III, and Section 59, Article XVI, Texas Constitution.

Sec. 8136.003. CONFIRMATION ELECTION REQUIRED. If the creation of a district is not confirmed at a confirmation election held under Section 8136.023 before September 1, 2007:

1 (1) the district is dissolved September 1, 2007,
2 except that:

3 (A) any debts incurred shall be paid;

4 (B) any assets that remain after the payment of
5 debts shall be transferred to Rockwall County; and

6 (C) the organization of the district shall be
7 maintained until all debts are paid and remaining assets are
8 transferred; and

9 (2) the provisions of this chapter relating to that
10 district expire September 1, 2010.

11 Sec. 8136.004. INITIAL DISTRICT TERRITORY. (a) Each
12 district is initially composed of the territory described by
13 Section 2 of the Act creating this chapter.

14 (b) The boundaries and field notes of each district, as
15 described in Section 2 of the Act creating this chapter, form a
16 closure. A mistake made in the field notes or in copying the field
17 notes in the legislative process does not affect:

18 (1) the organization, existence, or validity of the
19 district;

20 (2) the right of the district to impose taxes; or

21 (3) the legality or operation of the district or the
22 board.

23 Sec. 8136.005. APPLICABILITY OF OTHER LAW. Except as
24 otherwise provided by this chapter, Chapters 49 and 54, Water Code,
25 apply to the districts.

2 Sec. 8136.021. TEMPORARY DIRECTORS. (a) The temporary
3 board of each district consists of the following persons:

4 (1) Rockwall County Municipal Utility District No. 6:

1 (b) If a temporary director fails to qualify for office, the
2 remaining temporary directors of that district shall appoint a
3 person to fill the vacancy.

4 (c) Temporary directors serve until the earlier of:

5 (1) the date directors are elected under Section
6 8136.023; or

7 (2) the date the provisions of this chapter relating
8 to that district expire under Section 8136.003.

9 Sec. 8136.022. ORGANIZATIONAL MEETING OF TEMPORARY
10 DIRECTORS. As soon as practicable after all the temporary
11 directors of a district have qualified under Section 49.055, Water
12 Code, the temporary directors of that district shall meet at a
13 location in the district agreeable to a majority of the directors of
14 that district. If a location cannot be agreed upon, the meeting
15 shall be at the Rockwall County Courthouse. At the meeting, the
16 temporary directors shall elect officers from among the temporary
17 directors and conduct any other district business.

18 Sec. 8136.023. CONFIRMATION AND INITIAL DIRECTORS'
19 ELECTION. The temporary directors of each district shall hold an
20 election to confirm the creation of the district and to elect five
21 directors as provided by Section 49.102, Water Code.

22 Sec. 8136.024. INITIAL ELECTED DIRECTORS; TERMS. The
23 directors of each district elected under Section 8136.023 shall
24 draw lots to determine which two shall serve until the first
25 regularly scheduled election of directors under Section 8136.052
26 and which three shall serve until the second regularly scheduled
27 election of directors.

1 Sec. 8136.025. EXPIRATION OF SUBCHAPTER. This subchapter
2 expires September 1, 2010.

4 SUBCHAPTER B. BOARD OF DIRECTORS

5 Sec. 8136.051. DIRECTORS; TERMS. (a) Each district is
6 governed by a board of five directors.

7 (b) Directors serve staggered four-year terms.

8 Sec. 8136.052. ELECTION OF DIRECTORS. On the uniform
9 election date in May of each even-numbered year, the appropriate
10 number of directors of each district shall be elected.

12 SUBCHAPTER C. POWERS AND DUTIES

13 Sec. 8136.101. GENERAL POWERS. Each district has all of the
14 rights, powers, privileges, authority, functions, and duties
15 provided by the general law of this state, including Chapters 49 and
16 54, Water Code, applicable to municipal utility districts created
17 under Section 59, Article XVI, Texas Constitution.

18 Sec. 8136.102. ROAD PROJECTS. (a) To the extent
19 authorized by Section 52, Article III, Texas Constitution, each
20 district may construct, maintain, or operate paved roads or works,
21 facilities, or improvements in aid of those roads, inside the
22 district.

23 (b) A road project must meet or exceed all applicable
24 construction standards, zoning and subdivision requirements, and
25 regulatory ordinances of each municipality in whose corporate
26 limits or extraterritorial jurisdiction the district is located.
27 If the district is located outside the extraterritorial

1 jurisdiction of a municipality, a road project must meet all
2 applicable construction standards, zoning and subdivision
3 requirements, and regulatory ordinances of each county in which the
4 district is located.

5 (c) The district may not undertake a road project unless
6 each municipality in whose corporate limits or extraterritorial
7 jurisdiction the district is located consents by ordinance or
8 resolution. If the district is located outside the
9 extraterritorial jurisdiction of a municipality, the district may
10 not undertake a road project unless each county in which the
11 district is located consents by ordinance or resolution.

12 Sec. 8136.103. ADDING LAND BY PETITION OF LANDOWNER. Each
13 district may only add land to the district in the manner provided by
14 Section 49.301, Water Code, if a landowner petitions for the
15 addition of land that is:

- 16 (1) adjacent to the boundaries of the district; or
17 (2) separated from the district by public land or
18 right-of-way.

19 Sec. 8136.104. EMINENT DOMAIN. (a) Each district may
20 exercise the power of eminent domain within the boundaries of the
21 district for all public purposes.

22 (b) Each district may exercise the power of eminent domain
23 outside the boundaries of the district only for the purpose of
24 constructing, acquiring, operating, repairing, or maintaining
25 water supply lines or sanitary sewer lines.

26 (c) Each district shall exercise the power of eminent domain
27 in the same manner as required for a county.

2 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

3 Sec. 8136.151. TAX TO REPAY BONDS. Each district may impose
4 a tax to pay the principal of or interest on bonds issued to finance
5 projects under Section 8136.102.

6 [Sections 8136.152-8136.200 reserved for expansion]

7 SUBCHAPTER E. BONDS

8 Sec. 8136.201. AUTHORITY TO ISSUE BONDS AND OTHER
9 OBLIGATIONS. (a) Each district may issue bonds or other
10 obligations as provided by Chapters 49 and 54, Water Code, to
11 finance the construction, maintenance, or operation of projects
12 under Sections 8136.101 and 8136.102.

13 (b) A district may not issue bonds to finance projects
14 authorized by Section 8136.102 unless the issuance is approved by a
15 vote of a two-thirds majority of the voters of the district voting
16 at an election called for that purpose.

17 (c) Bonds or other obligations issued or incurred to finance
18 projects authorized by Section 8136.102 may not exceed one-fourth
19 of the assessed value of the real property in the district.

20 (d) Sections 49.181 and 49.182, Water Code, do not apply to
21 a project undertaken by a district under Section 8136.102 or to
22 bonds issued by the district to finance the project.

23 SECTION 2. Each district initially includes, respectively,
24 the territory contained in the following areas as indicated:

2 Texas, and being part of a tract of land described in a deed to Fate
3 Land, L.P., a Texas Limited Partnership, recorded in Volume 02919,
4 Page 00099 of the Deed Records of Rockwall County, Texas
5 (D.R.R.C.T.), and being all of a called 15.004 acre tract of land
6 described in a deed to Fate Land, L.P., recorded in Volume 02859,
7 Page 00029, D.R.R.C.T., and being more particularly described as
8 follows:

9 BEGINNING at a point in the east right-of way line of State Highway
10 No. 66 (60' right-of-way) for the southmost corner of 119.39 acre
11 tract of land described as Tract III in a deed to The Crown Hill

21 recorded in Volume 82, Page 85 of said Deed Records;

22 THENCE North 88 degrees 11 minutes 50 seconds East, along the south
23 line of said Gibbs tract and generally along a fence part-way, a
24 distance of 435.15 feet to a point for the southeast corner of said
25 Gibbs tract;

26 THENCE North 01 degree 48 minutes 10 seconds West, along the east
27 line of said Gibbs tract, a distance of 100.00 feet to a point for

1 the northeast corner thereof;

2 THENCE South 88 degrees 11 minutes 50 seconds West, along the north
3 line of said Gibbs tract and generally along a fence part-way, a
4 distance of 435.15 feet to a point in the east right-of-way line of
5 State Highway No. 66 for the northwest corner of said Gibbs tract;

6 THENCE North 01 degree 48 minutes 07 seconds West, along the east
7 right-of-way line of State Highway No. 66, a distance of 709.10 feet
8 to a point for the beginning of a tangent curve to the right, from
9 which a TxDOT concrete monument is located South 01 degree 48
10 minutes 07 seconds East, a distance of 1.41 feet;

11 THENCE Northeasterly, continuing along the east right-of-way line
12 of State Highway No. 66 and along the curve to the right which has a
13 chord that bears North 16 degrees 29 minutes 34 seconds East for
14 440.72 feet, a central angle of 36 degrees 35 minutes 22 seconds and
15 a radius of 702.00 feet, for an arc distance of 448.30 feet to a
16 point for the end of said curve, from which a TxDot concrete
17 monument is located South 03 degrees 50 minutes 05 seconds West, a
18 distance of 1.41 feet;

19 THENCE North 34 degrees 47 minutes 15 seconds East, continuing
20 along the easterly right-of-way line of State Highway No. 66, a
21 distance of 986.53 feet to a point for the beginning of a tangent
22 curve to the left, from which a TxDOT concrete monument is located
23 South 01 degree 40 minutes 43 seconds East, a distance of 1.69 feet;

24 THENCE Northeasterly, continuing along the easterly right-of-way
25 line of State Highway No. 66 and along the curve to the left which
26 has a chord that bears North 16 degrees 59 minutes 08 seconds East
27 for 486.72 feet, a central angle of 35 degrees 36 minutes 15 seconds

1 and a radius of 796.00 feet, for an arc distance of 494.64 feet to
2 the end of said curve;
3 THENCE North 00 degrees 49 minutes 00 seconds West, along the east
4 right-of-way line of State Highway No. 66, a distance of 1270.15
5 feet to a 1/2-inch iron rod found for the northwest corner of said
6 50.44 acre tract and the southwest corner of Luby Acres, an addition
7 to the Town of Fate according to the plat thereof recorded in
8 Cabinet B, Page 2 of the Map Records of Rockwall County, Texas;
9 THENCE North 88 degrees 12 minutes 44 seconds East, along the south
10 line of Luby Acres, a distance of 1739.21 feet to the southeast
11 corner of said Luby Acres;
12 THENCE North 01 degree 11 minutes 30 seconds West, along the west
13 line of said Fate Land tract, and the east line of said Luby Acres, a
14 distance of 750.20 feet to a 1/2-inch iron rod found for the
15 northeast corner of said Luby Acres;
16 THENCE North 01 degree 20 minutes 58 seconds West, continuing along
17 the west line of said Fate Land tract, a distance of 1327.26 feet to
18 a 1/2-inch iron rod found for the northwest corner thereof;
19 THENCE North 88 degrees 42 minutes 34 seconds East, along the north
20 line of said Fate Land tract, a distance of 2111.82 feet to a point
21 for the northeast corner of said Fate Land tract;
22 THENCE South 01 degree 20 minutes 57 seconds East, a distance of
23 2869.76 feet to a point in the northwest right-of-way of the Union
24 Pacific Railway (100' right-of-way);
25 THENCE South 46 degrees 07 minutes 06 seconds West, along the
26 northwest right-of-way line of the Union Pacific Railway, a
27 distance of 1290.89 feet to a point for corner;

1 THENCE North 89 degrees 57 minutes 29 seconds West, a distance of
2 1167.48 feet to a 5/8-inch iron rod found for corner, said rod being
3 the southeast corner of said 15.004 acre tract;

4 THENCE South 01 degree 11 minutes 30 seconds East, along the east
5 line of said 119.34 acre tract, a distance of 1101.83 feet to a
6 point in the northwest right-of-way line of the Union Pacific
7 Railway (100' right-of-way) for the southeast corner of said 119.34
8 acre tract;

9 THENCE South 46 degrees 07 minutes 06 seconds West, along the
10 northwest line of the Union Pacific Railway, a distance of 2669.57
11 feet to a 1/2-inch iron rod found for the southeast corner of said
12 City of Fate tract;

13 THENCE North 01 degree 44 minutes 40 seconds West, along the east
14 line of said City of Fate tract, a distance of 629.85 feet to a
15 1/2-inch iron rod found for the north corner of said City of Fate
16 tract;

17 THENCE South 35 degrees 52 minutes 53 seconds West, along the
18 northwest line of said City of Fate tract, a distance of 1037.55
19 feet to the POINT OF BEGINNING and containing 15,533,075 square
20 feet, or 356.590 acres of land, more or less.

26 iron rod found for the southeast corner of said Propane tract;

27 THENCE North 00 degree 57 minutes 34 second West, along the

2 5/8-inch iron rod found for the northeast corner of said Propane
3 tract at a point on the southeasterly line of said Interstate 30;
4 THENCE North 43 degrees 59 minutes 58 seconds East, along the
5 southeasterly line of said Interstate 30, a distance of 353.64 feet
6 to a TxDot concrete monument found for corner;
7 THENCE South 88 degrees 14 minutes 04 seconds East, along a cut-back
8 line in said Interstate Highway No. 30 right-of-way, a distance of
9 75.37 feet to a 5/8-inch iron rod with cap marked "PETITT-RPLS 4087"
10 found for corner;
11 THENCE North 41 degrees 40 minutes 56 seconds East, continuing
12 along said cut-back, a distance of 25.20 feet to a 1/2-inch iron rod
13 found in the center of Blackland Road, (undedicated public road);
14 THENCE South 53 degrees 28 minutes 01 second East, generally along
15 the center of Blackland Road, a distance of 904.64 feet to a
16 1/2-inch iron rod found for the north corner of a tract of land as
17 described to Macedonia Baptist Church, called 1.04 acres, recorded

20 line of said church tract, a distance of 317.23 feet to a 5/8-inch
21 iron rod with cap marked PETITT-RPLS 4087" found for the south

23 THENCE North 67 degrees 25 minutes 06 seconds East, along the
24 south line of said church tract, a distance of 306.42 feet to a
25 5/8-inch iron rod found in the center of said Black land Road for
26 the east corner of said church tract;
27 THENCE South 52 degrees 54 minutes 18 seconds East, along the

1 northeasterly boundary of said 64.07 acre tract and along generally
2 along the center of Blackland Road, a distance of 669.01 feet to a
3 5/8-inch iron rod with cap marked "PETITT-RPLS 4087" found for an
4 angle point, from which a 5/8-inch iron rod found is located South

17 1,421.23 feet to a 5/8-inch iron rod with cap marked "PETITT-RPLS
18 4087" found in the east line of a called 10.00 acre tract of land
19 described in a deed to Curtis M. Brunson and wife Nelda Brunson
20 recorded in Volume 138, Page 797 of said Deed Records;
21 THENCE North 01 degree 25 minutes 24 seconds West, along the east
22 line of said Brunson tract, a distance of 2,037.61 feet to a
23 5/8-inch iron rod with cap marked "PETITT-RPLS 4087" found in the
24 general center of a ditch for corner;
25 THENCE South 54 degrees 02 minutes 46 seconds West, generally along
26 the center of said ditch and along the north line of said Brunson
27 tract and the north line of a called 4.788 acre tract of land

1 described in a deed to Curtis M. Brunson recorded in Volume 130,
2 page 710 of said Deed Records, a distance of 461.00 feet to an angle
3 point;

4 THENCE South 30 degrees 55 minutes 20 seconds West, continuing
5 generally along the center of said ditch and along the westerly
6 north line of said 4.788 acre tract, the north line of a called
7 5.3801 acre tract described in a deed to Todd Winters recorded in
8 Volume 1571, Page 301 of said Deed Records, the north line of a
9 called 5.02 acre tract described in a deed to David W. Wright and
10 wife Linda Wright recorded in Volume 85, Page 144 of said Deed
11 Records, and the north line of a called 4.02 acre tract described in
12 a deed to David W. Wright and wife Linda Wright recorded in Volume
13 91, Page 442 of said Deed Records, a distance of 1,803.25 feet to a
14 1/2-inch iron rod found for corner;

15 THENCE South 00 degrees 25 minutes 35 seconds East, along the west

13 Act does not receive the vote necessary for immediate effect, this
14 Act takes effect September 1, 2005.
