5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 8136 to read as follows:
8	CHAPTER 8136. ROCKWALL COUNTY MUNICIPAL UTILITY DISTRICTS
9	NOS. 6, 7, 8, and 9
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 8136.001. DEFINITIONS. In this chapter:
12	(1) "Board" or "boards" means, as appropriate, the
13	board of directors of one or all of the districts.
14	(2) "Director" means a member of the board.
15	(3) "District" or "districts" means, as appropriate,
16	one or all of the Rockwall County Municipal Utility Districts Nos.
17	6, 7, 8, and 9.
18	Sec. 8136.002. NATURE OF DISTRICT. Each district is a
19	municipal utility district in Rockwall County created under and
20	essential to accomplish the purposes of Section 52, Article III,
21	and Section 59, Article XVI, Texas Constitution.
22	Sec. 8136.003. CONFIRMATION ELECTION REQUIRED. If the
23	creation of a district is not confirmed at a confirmation election
24	held under Section 8136.023 before September 1, 2007:

1	(1) the district is dissolved September 1, 2007,
2	<pre>except that:</pre>
3	(A) any debts incurred shall be paid;
4	(B) any assets that remain after the payment of
5	debts shall be transferred to Rockwall County; and
6	(C) the organization of the district shall be
7	maintained until all debts are paid and remaining assets are
8	transferred; and
9	(2) the provisions of this chapter relating to that
10	district expire September 1, 2010.
11	Sec. 8136.004. INITIAL DISTRICT TERRITORY. (a) Each
12	district is initially composed of the territory described by
13	Section 2 of the Act creating this chapter.
14	(b) The boundaries and field notes of each district, as
15	described in Section 2 of the Act creating this chapter, form a
16	closure. A mistake made in the field notes or in copying the field
17	notes in the legislative process does not affect:
18	(1) the organization, existence, or validity of the
19	<pre>district;</pre>
20	(2) the right of the district to impose taxes; or
21	(3) the legality or operation of the district or the
22	board.
23	Sec. 8136.005. APPLICABILITY OF OTHER LAW. Except as
24	otherwise provided by this chapter, Chapters 49 and 54, Water Code,
25	apply to the districts.

- 9 Sec. 8136.022. ORGANIZATIONAL MEETING OF TEMPORARY
- 10 DIRECTORS. As soon as practicable after all the temporary
- directors of a district have qualified under Section 49.055, Water
- 12 Code, the temporary directors of that district shall meet at a
- 13 location in the district agreeable to a majority of the directors of
- 14 that district. If a location cannot be agreed upon, the meeting
- shall be at the Rockwall County Courthouse. At the meeting, the
- 16 temporary directors shall elect officers from among the temporary
- 17 directors and conduct any other district business.
- 18 Sec. 8136.023. CONFIRMATION AND INITIAL DIRECTORS'
- 19 ELECTION. The temporary directors of each district shall hold an
- 20 election to confirm the creation of the district and to elect five
- 21 <u>directors as provided by Section 49.102, Water Code.</u>
- Sec. 8136.024. INITIAL ELECTED DIRECTORS; TERMS. The
- 23 directors of each district elected under Section 8136.023 shall
- 24 draw lots to determine which two shall serve until the first
- 25 regularly scheduled election of directors under Section 8136.052
- 26 and which three shall serve until the second regularly scheduled
- 27 election of directors.

L8	Sec. 8136.102. ROAD PROJECTS. To the extent authorized by

21	or improvements in aid of those roads, inside or outside the
22	<u>district.</u>
23	Sec. 8136.103. ADDING LAND BY PETITION OF LANDOWNER. Each
24	district may only add land to the district in the manner provided by
25	Section 49.301, Water Code, if a landowner petitions for the
26	addition of land that is:

4	exercise the power of eminent domain within the boundaries of the
5	district for all public purposes.

7	outside the boundaries of the district only for the purpose of
8	constructing, acquiring, operating, repairing, or maintaining
9	water supply lines or sanitary sewer lines.
10	(c) Each district shall exercise the power of eminent domain
11	in the same manner as required for a county.

24	(b) A district may not issue bonds to finance projects
25	authorized by Section 8136.102 unless the issuance is approved by a
26	vote of a two-thirds majority of the voters of the district voting
27	at an election called for that purpose.

- 2 projects authorized by Section 8136.102 may not exceed one-fourth
- of the assessed value of the real property in the district.
