- 3 (a) The district may issue bonds or other obligations as provided
- 4 by Chapters 49 and 54, Water Code, to finance the construction,
- 5 maintenance, or operation of projects under Section 8130.051.
- 6 (b) The district may not issue bonds or other obligations
- 7 secured in whole or in part by ad valorem taxation to finance
- 8 projects authorized by Section 8130.051 unless the issuance is
