A BILL TO BE ENTITLED

1	AN ACT
2	relating to the creation of the Galveston County Municipal Utility
3	District No. 67; providing authority to impose a tax and issue
4	bonds; granting the power of eminent domain.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle F, Title 6, Special District Local Laws
7	Code, is amended by adding Chapter 8151 to read as follows:
8	CHAPTER 8151. GALVESTON COUNTY MUNICIPAL UTILITY DISTRICT
9	<u>NO. 67</u>
10	SUBCHAPTER A. GENERAL PROVISIONS
11	Sec. 8151.001. DEFINITIONS. In this chapter:
12	(1) "Board" means the board of directors of the
13	district.
14	(2) "Director" means a member of the board.
15	(3) "District" means the Galveston County Municipal
16	Utility District No. 67.
17	Sec. 8151.002. NATURE OF DISTRICT. The district is a
18	municipal utility district in Galveston County created under and
19	essential to accomplish the purposes of Section 52, Article III,
20	and Section 59, Article XVI, Texas Constitution.
21	Sec. 8151.003. CONFIRMATION ELECTION REQUIRED. If the
22	creation of the district is not confirmed at a confirmation
23	election held under Section 8151.023 before September 1, 2007:
24	(1) the district is dissolved September 1, 2007,

1	<pre>except that:</pre>
2	(A) any debts incurred shall be paid;
3	(B) any assets that remain after the payment of
4	debts shall be transferred to Galveston County; and
5	(C) the organization of the district shall be
6	maintained until all debts are paid and remaining assets are
7	transferred; and
8	(2) this chapter expires September 1, 2010.
9	Sec. 8151.004. INITIAL DISTRICT TERRITORY. (a) The
10	district is initially composed of the territory described by
11	Section 2 of the Act creating this chapter.
12	(b) The boundaries and field notes contained in Section 2 of
13	the Act creating this chapter form a closure. A mistake made in the
14	field notes or in copying the field notes in the legislative process
15	does not affect:
16	(1) the organization, existence, or validity of the
17	district;
18	(2) the right of the district to impose taxes;
19	(3) the validity of the district's bonds, notes, or
20	indebtedness; or
21	(4) the legality or operation of the district or the
22	board.

24	SUBCHAPTER A1. TEMPORARY PROVISIONS
25	Sec. 8151.021. TEMPORARY DIRECTORS. (a) On or after
26	September 1, 2005, a person who owns land inside the boundaries of
27	the proposed district may petition the Texas Commission on

- 1 Environmental Quality to appoint as temporary directors the five
- 2 persons listed in the petition.
- 3 (b) The commission shall appoint as temporary directors the
- 4 persons listed in a petition received by the commission under
- 5 Subsection (a).
- 6 (c) If a temporary director fails to qualify for office, the
- 7 commission shall appoint a person to fill the vacancy.
- 8 <u>(d) Temporary directors serve until the earlier of:</u>
- 9 (1) the date directors are elected under Section
- 10 8151.023; or
- 11 (2) the date this chapter expires under Section
- 12 8151.003.
- 13 Sec. 8151.022. ORGANIZATIONAL MEETING OF TEMPORARY
- 14 DIRECTORS. As soon as practicable after all the temporary
- 15 directors have qualified under Section 49.055, Water Code, the
- 16 temporary directors shall meet at a location in the district
- 17 agreeable to a majority of the directors. If a location cannot be
- 18 agreed upon, the meeting shall be at the Galveston County
- 19 Courthouse. At the meeting, the temporary directors shall elect
- 20 officers from among the temporary directors and conduct any other
- 21 district business.
- 22 Sec. 8151.023. CONFIRMATION AND INITIAL DIRECTORS'
- 23 ELECTION. The temporary directors shall hold an election to
- 24 confirm the creation of the district and to elect five directors as
- 25 provided by Section 49.102, Water Code.
- 26 Sec. 8151.024. INITIAL ELECTED DIRECTORS; TERMS. The
- 27 directors elected under Section 8151.023 shall draw lots to

- determine which two shall serve terms expiring June 1 following the
- 2 first regularly scheduled election of directors under Section
- 3 8151.052 and which three shall serve until June 1 following the
- 4 second regularly scheduled election of directors.
- 5 Sec. 8151.025. EXPIRATION OF SUBCHAPTER. This subchapter
- 6 expires September 1, 2010.
- 7 [Sections 8151.026-8151.050 reserved for expansion]
- 8 SUBCHAPTER B. BOARD OF DIRECTORS
- 9 Sec. 8151.051. DIRECTORS; TERMS. (a) The district is
- 10 governed by a board of five directors.
- 11 (b) Directors serve staggered four-year terms that expire
- June 1 of even-numbered years.
- 13 Sec. 8151.052. ELECTION OF DIRECTORS. On the uniform
- 14 election date in May of each even-numbered year, the appropriate
- 15 number of directors shall be elected.
- [Sections 8151.053-8151.100 reserved for expansion]
- SUBCHAPTER C. POWERS AND DUTIES
- 18 Sec. 8151.101. MUNICIPAL UTILITY DISTRICT POWERS AND
- 19 DUTIES. The district has the powers and duties provided by the
- general law of this state, including Chapters 49 and 54, Water Code,
- 21 applicable to municipal utility districts created under Section 59,
- 22 Article XVI, Texas Constitution.
- Sec. 8151.102. ROAD PROJECTS. The district may construct,
- 24 acquire, improve, maintain, or operate macadamized, graveled, or
- 25 paved roads or turnpikes, or improvements in aid of those roads or
- 26 turnpikes, inside or outside the district.
- Sec. 8151.103. COMPLIANCE WITH MUNICIPAL CONSENT

- ORDINANCES OR RESOLUTIONS. Subject to the limitations of Section

 54.016, Water Code, the district shall comply with all applicable

 requirements of any ordinance or resolution adopted by the city

 council of the City of Texas City, including an ordinance or

 resolution adopted before September 1, 2005, that consents to the

 creation of the district or to the inclusion of lands within the

 district.
- 8 <u>Sec. 8151.104. DIVISION OF DISTRICT. The district may</u>
 9 <u>divide into two or more districts in the manner provided by Section</u>
 10 53.029, Water Code, if the district:
- 11 (1) has no outstanding bonded debt; and
- 12 (2) is not imposing an ad valorem tax.

- 14 <u>SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS</u>

- 19 SUBCHAPTER E. BONDS
- Sec. 8151.201. AUTHORITY TO ISSUE BONDS AND OTHER
- 21 OBLIGATIONS. (a) The district may issue bonds or other
- obligations as provided by Chapters 49 and 54, Water Code, to
- 23 <u>finance the construction, maintenance, or operation of projects</u>
- 24 under Sections 8151.101 and 8151.102.
- 25 (b) The district may not issue bonds under Subsection (a)
- 26 unless the issuance is approved by a vote of a two-thirds majority
- 27 of the voters of the district voting at an election called for that

- 1 purpose.
- 2 (c) Bonds or other obligations issued or incurred to finance
- 3 projects authorized by Section 8151.102 may not exceed one-fourth
- 4 of the assessed value of the real property in the district.
- 5 (d) Sections 49.181 and 49.182, Water Code, do not apply to
- 6 a project undertaken by the district under Section 8151.102 or to
- 7 bonds issued by the district to finance the project.
