A BILL TO BE ENTITLED

AN ACT

relating to the creation of the Galveston County Municipal Utility District No. 67; providing authority to impose a tax and issue bonds; granting the power of eminent domain.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

SECTION 1. Subtitle F, Title 6, Special District Local Laws Code, is amended by adding Chapter 8151 to read as follows:

CHAPTER 8151. GALVESTON COUNTY MUNICIPAL UTILITY DISTRICT

NO. 67

SUBCHAPTER A. GENERAL PROVISIONS

Sec. 8151.001. DEFINITIONS. In this chapter:

(1) "Board" means the board of directors of the district.

(2) "Director" means a member of the board.

(3) "District" means the Galveston County Municipal Utility District No. 67.

Sec. 8151.002. NATURE OF DISTRICT. The district is a municipal utility district in Galveston County created under and essential to accomplish the purposes of Section 52, Article III, and Section 59, Article XVI, Texas Constitution.

Sec. 8151.003. CONFIRMATION ELECTION REQUIRED. If the creation of the district is not confirmed at a confirmation election held under Section 8151.023 before September 1, 2007:

(1) the district is dissolved September 1, 2007,

1 except that:

2 (A) any debts incurred shall be paid;

3 (B) any assets that remain after the payment of
4 debts shall be transferred to Galveston County; and

5 (C) the organization of the district shall be
6 maintained until all debts are paid and remaining assets are
7 transferred; and

8 (2) this chapter expires September 1, 2010.

9 Sec. 8151.004. INITIAL DISTRICT TERRITORY. (a) The
10 district is initially composed of the territory described by
11 Section 2 of the Act creating this chapter.

12 (b) The boundaries and field notes contained in Section 2 of
13 the Act creating this chapter form a closure. A mistake made in the
14 field notes or in copying the field notes in the legislative process
15 does not affect:

16 (1) the organization, existence, or validity of the
17 district;

18 (2) the right of the district to impose taxes;

19 (3) the validity of the district's bonds, notes, or
20 indebtedness; or

21 (4) the legality or operation of the district or the
22 board.

24 SUBCHAPTER A1. TEMPORARY PROVISIONS

25 Sec. 8151.021. TEMPORARY DIRECTORS. (a) On or after
26 September 1, 2005, a person who owns land inside the boundaries of
27 the proposed district may petition the Texas Commission on

1 Environmental Quality to appoint as temporary directors the five
2 persons listed in the petition.

3 (b) The commission shall appoint as temporary directors the
4 persons listed in a petition received by the commission under
5 Subsection (a).

6 (c) If a temporary director fails to qualify for office, the
7 commission shall appoint a person to fill the vacancy.

8 (d) Temporary directors serve until the earlier of:

9 (1) the date directors are elected under Section
10 8151.023; or

11 (2) the date this chapter expires under Section
12 8151.003.

13 Sec. 8151.022. ORGANIZATIONAL MEETING OF TEMPORARY
14 DIRECTORS. As soon as practicable after all the temporary
15 directors have qualified under Section 49.055, Water Code, the
16 temporary directors shall meet at a location in the district
17 agreeable to a majority of the directors. If a location cannot be
18 agreed upon, the meeting shall be at the Galveston County
19 Courthouse. At the meeting, the temporary directors shall elect
20 officers from among the temporary directors and conduct any other
21 district business.

22 Sec. 8151.023. CONFIRMATION AND INITIAL DIRECTORS'
23 ELECTION. The temporary directors shall hold an election to
24 confirm the creation of the district and to elect five directors as
25 provided by Section 49.102, Water Code.

26 Sec. 8151.024. INITIAL ELECTED DIRECTORS; TERMS. The
27 directors elected under Section 8151.023 shall draw lots to

1 determine which two shall serve terms expiring June 1 following the
2 first regularly scheduled election of directors under Section
3 8151.052 and which three shall serve until June 1 following the
4 second regularly scheduled election of directors.

5 Sec. 8151.025. EXPIRATION OF SUBCHAPTER. This subchapter
6 expires September 1, 2010.

7 [Sections 8151.026-8151.050 reserved for expansion]

8 SUBCHAPTER B. BOARD OF DIRECTORS

9 Sec. 8151.051. DIRECTORS; TERMS. (a) The district is
10 governed by a board of five directors.

11 (b) Directors serve staggered four-year terms that expire
12 June 1 of even-numbered years.

13 Sec. 8151.052. ELECTION OF DIRECTORS. On the uniform
14 election date in May of each even-numbered year, the appropriate
15 number of directors shall be elected.

16 [Sections 8151.053-8151.100 reserved for expansion]

17 SUBCHAPTER C. POWERS AND DUTIES

18 Sec. 8151.101. MUNICIPAL UTILITY DISTRICT POWERS AND
19 DUTIES. The district has the powers and duties provided by the
20 general law of this state, including Chapters 49 and 54, Water Code,
21 applicable to municipal utility districts created under Section 59,
22 Article XVI, Texas Constitution.

23 Sec. 8151.102. ROAD PROJECTS. (a) To the extent authorized
24 by Section 52, Article III, Texas Constitution, the district may
25 construct, acquire, improve, maintain, or operate macadamized,
26 graveled, or paved roads or turnpikes, or improvements in aid of
27 those roads or turnpikes, inside the district.

1 (b) A road project must meet all applicable construction
2 standards, zoning and subdivision requirements, and regulatory
3 ordinances of the municipality or county in whose jurisdiction the
4 district is located.

5 (c) The district may not undertake a road project unless
6 each municipality or county in whose jurisdiction the district is
7 located consents by ordinance or resolution.

8 Sec. 8151.103. LIMITATION ON USE OF EMINENT DOMAIN. The
9 district may exercise the power of eminent domain outside the
10 district only to acquire an easement necessary for a pipeline that
11 serves the district.

12 Sec. 8151.104. COMPLIANCE WITH MUNICIPAL CONSENT
13 ORDINANCES OR RESOLUTIONS. Subject to the limitations of Section
14 54.016, Water Code, the district shall comply with all applicable
15 requirements of any ordinance or resolution adopted by the city
16 council of the City of Texas City, including an ordinance or
17 resolution adopted before September 1, 2005, that consents to the
18 creation of the district or to the inclusion of lands within the
19 district.

20 Sec. 8151.105. DIVISION OF DISTRICT. The district may
21 divide into two or more districts in the manner provided by Section
22 53.029, Water Code, if the district:

23 (1) has no outstanding bonded debt; and

24 (2) is not imposing an ad valorem tax.

26 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

27 Sec. 8151.151. TAX TO REPAY BONDS. The district may impose

1 a tax to pay the principal of or interest on bonds issued under
2 Section 8151.201.

3 Sec. 8151.152. UTILITY PROPERTY EXEMPT FROM IMPACT FEES AND
4 ASSESSMENTS. The district may not impose an impact fee or
5 assessment on the property, including the equipment,
6 rights-of-way, facilities, or improvements, of:

7 (1) an electric utility or a power generation company
8 as defined by Section 31.002, Utilities Code;

9 (2) a gas utility as defined by Section 101.003 or
10 121.001, Utilities Code;

11 (3) a telecommunications provider as defined by
12 Section 51.002, Utilities Code; or

13 (4) a person who provides to the public cable
14 television or advanced telecommunications services.

16 SUBCHAPTER E. BONDS

17 Sec. 8151.201. AUTHORITY TO ISSUE BONDS AND OTHER
18 OBLIGATIONS. (a) The district may issue bonds or other obligations
19 as provided by Chapters 49 and 54, Water Code, to finance the
20 construction, maintenance, or operation of projects under Sections
21 8151.101 and 8151.102.

22 (b) The district may not issue bonds under Subsection (a)
23 unless the issuance is approved by a vote of a two-thirds majority
24 of the voters of the district voting at an election called for that
25 purpose.

26 (c) Bonds or other obligations issued or incurred to finance
27 projects authorized by Section 8151.102 may not exceed one-fourth

1 of the assessed value of the real property in the district.

2 (d) Sections 49.181 and 49.182, Water Code, do not apply to
3 a project undertaken by the district under Section 8151.102 or to
4 bonds issued by the district to finance the project.

5 SECTION 2. The Galveston County Municipal Utility District
6 No. 67 initially includes all the territory contained in the
7 following area:

24 THENCE N14° 17'00" E, along the West line of Lot 1, a distance of
25 630.00 feet to the place of beginning and containing 19.9874 acres,
26 more or less.

27 (Part of Block 83/19.9874 Acres)

1 SECTION 3. (a) The legal notice of the intention to
2 introduce this Act, setting forth the general substance of this
3 Act, has been published as provided by law, and the notice and a
4 copy of this Act have been furnished to all persons, agencies,
5 officials, or entities to which they are required to be furnished
6 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
7 Government Code.

8 (b) The governor, one of the required recipients, has
9 submitted the notice and Act to the Texas Commission on
10 Environmental Quality.

11 (c) The Texas Commission on Environmental Quality has filed
12 its recommendations relating to this Act with the governor, the
13 lieutenant governor, and the speaker of the house of
14 representatives within the required time.

15 (d) All requirements of the constitution and laws of this
16 state and the rules and procedures of the legislature with respect
17 to the notice, introduction, and passage of this Act are fulfilled
18 and accomplished.

19 SECTION 4. This Act takes effect September 1, 2005.
