2	relating to the creation of the Espada Development District;
3	providing authority to provide water and wastewater services and to
4	impose assessments and taxes and to issue bonds.
5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
6	SECTION 1. Subtitle C, Title 4, Special District Local Laws
7	Code, is amended by adding Chapter 3833 to read as follows:
8	CHAPTER 3833. ESPADA DEVELOPMENT DISTRICT
9	SUBCHAPTER A. GENERAL PROVISIONS
10	Sec. 3833.001. DEFINITIONS. In this chapter:
11	(1) "Board" means the board of directors of the
12	district.
13	(2) "City" means the City of San Antonio.
14	(3) "District" means the Espada Development District.
15	Sec. 3833.002. ESPADA DEVELOPMENT DISTRICT. The Espada
16	Development District is a special district created under Sections
17	52 and 52-a, Article III, Section 1-g, Article VIII, and Section 59,
18	Article XVI, Texas Constitution.
19	Sec. 3833.003. MUNICIPAL CONSENT REQUIRED. Unless the
20	governing body of the city by resolution consents to the creation of
21	the district before January 1, 2007:
22	(1) the board may not hold an election to confirm the
23	creation of the district and to elect directors under Section
24	<u>3833.024;</u>

Т	(2) the district is dissolved on that date; and
2	(3) this chapter expires September 1, 2008.
3	Sec. 3833.004. CONFIRMATION ELECTION REQUIRED. If the
4	creation of the district is not confirmed at a confirmation
5	election held under Section 3833.024 before September 1, 2009:
6	(1) the district is dissolved September 1, 2009,
7	<pre>except that:</pre>
8	(A) the district shall pay any debts incurred;
9	(B) the district shall transfer any assets that
10	remain after the payment of debts to the city; and
11	(C) the organization of the district is
12	maintained until all debts are paid and remaining assets are
13	transferred; and
14	(2) this chapter expires September 1, 2012.
15	Sec. 3833.005. PURPOSE; DECLARATION OF INTENT. (a) The
16	creation of the district is essential to accomplish the purposes of
17	Sections 52 and 52-a, Article III, and Section 59, Article XVI,
18	Texas Constitution, and other public purposes stated in this
19	chapter.
20	(b) The creation of the district is necessary to develop,
21	encourage, and maintain employment, commerce, economic
22	development, and the public welfare of residents, employers,
23	employees, and consumers in the district and adjacent areas.
24	(c) Except as provided by this chapter, the creation of the
25	district may not be interpreted to relieve the city from providing
26	services to the area of the district. The district is created to
27	supplement and not to supplant the city services provided in the

1	area of the district.
2	Sec. 3833.006. FINDINGS OF BENEFIT AND PUBLIC PURPOSE.
3	(a) The district is created to serve a public use and benefit.
4	(b) The creation of the district is in the public interest
5	and is essential to:
6	(1) further the public purposes of developing and
7	diversifying the economy of the state;
8	(2) eliminate unemployment and underemployment; and
9	(3) develop or expand transportation and commerce.
10	(c) The district will provide needed funding for the
11	district to maintain and enhance the economic health and vitality
12	of the district territory as a community and business center.
13	(d) The district may not act as the agent or instrumentality
14	of any private interest even though the district will benefit many
15	private interests as well as the public.
16	Sec. 3833.007. DISTRICT TERRITORY. (a) The district is
17	composed of the territory described by Section 2 of the Act enacting
18	this chapter, as that territory may have been modified under:
19	(1) Subchapter J, Chapter 49, Water Code; or
20	(2) other law.
21	(b) The boundaries and field notes contained in Section 2 of
22	the Act creating this chapter form a closure. A mistake made in the
23	field notes or in copying the field notes in the legislative process
24	does not affect the district's:
25	(1) organization, existence, or validity;
26	(2) right to impose taxes;
27	(3) right to issue or pay bonds; or

1	(4) legality or operation.
2	Sec. 3833.008. COMPLIANCE WITH MUNICIPAL CONSENT
3	RESOLUTIONS. The district shall comply with all applicable
4	requirements of any resolution adopted by the governing body of the
5	city that consents to the creation of the district or to the
6	inclusion of territory in the district.
7	Sec. 3833.009. APPLICABILITY OF OTHER WATER DISTRICTS LAW.
8	Except as otherwise provided by this chapter, Chapter 49, Water
9	Code, does not apply to the district.
10	Sec. 3833.010. LIBERAL CONSTRUCTION OF CHAPTER. This
11	chapter shall be liberally construed in conformity with the
12	findings and purposes stated in this chapter.
13	[Sections 3833.011-3833.020 reserved for expansion]
14	SUBCHAPTER A1. TEMPORARY PROVISIONS
15	Sec. 3833.021. INITIAL DIRECTORS. (a) If the governing
16	body of the city consents to the creation of the district under
17	Section 3833.003, the governing body shall appoint a board of five
18	initial voting directors.
19	(b) The governing body of the city shall appoint the initial
20	directors with:
21	(1) two initial directors' terms expiring on June 1,
22	2008; and
23	(2) three directors' terms expiring on June 1, 2010.
24	(c) This section expires September 1, 2011.
25	Sec. 3833.022. ORGANIZATIONAL MEETING OF INITIAL
26	DIRECTORS. As soon as practicable after the appointment of all the
27	initial directors, the initial directors shall meet at a location

- 1 in the district agreeable to a majority of the directors. At the
- 2 meeting, the initial directors shall elect officers from among the
- 3 initial directors and conduct any other district business.
- 4 Sec. 3833.023. CHANGE IN DISTRICT TERRITORY BEFORE
- 5 CONFIRMATION ELECTION. (a) Except as provided by Subsection (b),
- 6 Section 49.315, Water Code, applies to the district.
- 7 (b) The governing body of the city must approve by
- 8 resolution the addition or exclusion of any territory in the
- 9 district. The governing body may include conditions in the
- 10 resolution, including a condition that certain territory be added
- 11 to or excluded from the district.
- 12 Sec. 3833.024. CONFIRMATION ELECTION. (a) The initial
- 13 board shall hold an election to confirm the district's creation.
- 14 (b) The ballots for a confirmation election must provide for
- voting "For District" and "Against District."
- (c) If a majority of the votes cast in the election favor the
- 17 creation of the district, then the initial board shall declare that
- 18 the district is created and enter the result in its minutes. If
- 19 less than a majority of the votes cast in the election are against
- 20 the creation of the district, the initial board shall declare that
- 21 the district was defeated and enter the result in its minutes. The
- 22 board shall file a copy of the order with the governing body of the
- 23 <u>city.</u>
- 24 (d) The order canvassing the results of the confirmation
- 25 election must contain a description of the district's boundaries.
- 26 The initial board shall file the order in the district's records and
- in the deed records of the county or counties in which the district

2	Sec. 3833.025. EXPIRATION OF SUBCHAPTER. This subchapter
3	expires September 1, 2012.
4	[Sections 3833.026-3833.050 reserved for expansion]
5	SUBCHAPTER B. BOARD OF DIRECTORS
6	Sec. 3833.051. BOARD OF DIRECTORS; TERMS. The district is
7	governed by a board of five directors who serve staggered four-year
8	terms, with two or three directors' terms expiring June 1 of each
9	even-numbered year.
10	Sec. 3833.052. QUALIFICATIONS. (a) To be qualified to
11	serve as a director, a person must be at least 18 years of age and be
12	eligible to vote in the:
13	(1) city, if fewer than 1,000 individuals reside in
14	the district; or
15	(2) district, if 1,000 or more individuals reside in
16	the district.
17	(b) A change in the number of individuals who reside in the
18	district does not affect a director's entitlement to serve out the
19	remainder of the director's term.
20	Sec. 3833.053. APPOINTMENT OF DIRECTORS. The governing
21	body of the city shall appoint the district's directors.
22	Sec. 3833.054. NONVOTING DIRECTORS. (a) The following
23	persons serve as nonvoting directors:
24	(1) the directors of the following departments of the
25	city or a person designated by that director:
26	(A) finance; and
27	(B) public works; and

- 1 (2) the city manager of the city.
- 2 (b) If a department described by Subsection (a) is
- 3 consolidated, renamed, or changed, the board may appoint a director
- 4 of the consolidated, renamed, or changed department as a nonvoting
- 5 director. If a department described by Subsection (a) is
- 6 abolished, the board may appoint a representative of another
- 7 department that performs duties comparable to those performed by
- 8 the abolished department.
- 9 Sec. 3833.055. QUORUM. Nonvoting directors are not counted
- 10 for purposes of determining whether a quorum is present.
- 11 Sec. 3833.056. VACANCY. A vacancy on the board is filled
- 12 for the remainder of the unexpired term in the same manner as the
- 13 original appointment.
- 14 Sec. 3833.057. GENERAL VOTING REQUIREMENTS. Except as
- 15 provided by Section 3833.251, three directors must approve any
- 16 <u>official district action.</u>
- Sec. 3833.058. COMPENSATION. A director is not entitled to
- 18 compensation for service on the board but is entitled to
- 19 reimbursement for necessary and reasonable expenses incurred in
- 20 carrying out the duties and responsibilities of a director.
- Sec. 3833.059. REMOVAL OF DIRECTORS. A board majority may
- 22 petition the city's governing body to remove a director for
- 23 misconduct or failure to carry out the director's duties. The
- 24 governing body, after notice and hearing, may remove the director
- 25 for the misconduct or failure.
- 26 Sec. 3833.060. APPLICABILITY OF OTHER WATER DISTRICTS LAW.
- 27 Subchapter C, Chapter 49, Water Code, applies to the district,

- 1 except for Sections 49.053, 49.055, and 49.060.
- 2 [Sections 3833.061-3833.100 reserved for expansion]
- 3 SUBCHAPTER C. PUBLIC IMPROVEMENTS
- 4 Sec. 3833.101. GENERAL IMPROVEMENTS POWERS. The district
- 5 has all powers necessary to acquire, construct, and maintain
- 6 improvements specified by this subchapter.
- 7 Sec. 3833.102. WATER-RELATED IMPROVEMENTS. The district
- 8 may acquire, construct, or maintain stormwater, drainage and
- 9 detention facilities, sanitary sewer lines and pump stations, and
- 10 water lines and pump stations.
- 11 Sec. 3833.103. ROAD-RELATED IMPROVEMENTS; REIMBURSEMENT TO
- 12 PRIVATE PARTY. (a) The district may acquire, construct, or
- 13 maintain streets, including sidewalks, streetscapes, street signs,
- 14 traffic signals, and street lights.
- 15 (b) For construction that occurs after the district's
- 16 creation, the district may pay a private person for money spent to
- 17 <u>construct a road or related improvement that will be transferred</u>
- under Subchapter D or to purchase a road or improvement constructed
- 19 by the private person.
- Sec. 3833.104. TRANSIT FACILITIES. The district may
- 21 acquire, construct, or maintain transit facilities.
- 22 Sec. 3833.105. PUBLIC PARKING FACILITIES. The district may
- 23 acquire, construct, or maintain public parking facilities.
- Sec. 3833.106. PUBLIC ART. The district may acquire,
- 25 construct, or maintain public art.
- Sec. 3833.107. PARKS AND OPEN SPACES. The district may
- 27 acquire, construct, or maintain parks and open spaces.

- Sec. 3833.108. PEDESTRIAN LINKAGES. The district may
 acquire, construct, or maintain pedestrian linkages.
- Sec. 3833.109. LIBRARY, POLICE STATION, FIRE STATION; CITY

 CONSENT REQUIRED. After obtaining the city's consent by

 resolution, the district may acquire, construct, and maintain a

 library, police station, or a fire station.
- 7 Sec. 3833.110. CITY CONSENT REQUIRED FOR CERTAIN ROADS AND CITY PROPERTY. Before the district begins a project that involves 8 the use of the rights-of-way of streets, roads, or highways or the 9 10 use of municipal land or any easements granted by the city, the district must obtain the approval of the city's governing body in 11 the form of a resolution approving the plans and specifications of 12 13 the project, including a substantial alteration to a plan or 14 specification.
- Sec. 3833.111. APPLICATION OF INTERLOCAL COOPERATION ACT.

 For purposes of Chapter 791, Government Code, the implementation of
 an improvement under this subchapter is a governmental function or
 service.
- Sec. 3833.112. ACQUISITION OF CERTAIN ENCUMBERED PROPERTY
 PROHIBITED. The district may not acquire an improvement under this
 subchapter that has a lien on it or is otherwise encumbered.
- [Sections 3833.113-3833.150 reserved for expansion]
- 23 <u>SUBCHAPTER D. TRANSFER OF PUBLIC IMPROVEMENTS</u>
- Sec. 3833.151. TRANSFER OF CERTAIN IMPROVEMENTS REQUIRED.

 (a) Subject to Section 3833.155, the district shall transfer an improvement as provided by this section when the district acquires or completes the improvement and the receiving entity approves the

Τ	<u>transier.</u>
2	(b) The district shall transfer a:
3	(1) water line or system, including a pump station or
4	other ancillary improvement, that is located in a portion of the
5	district that is in the certificated service area of the:
6	(A) San Antonio Water System, to that system; and
7	(B) Bexar Metropolitan Water District, to that
8	district;
9	(2) wastewater line or system, including a pump
10	station or other ancillary improvement, to the San Antonio Water
11	System;
12	(3) library, police station, or fire station to the
13	<pre>city;</pre>
14	(4) stormwater, drainage, or detention line or
15	detention facility, to the city;
16	(5) road or street, to the city;
17	(6) sidewalk, to the city;
18	(7) streetscape, to the city;
19	(8) street light, to the city;
20	(9) street sign, to the city;
21	(10) traffic signal, to the city; and
22	(11) pedestrian linkage, to the city.
23	(c) The district is not required to transfer an improvement
24	described by Subsections (b)(4)-(11) if the district and city enter
25	into a written agreement that the transfer is not required. The
26	district and the city may agree on other terms under this
27	subsection.

- Sec. 3833.152. CONSTRUCTION STANDARDS. A public
- 2 improvement required to be transferred under this subchapter must
- 3 be constructed in compliance with the requirements and
- 4 specifications established by the appropriate receiving entity at
- 5 the time construction of the improvement begins.
- 6 Sec. 3833.153. OPTIONAL TRANSFER FOR CERTAIN IMPROVEMENTS.
- 7 (a) The district may retain bus terminals or may transfer the bus
- 8 terminals to the VIA Metropolitan Transit Authority or any
- 9 successor regional transportation authority or district with the
- 10 agreement of the authority.
- 11 (b) The district may retain public parking areas, parks and
- open space improvements and public art, or may transfer these to the
- 13 city with the agreement of the city.
- 14 Sec. 3833.154. PARTIAL TRANSFER IN STAGES. The district
- may transfer part of an improvement as provided by this subchapter
- if the district constructs the improvement in stages.
- 17 Sec. 3833.155. TRANSFER WITHOUT DEBT REQUIRED. The
- 18 district shall convey all improvements that it is required to
- 19 transfer under this subchapter without debt or other encumbrance.
- 20 Sec. 3833.156. OWNERSHIP AND RESPONSIBILITY AFTER
- 21 TRANSFER. (a) After a transfer under this subchapter, the
- 22 receiving entity owns the improvement and has sole jurisdiction and
- 23 control over the improvement. The receiving entity is responsible
- 24 for all maintenance of the public improvement and the district is
- 25 not responsible for the public improvement or its maintenance.
- 26 (b) This section does not affect any authority of the
- 27 receiving entity to alter, relocate, close, or discontinue

- 1 maintenance of an improvement.
- 2 <u>Sec. 3833.157. CONTRACT</u> WITH DISTRICT TO MAINTAIN
- 3 IMPROVEMENT AFTER TRANSFER. The district may contract with the
- 4 receiving entity to provide a higher level of maintenance to an
- 5 improvement transferred under this subchapter. The district shall
- 6 pay the receiving entity for the higher level of maintenance.
- 7 Sec. 3833.158. EFFECT OF CONVEYANCE ON DISTRICT DEBT.
- 8 Conveyance of a public improvement to the appropriate entity under
- 9 this subchapter does not affect:
- 10 (1) the sole responsibility of the district to pay in
- 11 <u>full the principal of and interest and any premium on any</u>
- 12 outstanding district bonds or other debt; or
- 13 (2) the district's responsibility to perform the
- 14 obligations provided by the orders or resolutions authorizing the
- 15 bonds or other debt.
- [Sections 3833.159-3833.200 reserved for expansion]
- 17 SUBCHAPTER E. OTHER GENERAL POWERS AND DUTIES
- 18 Sec. 3833.201. CONTRACTS. In addition to the powers
- 19 granted by Section 49.057, Water Code, the district may contract
- 20 with any person for any district purpose, including governmental
- 21 entities, under terms and conditions the board considers advisable.
- Sec. 3833.202. CONTRACT ELECTIONS. Section 49.108, Water
- 23 Code, applies to the district.
- Sec. 3833.203. GRANTS; LOANS. The district may accept a
- grant or loan from any person for any district purpose.
- Sec. 3833.204. PROPERTY. The district may acquire or
- 27 dispose of any property right in any manner necessary, convenient,

- 1 or useful to exercise a district power.
- Sec. 3833.205. SURPLUS PROPERTY. (a) The district may
- 3 sell, lease, or otherwise dispose of any property right that is not
- 4 necessary for or, if the property right is a lease, that is
- 5 inconsistent with the efficient operation and maintenance of the
- 6 district's improvements.
- 7 (b) The district may sell, lease, or otherwise dispose of
- 8 any surplus property that is not necessary to implement a district
- 9 purpose.
- 10 Sec. 3833.206. RECREATIONAL FACILITIES. (a) In addition
- 11 to the district's powers under Section 3833.106 or 3833.107,
- 12 Subchapter N, Chapter 49, Water Code, applies to the district.
- 13 (b) Section 49.454, Water Code, does not apply to the
- 14 district.
- 15 Sec. 3833.207. HEARINGS. The district may conduct hearings
- and take testimony and proof, under oath or affirmation, at public
- hearings, on any matter necessary to implement a district purpose.
- 18 Sec. 3833.208. NOTICES, REPORTS, AND BANKRUPTCY.
- 19 (a) Except as provided by Subsection (b), Subchapter M, Chapter
- 20 49, Water Code, applies to the district.
- 21 (b) Section 49.454, Water Code, does not apply to the
- 22 <u>district.</u>
- Sec. 3833.209. ANNEXATION OF DEVELOPER'S PROPERTY; TAX
- 24 INCREMENT REINVESTMENT ZONE; SERVICES. (a) In this section,
- 25 "developer" means a person who owns a tract of land in the district
- and who has divided or proposes to divide the tract into two or more
- 27 parts to lay out a subdivision of the tract, including an addition

- 1 to a municipality, or to lay out suburban, building, or other lots,
- 2 and to lay out streets, alleys, squares, parks, or other parts of
- 3 the tract intended to be dedicated to public use or for the use of
- 4 purchasers or owners of lots fronting on or adjacent to the streets,
- 5 alleys, squares, parks, or other parts.
- 6 (b) The developer may petition the city to annex the
- 7 developer's property in the district and for the formation of a tax
- 8 <u>increment reinvestment zone in the annexed property under Chapter</u>
- 9 <u>311, Tax Code</u>.
- 10 (c) The developer and the city may negotiate the terms and
- 11 levels of services to be provided in the annexed area based on the
- developer's projected development plan. The plan may provide that
- one or more city services is not required unless and until the
- 14 property actually develops sufficiently to justify the service.
- 15 (d) In negotiating an agreement for services under this
- 16 section, the parties may agree to:
- 17 (1) any term allowed under Section 42.044 or 43.0751,
- 18 Local Government Code, regardless of whether the city or the area
- 19 proposed for annexation would have otherwise been able to agree to
- 20 the term under those sections; and
- 21 (2) any other provision to which both parties agree to
- 22 <u>satisfactorily resolve any dispute between the parties.</u>
- (e) The terms and conditions of the negotiated service plan
- 24 bind the city for the period provided by Section 43.056(1), Local
- 25 Government Code, and the developer, the developer's heirs,
- 26 <u>successors</u>, and assigns, and any person taking title to all or a
- 27 portion of the property annexed under the annexation petition for

- 1 that period.
- 2 (f) The developer and the city may amend the negotiated
- 3 service plan. An amendment binds only the property owned or
- 4 controlled by the developer at the time of the approval of the
- 5 amendment by the developer and the city.
- 6 (g) The developer and the city shall forward the negotiated
- 7 service plan and any later amendments to the board.
- 8 Sec. 3833.210. PROHIBITION ON UTILITY SERVICES. The
- 9 <u>district may not provide water, sewer, drainage, or flood control</u>
- 10 services to residential, retail, or commercial customers in or
- 11 outside the district.
- 12 Sec. 3833.211. USE AND ALTERATION OF PUBLIC WAYS. (a) The
- 13 district may not change, alter, or damage the property, including
- 14 facilities, of the state or any other governmental entity or of
- owners providing public services, or disrupt those services being
- 16 provided by others, or otherwise inconvenience the owners of that
- 17 property or those facilities without having first obtained the
- 18 written consent of those owners.
- (b) If the owners of the property, including facilities,
- desire to handle the change, alteration, or damage of the property,
- 21 including facilities, with their own personnel or to have the work
- 22 done by contractors of their own choosing, the district may agree
- 23 with the owners to provide for the necessary changes, alterations,
- or damage of the property, including facilities, by the owners or
- 25 contractors and the reimbursement by the district to those owners
- of the costs incurred by the owners in making those changes,
- 27 alterations, or damages or having them accomplished by contractors.

- 1 Sec. 3833.212. NO EMINENT DOMAIN POWER. The district may
- 2 not exercise the power of eminent domain.
- 3 [Sections 3833.213-3833.250 reserved for expansion]
- 4 SUBCHAPTER F. GENERAL FINANCIAL PROVISIONS
- 5 Sec. 3833.251. BOARD VOTE REQUIRED TO IMPOSE ASSESSMENTS,
- 6 TAXES, OR BONDS. The district may not impose an assessment or tax,
- 7 or issue bonds, unless four directors vote in favor of the
- 8 <u>assessment, tax, or issuance of bonds.</u>
- 9 Sec. 3833.252. BORROWING MONEY. The district may borrow
- 10 money on terms and conditions the board determines.
- 11 Sec. 3833.253. APPLICABILITY OF WATER DISTRICTS LAW ON
- 12 GENERAL FISCAL PROVISIONS. (a) Except as provided by Subsection
- 13 (b), Subchapter E, Chapter 49, Water Code, applies to the district.
- (b) Section 49.153, Water Code, does not apply to the
- 15 district.
- Sec. 3833.254. INSURANCE. The district may obtain
- insurance and pay premiums to insurers for insurance of any type in
- amounts considered necessary or advisable by the board.
- 19 Sec. 3833.255. DISADVANTAGED BUSINESSES. Section 375.222,
- 20 Local Government Code, applies to the district.
- Sec. 3833.256. AUDIT. (a) The board shall have the
- 22 <u>district's fiscal accounts and records audited annually. The audit</u>
- 23 must be completed not later than the 120th day after the date on
- 24 which the district's fiscal year ends.
- 25 (b) The person who performs the audit must hold a license
- 26 <u>issued under Chapter 901, Occupations Code.</u>
- (c) The audit must be performed according to generally

- 1 accepted auditing standards.
- 2 <u>Sec. 3833.257.</u> <u>STATE AUDITOR. The state auditor may audit</u>
- 3 the financial transactions of the district if the state auditor
- 4 determines the audit is necessary.
- 5 Sec. 3833.258. FINANCIAL REPORTS. (a) The district shall
- 6 keep a full and itemized account of district money. These accounts
- 7 must be available for audit.
- 8 <u>(b) Financial statements must be prepared in accordance</u>
- 9 with generally accepted accounting principles.
- 10 Sec. 3833.259. APPLICABILITY OF WATER DISTRICTS LAW ON
- 11 CONSTRUCTION, EQUIPMENT, MATERIALS, AND MACHINERY CONTRACTS.
- 12 (a) Except as provided by Subsection (b), Subchapter I, Chapter
- 13 49, Water Code, applies to the district.
- (b) Section 49.279, Water Code, does not apply to the
- 15 district.
- Sec. 3833.260. PREVAILING WAGE RATES; CITY. The district
- 17 shall use the prevailing wage rate in the city for purposes of
- 18 complying with Section 2258.022, Government Code.
- 19 Sec. 3833.261. HIGH TECHNOLOGY PROCUREMENT. In making a
- 20 high technology procurement, the district must comply with Sections
- 21 252.021(a) and 252.042, Local Government Code, in the same manner
- as a municipality governed by that subsection.
- Sec. 3833.262. ASSESSMENT ELECTION NOT REQUIRED. The
