

1 AN ACT

2 relating to the creation, powers, management, and boundaries of
3 certain utility districts and a water control and improvement
4 district in Kaufman County; providing authority to impose a tax and
5 issue bonds; granting the power of eminent domain.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

7 ARTICLE 1. CREATION OF KAUFMAN COUNTY WATER CONTROL AND
8 IMPROVEMENT DISTRICT NO. 1

9 SECTION 1.01. Subtitle I, Title 6, Special District Local
10 Laws Code, is amended by adding Chapter 9002 to read as follows:

11 CHAPTER 9002. KAUFMAN COUNTY WATER CONTROL AND IMPROVEMENT
12 DISTRICT NO. 1

13 SUBCHAPTER A. GENERAL PROVISIONS

14 Sec. 9002.001. DEFINITIONS. In this chapter:

15 (1) "Board" means the board of directors of the
16 district.

17 (2) "Director" means a member of the board.

18 (3) "District" means Kaufman County Water Control and
19 Improvement District No. 1.

20 Sec. 9002.002. NATURE OF DISTRICT. The district is a
21 conservation and reclamation district in Kaufman County created
22 under and essential to accomplish the purposes of Section 59,
23 Article XVI, Texas Constitution.

24 Sec. 9002.003. CONFIRMATION ELECTION REQUIRED. If the

1 creation of the district is not confirmed at a confirmation
2 election held under Section 9002.023 before September 1, 2007:

3 (1) the district is dissolved September 1, 2007,
4 except that:

5 (A) any debts incurred shall be paid;

6 (B) any assets that remain after the payment of
7 debts shall be transferred to Kaufman County; and

8 (C) the organization of the district shall be
9 maintained until all debts are paid and remaining assets are
10 transferred; and

11 (2) this chapter expires September 1, 2010.

12 Sec. 9002.004. INITIAL DISTRICT TERRITORY. (a) The
13 district is initially composed of the territory described by
14 Section 1.02 of the Act creating this chapter.

15 (b) The boundaries and field notes contained in Section 1.02
16 of the Act creating this chapter form a closure. A mistake made in
17 the field notes or in copying the field notes in the legislative
18 process does not affect:

19 (1) the organization, existence, or validity of the
20 district;

21 (2) the right of the district to impose taxes; or

22 (3) the legality or operation of the district or the
23 board.

24 Sec. 9002.005. APPLICABILITY OF OTHER LAW. Except as
25 otherwise provided by this chapter, Chapters 49 and 51, Water Code,
26 apply to the district.

1 SUBCHAPTER A1. TEMPORARY PROVISIONS

2 Sec. 9002.021. TEMPORARY DIRECTORS. (a) The temporary
3 board consists of:

- 4 (1) David G. Chaney;
5 (2) Rick Ellis;
6 (3) Jim Lee;
7 (4) Ronald H. Linam; and
8 (5) Max W. Lindsay.

9 (b) If a temporary director fails to qualify for office, the
10 Texas Commission on Environmental Quality shall appoint a person to
11 fill the vacancy.

12 (c) Temporary directors serve until the earlier of:

- 13 (1) the date directors are elected under Section
14 9002.023; or
15 (2) the date this chapter expires under Section
16 9002.003.

17 Sec. 9002.022. ORGANIZATIONAL MEETING OF TEMPORARY
18 DIRECTORS. As soon as practicable after all the temporary
19 directors have qualified under Section 49.055, Water Code, the
20 temporary directors shall convene the organizational meeting of the
21 district at a location in the district agreeable to a majority of
22 the directors. If a location cannot be agreed upon, the
23 organizational meeting shall be at the Kaufman County Courthouse.
24 At the meeting, the temporary directors shall elect officers from
25 among the temporary directors and conduct any other district
26 business.

27 Sec. 9002.023. CONFIRMATION AND INITIAL DIRECTORS'

1 ELECTION. The temporary directors shall hold an election to
2 confirm the creation of the district and to elect five directors as
3 provided by Section 49.102, Water Code.

4 Sec. 9002.024. INITIAL ELECTED DIRECTORS; TERMS. The
5 directors elected under Section 9002.023 shall draw lots to
6 determine which two shall serve until the first regularly scheduled
7 election of directors under Section 9002.052 and which three shall
8 serve until the second regularly scheduled election of directors.

9 Sec. 9002.025. EXPIRATION OF SUBCHAPTER. This subchapter
10 expires September 1, 2010.

11 [Sections 9002.026-9002.050 reserved for expansion]

12 SUBCHAPTER B. BOARD OF DIRECTORS

13 Sec. 9002.051. DIRECTORS; TERMS. (a) The district is
14 governed by a board of five directors.

15 (b) Directors serve staggered four-year terms.

16 Sec. 9002.052. ELECTION OF DIRECTORS. On the uniform
17 election date in May of each even-numbered year, the appropriate
18 number of directors shall be elected.

19 [Sections 9002.053-9002.100 reserved for expansion]

20 SUBCHAPTER C. POWERS AND DUTIES

21 Sec. 9002.101. ROAD PROJECTS. (a) To the extent
22 authorized by Section 52, Article III, Texas Constitution, the
23 district may construct, acquire, improve, maintain, or operate
24 macadamized, graveled, or paved roads or turnpikes, or improvements
25 in aid of those roads or turnpikes, inside the district.

26 (b) A road project must meet all applicable construction
27 standards, zoning and subdivision requirements, and regulatory

1 ordinances of the municipality or county in whose jurisdiction the
2 district is located.

3 (c) The district may not undertake a road project unless
4 each municipality or county in whose jurisdiction the district is
5 located consents by ordinance or resolution.

6 Sec. 9002.102. LIMITATION ON USE OF EMINENT DOMAIN. The
7 district may exercise the power of eminent domain outside the
8 district only to acquire an easement necessary for a pipeline that
9 serves the district.

10 Sec. 9002.103. AUTHORITY TO PROVIDE SERVICES. The district
11 may provide water, sanitary sewer, drainage, and road services to
12 any part of the district not receiving those services on the
13 effective date of the Act creating this chapter.

14 Sec. 9002.104. AUTHORITY TO CONTRACT. The district may
15 enter into a contract with an owner of real property in the district
16 to construct, acquire, finance, own, maintain, or operate works or
17 projects authorized by Section 9002.103.

18 Sec. 9002.105. DIVISION OF DISTRICT. The district may
19 divide into two new districts as provided by Section 53.029, Water
20 Code.

22 SUBCHAPTER D. GENERAL FINANCIAL PROVISIONS

23 Sec. 9002.151. TAX TO REPAY BONDS. The district may impose
24 a tax to pay the principal of and interest on bonds issued under
25 Section 9002.201.

26 Sec. 9002.152. UTILITY PROPERTY EXEMPT FROM IMPACT FEES AND
27 ASSESSMENTS. The district may not impose an impact fee or

1 assessment on the property, including the equipment,
2 rights-of-way, facilities, or improvements, of:

3 (1) an electric utility or a power generation company
4 as defined by Section 31.002, Utilities Code;

5 (2) a gas utility as defined by Section 101.003 or
6 121.001, Utilities Code;

7 (3) a telecommunications provider as defined by
8 Section 51.002, Utilities Code; or

9 (4) a cable operator as defined by 47 U.S.C. Section
10 522.

11 [Sections 9002.153-9002.200 reserved for expansion]

12 SUBCHAPTER E. BONDS

13 Sec. 9002.201. AUTHORITY TO ISSUE BONDS AND OTHER
14 OBLIGATIONS. (a) The district may issue bonds or other
15 obligations as provided by Chapters 49 and 51, Water Code, to
16 finance the construction, maintenance, or operation of projects
17 under Section 9002.101.

18 (b) The district may not issue bonds under Subsection (a)
19 unless the issuance is approved by a vote of a two-thirds majority
20 of the voters of the district voting at an election called for that
21 purpose.

22 (c) Bonds or other obligations issued or incurred to finance
23 projects authorized by Section 9002.101 may not exceed one-fourth
24 of the assessed value of the real property in the district.

25 (d) Sections 49.181 and 49.182, Water Code, do not apply to
26 a project undertaken by the district under Section 9002.101 or to
27 bonds issued by the district to finance the project.

1 Sec. 9002.202. USE OF BOND PROCEEDS. The district may use
2 proceeds from the sale of bonds to acquire from a private water
3 supply corporation facilities or improvements necessary to provide
4 a service authorized by Section 9002.103.

5 SECTION 1.02. Kaufman County Water Control and Improvement
6 District No. 1 initially includes all the territory contained in
7 the following described area:

2 municipal utility district in Kaufman County created under and
3 essential to accomplish the purposes of Section 59, Article XVI,
4 Texas Constitution.

5 Sec. 8138.003. CONFIRMATION ELECTION REQUIRED. If the
6 creation of the district is not confirmed at a confirmation
7 election held under Section 8138.023 before September 1, 2007:

8 (1) the district is dissolved September 1, 2007,
9 except that:

10 (A) any debts incurred shall be paid;

11 (B) any assets that remain after the payment of
12 debts shall be transferred to Kaufman County; and

13 (C) the organization of the district shall be
14 maintained until all debts are paid and remaining assets are
15 transferred; and

16 (2) this chapter expires September 1, 2010.

17 Sec. 8138.004. INITIAL DISTRICT TERRITORY. (a) The
18 district is initially composed of the territory described by
19 Section 2.02 of the Act creating this chapter.

20 (b) The boundaries and field notes contained in Section 2.02
21 of the Act creating this chapter form a closure. A mistake made in
22 the field notes or in copying the field notes in the legislative
23 process does not affect:

24 (1) the organization, existence, or validity of the
25 district;

26 (2) the right of the district to impose taxes; or

27 (3) the legality or operation of the board.

19 number of directors shall be elected.

21 SUBCHAPTER C. POWERS AND DUTIES

22 Sec. 8138.101. MUNICIPAL UTILITY DISTRICT POWERS AND
23 DUTIES. The district has the powers and duties provided by the
24 general law of this state, including Chapters 49 and 54, Water Code,
25 applicable to municipal utility districts created under Section 59,
26 Article XVI, Texas Constitution.

27 Sec. 8138.102. ROAD PROJECTS. (a) To the extent

1 authorized by Section 52, Article III, Texas Constitution, the
2 district may construct, acquire, improve, maintain, or operate
3 macadamized, graveled, or paved roads or turnpikes, or improvements
4 in aid of those roads or turnpikes, inside the district.

5 (b) A project authorized by this section must meet or exceed
6 the construction standards adopted by the North Central Texas
7 Council of Governments, or its successor agency.

8 (c) The district may not undertake a road project unless
9 each municipality in whose corporate limits or extraterritorial
10 jurisdiction the district is located consents by ordinance or
11 resolution. If the district is located outside the
12 extraterritorial jurisdiction of a municipality, the district may
13 not undertake a road project unless each county in which the
14 district is located consents by ordinance or resolution.

15 Sec. 8138.103. CERTIFICATE OF CONVENIENCE AND NECESSITY.

16 (a) The district may pay out of bond proceeds or other available
17 district money all expenses, including legal, engineering, and
18 other fees, related to obtaining a new certificate of convenience
19 and necessity under Chapter 13, Water Code, authorizing the
20 district to provide retail water or sewer service inside or outside
21 the district.

22 (b) The district may pay out of bond proceeds or other
23 available district money all expenses, including the purchase
24 price, related to acquiring certificate of convenience and
25 necessity rights from another retail public utility to allow the
26 district to provide retail water or sewer service in the district.

27 Sec. 8138.104. CONTRACT WITH POLITICAL SUBDIVISION FOR

1 WATER OR SEWER SERVICES. (a) The district may enter into a
2 contract to allow a political subdivision to provide retail water
3 or sewer service in the district. The contract may contain terms

6 Sec. 8138.153. UTILITY PROPERTY EXEMPT FROM IMPACT FEES AND
7 ASSESSMENTS. The district may not impose an impact fee or
8 assessment on the property, including the equipment,
9 rights-of-way, facilities, or improvements, of:

10 (1) an electric utility or a power generation company
11 as defined by Section 31.002, Utilities Code;

12 (2) a gas utility as defined by Section 101.003 or
13 121.001, Utilities Code;

14 (3) a telecommunications provider as defined by
15 Section 51.002, Utilities Code;

16 (4) a cable operator, as defined by 47 U.S.C. Section
17 522; or

18 (5) a person who provides to the public advanced
19 telecommunications services.

21 SUBCHAPTER E. BONDS

22 Sec. 8138.201. AUTHORITY TO ISSUE BONDS AND OTHER
23 OBLIGATIONS. (a) The district may issue bonds or other
24 obligations as provided by Chapters 49 and 54, Water Code, and to
25 finance:

26 (1) the construction, maintenance, or operation of
27 projects under Section 8138.102;

1 (2) the district's efforts to obtain a new certificate
2 of convenience and necessity or to acquire certificate of
3 convenience and necessity rights under Section 8138.103; or

5 Section 8138.104.

6 (b) The district may not issue bonds to finance projects

15 bonds issued by the district to finance the project.

10 board shall hold an election in the district to determine whether
11 the district should be divided as proposed.

12 (b) The board shall give notice of the election not later
13 than the 35th day before the date of the election. The notice must
14 state:

15 (1) the date and location of the election; and

16 (2) the proposition to be voted on.

17 (c) If a majority of the votes are cast in favor of the
18 division:

19 (1) the district shall be divided; and

20 (2) not later than the 30th day after the date of the

3 (d) If a majority of the votes are not cast in favor of the
4 division, the district may not be divided.

5 Sec. 8138.253. ELECTION OF DIRECTORS OF NEW DISTRICTS.

6 (a) Not later than the 90th day after the date of an election in
7 favor of the division of the district, the board shall:

8 (1) appoint itself as the board of one of the new
9 districts; and

10 (2) appoint five directors for each of the other new
11 districts.

12 (b) Directors appointed under Subsection (a)(1) serve the
13 staggered terms to which they were elected in the original
14 district. Directors appointed under Subsection (a)(2) serve until
15 the election for directors under Subsection (c).

16 (c) On the uniform election date in May of the first
17 even-numbered year after the year in which the directors are
18 appointed, an election shall be held to elect five directors in each

24 parallel to Farm to Market Road 2578 approximately 3,922 feet to a
25 point for a corner;
26 THENCE north 78 degrees 29 minutes 32 seconds west along a line and
27 parallel to the US Highway 175 north right of way approximately

1 1,084 feet to a point for a corner;
2 THENCE south 10 degrees 0 minutes 13 seconds west along a line to
3 its intersection with the US Highway 175 north right of way
4 approximately 516 feet for a corner;
5 THENCE westerly along the US Highway 175 north right of way
6 approximately 624 feet to its intersection with the center of Big
7 Brushy Creek and back to the place of beginning and containing
8 approximately 27,817 acres.

9 SECTION 4.03. (a) The legal notice of the intention to
10 introduce this article, setting forth the general substance of this
11 article, has been published as provided by law, and the notice and a
12 copy of this article have been furnished to all persons, agencies,
13 officials, or entities to which they are required to be furnished
14 under Section 59, Article XVI, Texas Constitution, and Chapter 313,
15 Government Code.

16 (b) The governor has submitted the notice and article to the
17 Texas Commission on Environmental Quality.

18 (c) The Texas Commission on Environmental Quality has filed
19 its recommendations relating to this article with the governor,
20 lieutenant governor, and speaker of the house of representatives
21 within the required time.

22 (d) The general law relating to consent by political
23 subdivisions to the creation of a conservation and reclamation
24 district and the inclusion of land in the district has been complied
25 with. All requirements of the constitution and laws of this state
26 and the rules and procedures of the legislature with respect to the
27 notice, introduction, and passage of this article are fulfilled and

1 accomplished.

2 ARTICLE 5. EFFECTIVE DATE

3 SECTION 5.01. This Act takes effect immediately if it
4 receives a vote of two-thirds of all the members elected to each
5 house, as provided by Section 39, Article III, Texas Constitution.
6 If this Act does not receive the vote necessary for immediate
7 effect, this Act takes effect September 1, 2005.
