IN RE: SB833 by Barrientos (Relating to the required use of tax increment financing to provide affordable housing in certain reinvestment zones.), Committee Report 1st House, Substituted

No fiscal implication to the State is anticipated.

The bill would require the provision of certain affordable housing requirements in tax increment financing (TIF) projects within specific counties.

The bill would require a specified allocation of local property taxes for the purpose of providing housing to low-income individuals and families in Travis County.
