- 10 (b) The commission is composed of 17 members appointed by
- 11 the governor with the advice and consent of the senate. [One member
- 12 must be a professional archeologist, one must be a professional
- 13 historian, and one must be a licensed architect who has expertise in
- 14 historic preservation and architectural history. Fourteen members
- 15 must be representatives of the general public. A person may [is]
- 16 not be [eligible for appointment as] a [public] member of the
- 17 commission if the person or the person's spouse:
- 18 (1) owns or controls, directly or indirectly, more
- 19 than a 10 percent interest in a business entity or other
- organization regulated by the commission or receiving money [funds]
- other than grant money [funds] from the commission; [or]
- 22 (2) uses or receives a substantial amount of tangible
- 23 goods, services, or money [funds] from the commission, other than
- 24 compensation or reimbursement authorized by law for commission

- 1 membership, attendance, or expenses; or
- 2 (3) is employed by or participates in the management
- 3 of a business entity or other organization regulated by or
- 4 receiving money other than grant money from the commission.
- 5 (e) A member of the commission must be a citizen of this
- 6 state who has demonstrated an interest in the preservation of the
- 7 state's historical or archeological heritage. In making
- 8 appointments to the commission, the governor shall $[\div]$
- 9 $\left[\frac{1}{1}\right]$ seek to have each geographical section of the
- state represented as nearly as possible[; and
- 11 [(2) appoint at least two members from counties with a
- 12 population of less than 50,000].
- 13 (k) The Texas Historical Commission is subject to Chapter
- 14 325 (Texas Sunset Act). Unless continued in existence as provided
- 15 by that chapter, the commission is abolished and this chapter
- 16 expires September 1, 2019 [2007].
- SECTION 2. Section 442.0021, Government Code, is amended to
- 18 read as follows:
- 19 Sec. 442.0021. COMMISSION MEMBERS: TRAINING. (a) A person
- 20 who is appointed to and qualifies for office as a member of the
- 21 <u>commission may not vote, deliberate, or be counted as a member in</u>
- 22 <u>attendance at a meeting of the commission until the person</u>
- 23 completes a training program that complies with this section
- 24 [Before a member of the commission may assume the member's duties
- 25 and before the member may be confirmed by the senate, the member
- 26 must complete at least one course of the training program
- 27 <u>established under this section</u>].

1	(b) $\underline{ ext{The}}$ [A] training program $\underline{ ext{must}}$ [$ ext{established under this}$
2	section shall] provide the person with information [to the member]
3	regarding:
4	(1) the [enabling] legislation that created the
5	commission;

8	(3) the results of the most recent formal audit of the
9	<pre>commission [(2) the programs operated by the commission];</pre>
10	(4) the requirements of laws relating to open
11	meetings, public information, administrative procedure, and
12	conflicts of interest [(3) the role and functions of the
13	<pre>commission]; and</pre>
14	(5) any applicable ethics policies adopted by the
15	commission or the Texas Ethics Commission [(4) the rules of the
16	commission with an emphasis on the rules that relate to
17	disciplinary and investigatory authority;
18	[(5) the current budget for the commission;
19	(6) the results of the most recent formal audit of the
20	commission;
21	(7) the requirements of the:
22	[(A) open meetings law, Chapter 551;
23	[(B) open records law, Chapter 552; and
24	(C) administrative procedure law, Chapter 2001;
25	(8) the requirements of the conflict of interest laws
26	and other laws relating to public officials; and
27	[(9) any applicable ethics policies adopted by the

- 1 commission or the Texas Ethics Commission].
- 2 (c) A person appointed to the commission is entitled to
- 3 reimbursement, as provided by the General Appropriations Act, for
- 4 the travel expenses incurred in attending the training program
- 5 regardless of whether the attendance at the program occurs before
- 6 or after the person qualifies for office.
- 7 SECTION 3. Sections 442.0022(a) and (b), Government Code,
- 8 are amended to read as follows:
- 9 (a) <u>In this section</u>, "Texas trade association" means a
- 10 cooperative and voluntarily joined statewide association of
- 11 business or professional competitors in this state designed to
- 12 assist its members and its industry or profession in dealing with
- 13 mutual business or professional problems and in promoting their
- 14 <u>common interest</u> [An officer, employee, or paid consultant of a
- 15 Texas trade association in the field of archeology or historic
- 16 preservation may not be a member of the commission or employee of
- 17 the commission who is exempt from the state's position
- 18 classification plan or is compensated at or above the amount
- 19 prescribed by the General Appropriations Act for step 1, salary
- 20 group 17, of the position classification salary schedule].
- 21 (b) A person may not be a member of the commission and may
- 22 not be a commission employee employed in a "bona fide executive,
- 23 administrative, or professional capacity," as that phrase is used
- 24 for purposes of establishing an exemption to the overtime
- 25 provisions of the federal Fair Labor Standards Act of 1938 (29
- 26 U.S.C. Section 201 et seq.) if:
- 27 (1) the person is an officer, employee, or paid

- 1 consultant of a Texas trade association in the field of archeology
- 2 or historic preservation; or
- 3 (2) the person's spouse is an officer, manager, or paid
- 4 consultant of a Texas trade association in the field of archeology
- or historic preservation [A person who is the spouse of an officer,
- 6 manager, or paid consultant of a Texas trade association in the
- 7 field of archeology or historic preservation may not be a member of
- 8 the commission and may not be an employee of the commission who is
- 9 exempt from the state's position classification plan or is
- 10 compensated at or above the amount prescribed by the General
- 11 Appropriations Act for step 1, salary group 17, of the position
- 12 classification salary schedule].
- SECTION 4. Section 442.004, Government Code, is amended by
- 14 adding Subsection (b-1) to read as follows:
- 15 (b-1) The executive director may not serve as a voting
- 16 <u>director on the board of directors of an affiliated nonprofit</u>
- organization formed under Section 442.005(p).
- 18 SECTION 5. Subchapter A, Chapter 442, Government Code, is
- 19 amended by adding Sections 442.0051, 442.0052, and 442.0053 to read
- 20 as follows:
- 21 <u>Sec. 442.0051. FEES. The commission by rule may establish</u>
- 22 reasonable fees for commission purposes under this chapter,
- 23 <u>including an admission fee appropriate to a historic site under its</u>
- 24 jurisdiction.
- 25 Sec. 442.0052. VOLUNTEER SERVICES. (a) Except as provided
- 26 by Subsection (b), the commission may use the services of
- volunteers to help carry out the duties and responsibilities of the

- 2 (b) A volunteer may not enforce this code.
- 3 Sec. 442.0053. ELIGIBILITY CRITERIA FOR INCLUSION OF REAL
- 4 PROPERTY IN STATE HISTORIC SITES SYSTEM. (a) The commission by
- 5 rule shall adopt criteria for determining the eligibility of real
- 6 property donated to the commission for inclusion in the historic
- 7 sites system.
- 8 (b) The commission may accept a donation of real property
- 9 that satisfies the criteria adopted under Subsection (a).
- 10 <u>(c) The commission may renovate or restore donated real</u>
- 11 property, including improvements to the property, or construct new
- improvements on the donated real property as necessary and prudent.
- SECTION 6. Subchapter A, Chapter 442, Government Code, is
- 14 amended by adding Section 442.0055 to read as follows:
- 15 Sec. 442.0055. AFFILIATED NONPROFIT ORGANIZATION; RULES;
- 16 GUIDELINES. (a) The commission shall adopt rules governing the
- 17 relationship between the commission and an affiliated nonprofit
- 18 organization formed under Section 442.005(p), including rules
- 19 that, at a minimum:
- 20 (1) define the extent to which commission employees
- 21 with regulatory responsibilities, including the executive
- 22 director, may participate in activities that raise funds for an
- 23 affiliated nonprofit organization, which may not include the direct
- 24 solicitation of funds; and
- 25 (2) define the relationship between commission
- 26 employees and an affiliated nonprofit organization.
- 27 (b) The commission shall establish guidelines for

- 1 identifying and defining the administrative and financial support
- 2 the commission may provide for an affiliated nonprofit organization
- 3 formed under Section 442.005(p).
- 4 SECTION 7. Section 442.006, Government Code, is amended by
- 5 amending Subsection (b) and adding Subsection (h) to read as
- 6 follows:
- 7 (b) The commission shall:
- 8 <u>(1) develop statewide themes for the program related</u> 9 to the commission's preservation goals for the state;
- 10 (2) install markers recognizing districts, sites,
- 11 individuals, events, structures, and objects significant in Texas
- or American history, architecture, archeology, or culture;
- 13 (3) [and shall] keep a register of those markers; and
- 14 (4) establish a limit for the number of markers the
- 15 commission awards annually.
- 16 (h) The commission by rule shall establish guidelines for an
- 17 application for, and the commission's review of the application
- 18 for, a historical marker, monument, or medallion. The guidelines
- 19 must include criteria for ranking the applications. The commission
- 20 shall give priority to the markers, monuments, and medallions that
- 21 relate to the statewide themes developed by the commission.
- SECTION 8. Sections 442.009(a), (b), and (c), Government
- 23 Code, are amended to read as follows:
- 24 (a) The commission shall maintain a system to promptly and
- 25 efficiently act on complaints filed with the commission. The
- 26 <u>commission</u> shall maintain information about parties to the
- 27 complaint, the subject matter of the complaint, a summary of the

- results of the review or investigation of the complaint, and its disposition [prepare information of public interest describing the functions of the commission and the procedures by which complaints are filed with and resolved by the commission. The commission shall make the information available to the public and appropriate state agencies].
 - (b) The commission [by rule] shall make information available describing its procedures for complaint investigation and resolution [establish methods by which consumers and service recipients are notified of the name, mailing address, and telephone number of the commission for the purpose of directing complaints to the commission].
- 13 (c) The commission shall periodically notify the complaint
 14 parties of the status of the complaint until final disposition
 15 [keep information about each complaint filed with the commission.
 16 The information shall include:
- 17 [(1) the date the complaint is received;
- 18 [(2) the name of the complainant;

- 3 Notwithstanding Sections 403.094 and 403.095, the Texas 4 preservation trust fund account is a separate account in the general revenue fund. The account consists of transfers made to the 5 6 account, loan repayments, grants and donations made for the 7 purposes of this program, proceeds of sales, earnings [income 8 earned] on [money in] the account, and any other money received under this section. Distributions from [Money in] the account may 9 be used only for the purposes of this section and may not be used to 10 pay operating expenses of the commission. Money allocated to the 11 commission's historic preservation grant 12 program shall be deposited to the credit of the account. Earnings [Income earned] on 13 14 [money in] the account shall be deposited to the credit of the 15 account.
 - (b) The commission may use <u>distributions from [money in]</u> the Texas preservation trust fund account to provide financial assistance to public or private entities for the acquisition, survey, restoration, or preservation, or for planning and educational activities leading to the preservation, of historic property in the state that is listed in the National Register of Historic Places or designated as a State Archeological Landmark or Recorded Texas Historic Landmark, or that the commission determines is eligible for such listing or designation. The financial assistance may be in the amount and form and according to the terms that the commission by rule determines. The commission shall give priority to property the commission determines to be endangered by

- demolition, neglect, underuse, looting, vandalism, or other threat 1 2 to the property. Gifts and grants [Money] deposited to the credit 3 of the account specifically for any eligible projects may be used only for the type of projects specified. If such a specification is 4 5 not made, the gift or grant [money] shall be unencumbered and accrue to the benefit of the Texas preservation trust fund account. If 6 7 such a specification is made, the entire amount of the gift or grant may be used during any period for the project or type of project 8 9 specified.
- 10 (f) The advisory board shall recommend to the commission rules for administering <u>Subsections (a)-(e)</u> [this section].
- 12 (h) The comptroller shall manage the assets of the account. In managing the assets of the account, the comptroller may acquire, 13 exchange, sell, supervise, manage, or retain, through procedures 14 15 and subject to restrictions the comptroller considers appropriate, any kind of investment that a prudent investor, exercising 16 reasonable care, skill, and caution, would acquire or retain in 17 light of the purposes, terms, distribution requirements, and other 18 circumstances of the account then prevailing, taking into 19 consideration the investment of all the assets of the account 20 21 rather than a single investment.
 - (i) The amount of a distribution shall be determined by the comptroller in a manner intended to provide a stable and predictable stream of annual distributions and to maintain over time the purchasing power of account investments and annual distributions from the account. If the purchasing power of account investments for any 10-year period is not preserved, the

- 3 (j) An annual distribution made by the comptroller from the

- 7 (k) The expenses of managing account investments shall be
- 8 paid from the account.
- 9 (1) On request, the comptroller shall fully disclose all
- 10 details concerning the investments of the account.
- 11 SECTION 10. Subchapter A, Chapter 442, Government Code, is
- amended by adding Sections 442.022 and 442.023 to read as follows:
- Sec. 442.022. USE OF TECHNOLOGY. The commission shall
- 14 implement a policy requiring the commission to use appropriate
- 15 technological solutions to improve the commission's ability to
- 16 perform its functions. The policy must ensure that the public is
- 17 able to interact with the commission on the Internet.
- 18 Sec. 442.023. NEGOTIATED RULEMAKING AND ALTERNATIVE
- 19 DISPUTE PROCEDURES. (a) The commission shall develop and
- 20 implement a policy to encourage the use of:
- 21 (1) negotiated rulemaking procedures under Chapter
- 22 2008 for the adoption of commission rules; and
- 23 <u>(2) appropriate alternative dispute resolution</u>
- 24 procedures under Chapter 2009 to assist in the resolution of
- 25 <u>internal</u> and external disputes under the commission's
- 26 jurisdiction.

- 20 (b) Money accepted under this section shall be deposited to
- 21 the credit of the historic site account.
- SECTION 12. Section 442.019, Government Code, as added by
- 23 Chapter 1259, Acts of the 79th Legislature, Regular Session, 2005,
- 24 is transferred to Subchapter C, Chapter 442, Government Code, as
- added by this Act, renumbered as Section 442.075, Government Code,
- 26 and amended to read as follows:

- 16 (a) An employee of the state parks division of the

- 18 (1) the employee, as a primary job duty, serves food or

- 20 establishment located within a state park and owned and operated by
- 21 the department;
- 22 (2) <u>the employee</u>, as an auxiliary duty in performance
- 23 of a regular duty renders a special customer service to an

- 12 Sec. 24.052. LARGE COUNTY AND MUNICIPALITY RECREATION AND
- 13 PARKS ACCOUNT. The large county and municipality recreation and

When revenue to the large county and municipality recreation and parks account exceeds \$14 million per year, an amount not less than 15 percent shall be made available for grants to large counties and municipalities for up to 50 percent of the cost of acquisition or development of indoor public recreation facilities for indoor recreation programs, sports activities, nature programs, or exhibits.

- 18 Chapter 43, Parks and Wildlife Code, as added by this Act.
- 19 (b) The study must include:
- 20 (1) a comparison of laws regulating nonindigenous
- 21 snakes in other states;
- 22 (2) alternative methods of regulating the possession
- 23 of nonindigenous snakes;
- 24 (3) the economic, environmental, and other effects of
- 25 allowing nonindigenous snakes to be held in the state, including:
- 26 (A) the potential to harbor and spread diseases
- or parasites, or other adverse effects; and

- 1 (B) the economic and other benefits to this state
- 2 that may be obtained by regulating the trade in nonindigenous
- 3 snakes; and
- 4 (4) other related matters the committee finds useful.
- 5 (c) Not later than November 1, 2008, the committee shall
- 6 report its findings to the governor, the executive directors of the
- 7 Parks and Wildlife Department, and each member of the committee.
- 8 SECTION 55. (a) The Parks and Wildlife Commission shall
- 9 adopt the rules necessary under Subchapter V, Chapter 43, Parks and
- 10 Wildlife Code, as added by this Act, not later than April 1, 2008.
- 11 (b) The Parks and Wildlife Department shall begin issuing
- 12 permits under Subchapter V, Chapter 43, Parks and Wildlife Code, as
- added by this Act, not later than April 1, 2008.
- 14 SECTION 56. (a) The joint legislative task force on the use
- of the sales tax on sporting goods is composed of eight members, as
- 16 follows:
- 17 (1) two members of the House Culture, Recreation and
- 18 Tourism Committee, one being the chair of the committee and one
- 19 appointed by the speaker of the house of representatives;
- 20 (2) two members, each of whom must be a member of the
- 21 House Appropriations Committee or House Ways and Means Committee,

- 9 (1) review the items that are included in the definition of "sporting goods" under Section 151.801(e), Tax Code;
- 11 (2) determine the amount of sales tax revenue that
- 12 must be generated from the sale of "sporting goods" to fund, at a
- 13 minimum, the appropriations made by the 80th Legislature regarding
- 14 state parks, local parks, historic sites, coastal management
- 15 programs, and water planning;
- 16 (3) not later than December 15, 2008, prepare and
- 17 present to the legislature a report that describes the findings of
- 18 the task force and includes recommendations regarding the specific
- 19 items that should be included in the definition of "sporting goods"
- 20 under Section 151.801(e), Tax Code, in order to more evenly match
- 21 the revenue streams needed to cover ongoing appropriations
- 22 (estimated to be \$70 million per annum), net of the use of
- 23 unexpended balances in 2008-2009 biennium, without creating large
- 24 dedicated fund balances.
- (e) It is the intent of the 80th Legislature that Section
- 26 151.801(c-1), Tax Code, as added by this Act, be repealed on
- 27 adoption of a statute implementing the recommendations of the task

- 1 force.
- 2 SECTION 57. If the Parks and Wildlife Department does not
- 3 receive a grant of funds from the Department of Transportation, the
- 4 Parks and Wildlife Department may spend no more than \$50,000 to
- 5 maintain a river-access point and picnic area in Zavala County that
- 6 is adjacent to the Nueces River and United States Highway 83
- 7 intersection north of La Pryor, Texas. If the Parks and Wildlife
- 8 Department receives a grant of funds from the Department of
- 9 Transportation, the Parks and Wildlife Department may not spend
- 10 money, other than money received under the grant, on maintenance
- 11 described by this section.
- 12 SECTION 58. (a) The Parks and Wildlife Department shall
- 13 conduct a study of ways to improve the efficiency and ease of use of
- 14 the department's hunting and fishing license systems. The study
- 15 must:
- 16 (1) evaluate the efficiency of the hunting and fishing
- 17 license systems in effect on September 1, 2007;
- 18 (2) identify problems and suggest improvements to
- 19 those systems; and
- 20 (3) identify ways to increase ease of use for
- 21 individuals applying for a hunting or fishing license in this
- 22 state.
- 23 (b) The Parks and Wildlife Department shall complete the
- 24 study conducted under Subsection (a) of this section not later than
- 25 July 1, 2008.
- 26 (c) Not later than October 1, 2008, the Parks and Wildlife
- 27 Department shall submit to the governor, the lieutenant governor,

- 1 the speaker of the house of representatives, and the chair of each
- 2 committee of the legislature that has primary oversight
- 3 jurisdiction over the department a written report that summarizes
- 4 the findings of the study conducted under Subsection (a) of this
- 5 section.
- 6 SECTION 59. (a) Except as provided by Subsections (b) and
- 7 (c) of this section, this Act takes effect immediately if it
- 8 receives a vote of two-thirds of all the members elected to each
- 9 house, as provided by Section 39, Article III, Texas Constitution.
- 10 If this Act does not receive the vote necessary for immediate
- 11 effect, this Act takes effect September 1, 2007.
- 12 (b) The following take effect September 1, 2007:
- 13 (1) Sections 442.002, 442.0021, 442.0022, 442.004,
- 14 442.0055, 442.006, and 442.009, Government Code, as amended by this
- 15 Act;
- 16 (2) Sections 442.022 and 442.023, Government Code, as
- 17 added by this Act;
- 18 (3) Subchapter H, Chapter 614, Government Code, as
- 19 added by this Act;
- 20 (4) Sections 12.013, 12.306, 43.402, 46.001, 62.011,
- 21 65.0072, 65.008, and 284.001, Parks and Wildlife Code, as amended
- 22 by this Act; and
- 23 (5) except as provided by Subsection (c) of this
- 24 section, Subchapter V, Chapter 43, Parks and Wildlife Code, as
- 25 added by this Act.
- (c) Sections 43.851(d) and 43.856, Parks and Wildlife Code,
- as added by this Act, take effect April 1, 2008.
