- 18 election or appointment as commissioner [may not be a member of the

- (e) [<del>(h)</del>] A person required to register as a lobbyist under
- 21 Chapter 305, Government Code, because of the person's activities
- for compensation on behalf of a profession related to the operation
- 23 of the department is not eligible for election or appointment as
- 24 commissioner [may not serve as a member of the commission].
- 25 [(i) Appointments to the commission shall be made without
- 26 regard to race, color, disability, sex, religion, age, or national
- 27 origin of the appointees and shall reflect the diversity of the

- (f) [(j)] In this section, "Texas trade association" means a nonprofit, cooperative, and voluntarily joined association of business or professional competitors in this state designed to assist its members and its industry or profession in dealing with mutual business or professional problems and in promoting their common interest.
- 8 (g) The commissioner is a successor to the Texas
  9 Transportation Commission for all purposes, including for the
  10 purposes of Sections 49-k, 49-l, 49-m, 49-n, and 49-o, Article III,
  11 Texas Constitution.
- 12 SECTION 4. Section 201.053, Transportation Code, is amended 13 to read as follows:
- Sec. 201.053. <u>DUTIES OF THE COMMISSIONER</u> [CHAIR OF THE COMMISSION]. [(a) The governor periodically shall designate one commissioner as the chair of the commission, who shall serve as presiding officer of the commission.
- 18 [<del>(b)</del>] The commissioner [<del>chair</del>] shall:
- 19 (1) [preside over commission meetings, make rulings on 20 motions and points of order, and determine the order of business;
- [ $\frac{(2)}{2}$ ] represent the department in dealing with the governor;
- 23 <u>(2)</u> [<del>(3)</del>] report to the governor on the state of affairs of the department at least quarterly;
- 25 <u>(3)</u> [<del>(4) report to the commission the governor's</del> 26 <del>suggestions for department operations;</del>

at the general election held in November 2008 to serve for a term that begins January 1, 2009.

- (b) Until the first commissioner of transportation elected 3 4 this Act takes office, the members of 5 Transportation Commission serving on the effective date of this Act 6 shall, unless otherwise removed as provided by law, continue in 7 office under the prior law that governed the composition of the 8 Texas Transportation Commission, and that prior law is continued in effect for that purpose. If on January 1, 2009, there is a vacancy 9 in the new office of commissioner of transportation created under 10 this Act because the first commissioner of transportation-elect has 11 died or refuses or is permanently unable to serve, the members of 12 the Texas Transportation Commission serving on the effective date 13 14 of this Act shall, unless otherwise removed as provided by law, 15 continue in office under the prior law that governed the composition of the Texas Transportation Commission until the 16 17 governor fills the vacancy by appointment in the manner provided by The prior law that governed the composition of the Texas 18 Transportation Commission is continued in effect for that purpose. 19 At the time that the first commissioner of transportation that is 20 21 elected, or in extraordinary circumstances appointed, under this Act takes office, the Texas Transportation Commission is abolished. 22 The commissioner of transportation succeeds to all 23 24 powers, duties, rights, and obligations of the Texas Transportation
  - (c) The commissioner of transportation succeeds to all powers, duties, rights, and obligations of the Texas Transportation Commission, and the abolition of the Texas Transportation Commission does not affect the validity of any right, duty, decision, rule, or action of any kind taken by or under the
