- 2 relating to mandatory kindergarten attendance in public schools.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 4 SECTION 1. Section 25.085(b), Education Code, is amended to
- 5 read as follows:
- 6 (b) Unless specifically exempted by Section 25.086, a child
- 7 who is at least <u>five</u> [six] years of age <u>on September 1 of the school</u>
- 8 <u>year</u>, or who is younger than <u>five</u> [six] years of age <u>on September 1</u>
- 9 of the school year and has previously been enrolled in
- 10 prekindergarten or kindergarten [first grade], and who has not yet
- 11 reached the child's 18th birthday shall attend school.
- 12 SECTION 2. Section 29.009, Education Code, is amended to
- 13 read as follows:
- 14 Sec. 29.009. PUBLIC NOTICE CONCERNING PRESCHOOL PROGRAMS
- 15 FOR STUDENTS WITH DISABILITIES. Each school district shall develop
- 16 a system to notify the population in the district with children who
- are at least three years of age but younger than five [six] years of
- 18 age and who are eligible for enrollment in a special education
- 19 program of the availability of the program.
- SECTION 3. Sections 42.003(a) and (d), Education Code, are
- 21 amended to read as follows:
- 22 (a) A student is entitled to the benefits of the Foundation
- 23 School Program if the student is:
- (1) enrolled in kindergarten or is five $[\frac{5}{2}]$ years of

- 1 age or older on September 1 of the school year; and
- 2 (2) under 21 years of age on September 1 of the school
- 3 year and has not graduated from high school.
- 4 (d) Notwithstanding Subsection (a), a student younger than
- 5 five years of age on September 1 of the school year who is not
- 6 <u>otherwise</u> [is] entitled to the benefits of the Foundation School
- 7 Program is entitled to the benefits of the program if:
- 8 (1) the student performs satisfactorily on the
- 9 assessment instrument administered under Section 39.023(a) to
- 10 students in the third grade; and
- 11 (2) the district has adopted a policy for admitting
- 12 students younger than five years of age.
- 13 SECTION 4. Sections 25.085(c) and 42.003(c), Education
- 14 Code, are repealed.
- SECTION 5. This Act applies beginning with the 2007-2008
- 16 school year.
- 17 SECTION 6. This Act takes effect immediately if it receives
- 18 a vote of two-thirds of all the members elected to each house, as
- 19 provided by Section 39, Article III, Texas Constitution. If this
- 20 Act does not receive the vote necessary for immediate effect, this
- 21 Act takes effect September 1, 2007.
